

## **CITY OF MISSISSAUGA** NOTICE OF STUDY COMPLETION

## **Creditview Road Municipal Class Environmental Assessment Study**

The City of Mississauga has completed a Municipal Class Environmental Assessment (EA) Study and preliminary design for the section of Creditview Road from Sir Monty's Drive/Bancroft Drive to Old Creditview Road (excluding the bridge over the Credit River). The Study was conducted in accordance with the planning and design process for 'Schedule C' projects as outlined in the Municipal Engineers Association Municipal Class Environmental Assessment document, as amended in 2015, which is approved under the Ontario Environmental Assessment Act.

The Study was undertaken to investigate the need for additional north-south capacity and traffic management improvements along this section of Creditview Road, considering the road's identification as part of the City's cultural heritage landscape and its function as a future active transportation corridor. A context sensitive design approach was used in recognition of the multi-modal transportation needs of the area while



protecting established parks, recreational areas, communities and businesses.

- The Preferred Design for Creditview Road generally includes the following key elements:
  - Maintain the existing two (2) travel lanes of traffic from Sir Monty's Drive/Bancroft Drive to Argentia Road;
- Widen to four (4) travel lanes of traffic from Argentia Road to Old Creditview Road; \_
- Implement roundabouts at Argentia Road, Falconer Drive, and Kenninghall Boulevard; and \_
- Implement a 3.5 m multi-use trail (west side) and 1.5 m sidewalk (east side) of the roadway.

The Preferred Design noted above is expected to support traffic operations to Year 2031 and potentially beyond. If and when additional capacity is required, the City will consult with the community to discuss a long-term solution for Creditview Road; which may include widening to four (4) travel lanes of traffic from Sir Monty's Drive/Bancroft Drive to Argentia Road.

The Environmental Study Report (ESR) has been prepared to document the planning and decision-making process for this study. By this Notice, the ESR is being placed on the public record for a thirty (30) day review period from and including May 9, 2016 to June 8, 2016 at the following locations and through the website below:
