# CITY OF MISSISSAUGA – NOTICE OF STUDY COMMENCEMENT Municipal Class Environmental Assessment Study:

Malton Flood Mitigation Study - Etude Drive to Justine Drive

## WHAT?

• The City of Mississauga has initiated a Schedule B Municipal Class Environmental Assessment (Class EA) Study to develop a flood mitigation plan for the general area between Etude Drive and Justine Drive in the Malton community.



# WHY?

• The purpose of the project is to mitigate urban flooding risks to people, property and infrastructure for the Etude Drive to Justine Drive area (see above map).

#### HOW?

- The Study will characterize and model the existing conditions of the area to propose mitigation measures and identify potential impacts.
- The Class EA process will involve identifying and evaluating various alternative solutions to help mitigate flooding, including the preferred solution that will be presented at a Public Information Centre.
- Over the coming months project team environmental specialists will be walking the study area and making notes to document existing conditions to support the evaluation of alternative solutions.
- A Project File documenting the Class EA process will be available for public review at the end of the study.

## **GET INVOLVED!**

- The City would like anyone with an interest in the Study to have an opportunity to provide input and help inform the decision-making process.
- A Public Information Centre (PIC) will be held to present the study findings and the alternative solutions being considered, including the preliminary preferred solution. The details of the PIC will be advertised closer to the date.
- The City may also hold a community site walk prior to the PIC to further explain the project and receive local input. Details on the community site walk will be provided to those who request to be added to the study mailing list.
