1.0 EXECUTIVE SUMMARY

420 Lakeshore Management Inc. (the Client) retained McClymont & Rak Engineers Inc. (MCR) to conduct a Phase One Environmental Site Assessment (ESA) for the property located at 420 Lakeshore Road East, in the City of Mississauga (hereafter referred to as 'the Site'), in accordance with Ontario Regulation (O.Reg.) 153/04, as amended. The Phase One ESA was prepared in general accordance with Ontario Regulation (O.Reg.) 153/04, as amended, and is intended to support the filing of a Record of Site Condition (RSC) with the Ministry of Environment, Conservation and Parks (MECP). The purpose of this assessment was to identify actual or potential sources of subsurface contamination.

Methodology for the Phase One ESA followed Table 1 - Mandatory Requirements for Phase One ESA Reports of the Environmental Protection Act. The assessment included a visual examination of the Site, interview, a review of land use history and a search of public records for the area to determine activities that may have been a source of contamination.

The Site is located on the southwest corner of Lakeshore Road East and Enola Avenue, in the City of Mississauga. The Phase One Study Area, delineated by a 250 m radius surrounding the Site, is part of a commercial and institutional development area. The following PCAs were identified for the Phase One Study Area:

Off-site:

- PCA 1: Gasoline and Associated Products in Fixed Tanks. Gasoline service stations were located north of the Site at 347, 411, 415, 452 Lakeshore Road East. The closest was 25 m northwest of the Site.
- PCA 2: Commercial Auto Body Shops. A former service station/auto service garage at 411 Lakeshore Road East, located 25 m northwest of the Site. An auto service garage had operated at 452 Lakeshore Road East since at least 1958.
- PCA 3: Gasoline and Associated Products in Fixed Tanks. A spill was identified at 406 Lakeshore Road East, located immediately west of the Site, consisting of diesel fuel tank barrel leaks that had possible soil contamination in 2004.
- PCA 4: Gasoline and Associated Products in Fixed Tanks. A gasoline service station is located 35 m east of the Site at 456 Lakeshore Road East.

 PCA 5: Electronic and Computer Equipment Manufacturing. "Canadian Admiral Corps. Ltd. Radio & Television Assembly", was identified on FIPs as being located northwest of the Site at 467 Lakeshore Road East.

These PCAs could lead to the following areas of potential environmental concern at the Site:

- APEC 1: Northern Property Boundary. Gasoline service stations were located north of the Site at 347, 411, 415, 452 Lakeshore Road East. The closest was 25 m northwest of the Site. A former service station/auto service garage at 411 Lakeshore Road East, located 25 m northwest of the Site. An auto service garage had operated at 452 Lakeshore Road East since at least 1958.
- APEC 2: Southwestern Portion of Site. A spill was identified at 406
 Lakeshore Road East, located immediately west of the Site, consisting of diesel fuel tank barrel leaks that had possible soil contamination in 2004.
- APEC 3: Eastern Property Boundary. A gasoline service station is located 35 m east of the Site at 456 Lakeshore Road East. "Canadian Admiral Corps. Ltd. Radio & Television Assembly", was identified on FIPs as being located northwest of the Site at 467 Lakeshore Road East.

Based on the findings of this Phase One ESA, further environmental investigation is required for the Site at this time in order to file for a Record of Site Condition (RSC).

2.0 INTRODUCTION

420 Lakeshore Management Inc. (the Client) retained McClymont & Rak Engineers Inc. (MCR) to conduct a Phase One Environmental Site Assessment (ESA) for the property located at 420 Lakeshore Road East, in the City of Mississauga (hereafter referred to as 'the Site'), in accordance with Ontario Regulation (O.Reg.) 153/04, as amended. The Phase One ESA was prepared in general accordance with Ontario Regulation (O.Reg.) 153/04, as amended, and is intended to support the filing of a Record of Site Condition (RSC) with the Ministry of Environment, Conservation and Parks (MECP). The purpose of this assessment was to identify actual or potential sources of subsurface contamination.

Methodology for the Phase One ESA followed Table 1 - Mandatory Requirements for Phase One ESA Reports of the Environmental Protection Act. The assessment included a visual examination of the Site, interview, a review of land use history and a search of public records for the area to determine activities that may have been a source of contamination.

2.1 Phase One Property Information

The Site is legally described as Part of Lot 12, Concession 3, South of Dundas Street, City of Mississauga, Regional Municipality of Peel. The Legal Survey is provided in Appendix A. The municipal address for the Site is 420 Lakeshore Road East, Mississauga, Ontario. The Site is located on the southwest corner of Lakeshore Road East and Enola Avenue, in the City of Mississauga (see Figure 1). The Site has an irregular shape with an area of approximately 3,751 m² and is currently developed with a commercial building.

3.0 SCOPE OF INVESTIGATION

The scope of work for this Phase One ESA included, but was not limited to, the following:

- Reviews of:
 - Fire Insurance Plans,
 - City directories,
 - A Title Search,
 - Previous environmental reports,
 - Aerial photographs,
 - o Topographic, soil, geological and land use maps, and
 - Municipal, provincial and federal records;
- Interviews with relevant personnel involved with the Site;
- An inspection of the Site and surrounding area;
- Review and evaluation of the information gathered; and
- Preparation of this report containing relevant data, conclusions, and recommendations.

4.0 RECORDS REVIEW

4.1 General Information

4.1.1 Phase One Study Area

The Phase One Study Area was determined to include the Site and all properties within a 250 m radius of the Site (see Figure 2). From the records review, it was determined that there are no properties outside the required 250 m from the property boundary of the Site that need to be included in this Phase One ESA.

4.1.2 First Developed Use

The records review indicates the first developed use of the Site was for commercial use between 1952 and 1954, with the present-day building.

4.1.3 Fire Insurance Plans

MCR contracted Environmental Risk Information Services Ltd. (Ecolog) to search for FIPs and Ecolog provided an FIP for 1952. The following notable information was gleaned from the FIPs:

• 1952: The Site is undeveloped. The Phase One Study Area is largely

residential. Notable surrounding properties include:

- A gasoline service station northwest of the Site at 347 Lakeshore, with two USTs.
- A gasoline service station with three USTs located at 415 Lakeshore, north of the Site.
- "Canadian Admiral Corps. Ltd. Radio & Television Assembly", located northwest of the Site at 467 Lakeshore.
- A gasoline service station with two USTs located northeast of the Site at 484 Lakeshore.

4.1.4 Chain of Title

A full title search was note completed as the history of the Site could be obtained from other sources, indicating the Site has been commercial since first use.

4.1.5 City Directories

MCR contacted Environmental Risk Information Services Ltd. (Ecolog) to search city directories for the Phase One Study Area from the 1880s to 2000. Ecolog was not able to provide city directories due to Covid-19 library restrictions.

4.1.6 Environmental Reports

The following reports for the Site and Phase One Study Area were available as part of the records review and are summarized below:

"Phase One Environmental Site Assessment: 420 Lakeshore Road East, Mississauga, Ontario", dated April 5, 2018. Prepared by Colestar Environmental Inc. Prepared for Stellarcorp Developments 420 Inc.

- The Phase One investigation was for the entire Site.
- The groundwater flow direction was identified as east to southeast, due to the identification of an RSC at 501 Lakeshore Road East (47 m north of the Site).
- The Site was identified as being developed in 1953 with the present-day building.
- The following PCAs were identified:
 - A service station with three gasoline USTs was present at 456 Lakeshore Road East, 20 m northeast of the Site. This was identified in city directories, FIPs and aerial photos. The gas station was present since 1953.
 - An auto service garage was present at 452 Lakeshore Road East,

approximately 25 m northwest of the Site. This was identified in city directories. The auto service garage had operated at this location since at least 1958.

- A former service station/auto service garage at 411 Lakeshore Road East, located 25 m northwest of the Site. This was identified on FIPs, city directories and aerial photos.
- A former manufacturing plant was present at 501 to 515 Lakeshore Road East, approximately 45 m north of the Site.

"Phase Two Environmental Site Assessment: 420 Lakeshore Road East, Mississauga, Ontario", dated April 20, 2018. Prepared by Colestar Environmental Inc. Prepared for Stellarcorp Developments 420 Inc.

- Two APECs were investigated as part of the Phase Two:
 - The northwest portion of the Site due to off-site service stations and auto garages.
 - o The northeast portion of the Site due to an off-site service station.
- Three boreholes were drilled on the Site, all installed as monitoring wells.
- Groundwater was encountered at 3.6 to 4.1 mbgs.
- The soil stratigraphy consisted of sand and gravel fill underlain by sand, with clay till and then shale bedrock below.
- Soil samples were submitted for analysis of VOCs, PHCs, metals and inorganics and PAHs. All samples met applicable standards with the exceptions of electronic conductivity and sodium adsorption ratio. These exceedances would no longer be retained in 2020 due to being related to normal de-icing activities.
- Groundwater samples were submitted for VOCs, PHCs, metals and PAHs. All samples met applicable standards.

4.1.7 Other Records

A Google Street Search dated August 2018 confirmed the land use of the Site and adjoining properties.

4.2 Environmental Source Information

An inquiry was sent to the Ontario MECP, Freedom of Information Office, with regard to records of the Site, in May 2020. A response was not received prior to publication. Any notable response received will be forwarded to the client.

Technical Standards and Safety Authority (TSSA) registers underground storage

tanks (USTs) since 1987. An inquiry was sent to the TSSA with regard to records of the Site, in May 2020. A response was not received prior to publication. Any notable response received will be forwarded to the client.

4.2.1 MECP Notices, Instruments and Reports

MCR contracted Ecolog to search any available federal, provincial or private databases for the Phase One Study Area. Appendix B contains the Ecolog Report. No notable records were identified within the Phase One Study Area.

4.2.2 Databases

- A review by Ecolog of the National Pollutant Release Inventory found no notable records within the Phase One Study Area.
- A review by Ecolog of the National PCB Inventory and Ontario Inventory of PCB Storage Sites found no notable records within the Phase One Study Area.
- A review by Ecolog of the Inventory of Coal Gasification Plant Waste Sites in Ontario (1987) found no notable records within the Phase One Study Area.
- A review by Ecolog of the Ontario Regulation 347 Waste Generators found the following notable records within the Phase One Study Area:
 - A photo shop was present in the Dominion grocery store at 406 Lakeshore Road East, with records for photoprocessing wastes in the 1990s and 2000s.
- A review by Ecolog of the Commercial Fuel Tanks Directory, List of TSSA Expired Facilities database, TSSA Fuel Storage Tank database, the Historic TSSA database, Anderson's Storage Tanks database, Transport Canada Fuel Storage Tanks database and the Retail Fuel Storage Tanks database found no records for the Site. Records for the Phase One Study Area were:
 - Fuel tanks related to a gasoline service station was located at 456 Lakeshore Road East.
 - A gasoline service station had records at 364 Lakeshore Road East,
 160 m southwest of the Site.
- A review by Ecolog of the MECP's Waste Disposal Site Inventory (June 1991) found no records within the Phase One Study Area.
- A review by Ecolog of the MECP's Inventory for Industrial Sites Producing or Using Coal Tar and Related Tars (1988) found no notable records within the Phase One Study Area.
- A review by Ecolog of the National Environmental Emergency System found no notable records within the Phase One Study Area.
- A review by Ecolog of the Ontario Spills Action Centre and TSSA Incidents

databases found no liquid spill records for the Site. A spill was identified at 406 Lakeshore Road East, located immediately west of the Site, consisting of diesel fuel tank barrel leaks that had possible soil contamination in 2004.

- A review by Ecolog of the Waste Disposal Sites database found no notable records within the Phase One Study Area:
- A review by Ecolog of the Scott's Manufacturing Directory found no notable records within the Phase One Study Area.
- A review of the Pesticide Register database found records for the Metro store, immediately west of the Site.

4.3 Physical Setting

4.3.1 Aerial Photographs

Aerial photographs were viewed online, using the Mississauga Maps database. An aerial photograph for every available decade was reviewed as this was deemed to be a reasonable search effort. Additional photos, where available, were reviewed where a change in property use required more information. The following notable information was gleaned from the photographs:

4.3.2 Topography

Regional and local topography are summarized in Sections 4.3.2.1 and 4.3.2.2, respectively.

4.3.2.1 Regional Topography

The topography of the region surrounding the Phase One Study Area, as shown in Figure 1, slopes south towards Lake Ontario, located 400 m south of the Site.

4.3.2.1 Local Topography

On a local scale, according to the topographic information shown on Figure 1, Phase One Study Area grades towards the south to Lake Ontario, located 400 m south of the Site. The Site and general vicinity slopes to the south. The Site is currently graded to approximately 80 masl based on available engineering drawings.

4.3.3 Geology and Hydrogeology

Regional and local geology and hydrogeology are summarized in Sections 4.3.3.1 and 4.3.3.2, respectively.

4.3.3.1 Regional Geology and Hydrogeology

The bedrock formation of the region is shale, limestone, dolostone and siltstone from the Georgian Bay formation. The surficial formations consist mainly of sedimentary lacustrine deposits. According to a Quaternary Geology Map of Southern Ontario (Ministry of Northern Development and Mines, 1990), the subsurface soils in the Phase One Study Area are sequences of clayey and sandy silt tills. It should be noted that the subsurface soil, rock and groundwater conditions assumed represent generalized conditions only, and should not be considered site-specific.

The Phase One Study Area is in the Lake Ontario Shoreline East Subwatershed, which drains to Lake Ontario located 400 m south of the Site. It is expected that the groundwater flow at a regional scale would follow should be directed toward the south.

4.3.3.2 Local Geology and Hydrogeology

On a local scale, geological conditions and hydrogeology are similar to the ones at a regional scale. The groundwater table can be influenced by nearby subsurface water bodies, subsurface utilities, or structures as well as by historical fill/redevelopment works, and can be best confirmed through long-term monitoring.

Bedrock for the Phase One Study Area is estimated to be at a depth of 1-3 mbgs as identified in the previous Phase Two ESA (see Section 4.1.6).

4.3.4 Fill Materials

The records review indicates the Site is underlain by fill, as identified in the previous

Phase Two ESA (see Section 4.1.6).

4.3.5 Water Bodies and Areas of Natural Significance

The nearest surface water body to the Site is Cooksville Creek, located 300 m east of the Site. The nearest downgradient water body to the Site is Lake Ontario, located 400 m south of the Site. There are no areas of natural significance in the Phase One Study Area based on a review of the City of Mississauga Interactive Maps as well as the Ontario Natural Heritage Information Centre Maps.

4.3.6 Well Records

There are no records of potable drinking wells on the Site. The Phase One Study Area is part of the Greater Toronto Area which obtains its drinking water from Lake Ontario and does not rely on groundwater. Well records for within the Phase One Study Area are included in the Ecolog report, provided in Appendix C.

4.4 Site Operating Records

No site operating records were available for review.

5.0 INTERVIEWS

Mr. Garth Robertson was interviewed in person on, May 26, 2020. Mr. Robertson is the current manager of the Beer Store onsite and is familiar with daily operations. Information gleaned from the interview was incorporated in the report. All notable information provided corroborated with information obtained from other sources such as the site visit and records review. Key information provided by the interview includes:

- No underground or aboveground storage tanks or chemical storage was known to be historically or currently present on the Site.
- No bulk chemical storage has occurred at the Site.
- No spills or floods are known to have occurred on the Site.
- The Site was originally heated with coal but Mr. Robinson is not sure when it was converted to the natural gas system that is currently in use.
- Mr. Robinson was not aware of any other potential for contamination on the Site.

6.0 SITE RECONNAISSANCE

6.1 General Information

A reconnaissance of the Site and surroundings was completed by MCR staff (Mr. Michael Hozjan) for evaluating potential environmental risk factors. The Site visit took place on May 26, 2020, from 1:00 pm to 2:00 pm. The Site visit was both internal and external with a review of surrounding properties. The weather was sunny, with temperatures around 25°C. Photographs are provided in Appendix C.

6.2 Specific Observations at the Site

The Site has a rectangular shape with an area of approximately 4,590 m² and is currently developed with one commercial buildings. The following features were encountered on the Site:

- A single storey commercial Beer Store building present at 420 Lakeshore Road East on the south western portion of the Site, with an area of approximately 595 m², occupying 13% of the Site.
- An asphalt parking area on the northern portion of the Site with an area of approximately 2,215 m², occupying 48% of the Site.
- Miscellaneous landscaping, walkways, driveways and natural areas, occupying approximately 1,780 m² or the remaining 39% of the Site.

The following observations were made with regard to the Site inspection:

- No unidentified substances, corrosion, staining or any other notable features were observed at the Site.
- All asphalt appeared in good condition.
- All concrete flooring, including the storage room, appeared in good condition.
- No areas of stressed vegetation were identified on the Site.
- There was no evidence of underground storage tanks, chemicals, or designated substances on the Site.
- Evidence of historic use and coal for heating present in the boiler room. Location of coal storage could not be decerned in buildings current condition
- A hydraulic lift is present in the south eastern portion of the on-site building.
- No natural water courses or features, standing water or ditches were noted on any of the Site portions.
- The Site grading was sloped to the south.

6.3 Enhanced Investigation Property

As stated in Schedule D, Section 13(3) of O.Reg.153/04, an enhanced investigation is required when the subject Site is currently used in whole or in part for an industrial use or as garage, a bulk liquid dispensing facility or operating dry cleaning equipment. Schedule D, Section 13(4) of O.Reg.153/04, discusses the requirements for site inspection where the Site was historically used for one of these purposes.

The Site is not currently being used for any of the above stated purposes and as such is not considered an Enhanced Investigation Property.

6.4 Written Description of Inspection

The Site was inspected on May 26, 2020 which included all exterior spaces, buildings, mechanical rooms, storage rooms and basements. No portion of the Site was restricted or inaccessible during the Site visit. Photographs were taken throughout the Site (as provided in Appendix C) and any relevant observations were recorded.

6.5 Observations of Adjoining Properties

The Site is located on the southwest corner of the intersection of Lakeshore Road East and Enola Avenue, in the City of Mississauga (see Figure 2):

North: An active construction Site, an auto garage and a residential apartment

building are all present to the north of the Site along Lakeshore Road

East.

East: A Gas Station is present immediately east of the Site at 456 Lakeshore

Road East.

South: A residential development consisting of detached single-family

dwellings.

West: A commercial development immediately west of the Site consisting of

several businesses including a Dry Cleaner at 386 Lakeshore Road

East.

7.0 REVIEW AND EVALUATION OF INFORMATION

7.1 Current and Past Uses

The records review indicates the first developed use of the Site was commercial use with the present-day building. The Site is presently under use as a Beer Store.

7.2 Potentially Contaminating Activities

The following PCAs, identified based on the overall history and use of the Site and surrounding area, have the potential to impact the soil and/or groundwater beneath the Site (see Figure 3):

- PCA 1: Gasoline and Associated Products in Fixed Tanks. Gasoline service stations were located north of the Site at 347, 411, 415, 452
 Lakeshore Road East. The closest was 25 m northwest of the Site.
- PCA 2: Commercial Auto Body Shops. A former service station/auto service garage at 411 Lakeshore Road East, located 25 m northwest of the Site. An auto service garage had operated at 452 Lakeshore Road East since at least 1958.
- PCA 3: Gasoline and Associated Products in Fixed Tanks. A spill was identified at 406 Lakeshore Road East, located immediately west of the Site, consisting of diesel fuel tank barrel leaks that had possible soil contamination in 2004.
- PCA 4: Gasoline and Associated Products in Fixed Tanks. A gasoline service station is located 35 m east of the Site at 456 Lakeshore Road East.
- PCA 5: Electronic and Computer Equipment Manufacturing. "Canadian Admiral Corps. Ltd. Radio & Television Assembly", was identified on FIPs as being located northwest of the Site at 467 Lakeshore Road East.

7.3 Areas of Potential Environmental Concern

Based on the finding of this Phase One ESA, MCR concludes that there are the following areas of potential environmental concern (APECs) associated with the Site that indicate potential for contamination in the soil or groundwater beneath the Site:

 APEC 1: Northern Property Boundary. Gasoline service stations were located north of the Site at 347, 411, 415, 452 Lakeshore Road East. The closest was 25 m northwest of the Site. A former service station/auto service

garage at 411 Lakeshore Road East, located 25 m northwest of the Site. An auto service garage had operated at 452 Lakeshore Road East since at least 1958.

- APEC 2: Southwestern Portion of Site. A spill was identified at 406
 Lakeshore Road East, located immediately west of the Site, consisting of diesel fuel tank barrel leaks that had possible soil contamination in 2004.
- APEC 3: Eastern Property Boundary. A gasoline service station is located 35 m east of the Site at 456 Lakeshore Road East. "Canadian Admiral Corps. Ltd. Radio & Television Assembly", was identified on FIPs as being located northwest of the Site at 467 Lakeshore Road East.

7.4 Phase One Conceptual Site Model

The Site is located on the southwest corner of Lakeshore Road East and Enola Avenue, in the City of Mississauga (Figure 1). Table 1 describes the PCAs, identified based on the overall history of the Site and surrounding area, that have the potential to impact the soil and/or groundwater beneath the Site (See Figure 3).

7.4.1 Uncertainties Affecting the Validity of the Phase One ESA

The Phase One ESA obtained supporting background information from various sources including: aerial photographs, City directories, property title search, interviews, site reconnaissance, etc. Each of these information sources was thoroughly examined and there is no indication of uncertainty with any of these sources that would invalidate the Phase One Conceptual Site Model.

8.0 CONCLUSIONS

8.1 Further Environmental Investigation

The objective of this assessment was to document current conditions of the Site and flag potential environmental issues associated with its suitability for development. The work included a review of historical uses of the Site and its surrounding area, as well as a visual inspection of the Site and vicinity.

Based on the findings of this Phase One ESA, further environmental investigation is warranted for the Site.

8.2 Phase Two ESA Requirement

As stated in Section 32 (1) of O.Reg.153/04, a Phase Two ESA is required prior to filing an RSC when the subject Site is used or has ever been used in whole or in part

for an industrial use, as garage, a bulk liquid dispensing facility or operating dry cleaning equipment. Since the Site has never been used for any of these activities.

this requirement does not apply.

8.3 Record of Site Condition

A Record of Site Condition (RSC) cannot be obtained for the Site without a Phase

Two ESA at this time.

<u>Map Key:</u> The map key number is assigned according to closest proximity from the project property. Map Key numbers always start at #1. The project property will always have a map key of '1' if records are available. If there is a number in brackets beside the main number, this will indicate the number of records on that specific property. If there is no number in brackets, there is only one record for that property.

The symbol and colour used indicates 'elevation': the red inverted triangle will dictate 'ERIS Sites with Lower Elevation', the yellow triangle will dictate 'ERIS Sites with Higher Elevation' and the orange square will dictate 'ERIS Sites with Same Elevation.'

<u>Unplottables:</u> These are records that could not be mapped due to various reasons, including limited geographic information. These records may or may not be in your study area, and are included as reference.






