#### Affidavit only required for units created on or before July 14, 1994

#### What is an affidavit?

An affidavit is a written statement of facts made under oath or affirmation, and is administered by a person authorized for taking affidavits (e.g. lawyer).

### Why is an affidavit being requested prior to registering my second unit?

A Second Unit Creation Date Affidavit is requested where you wish to commit to the creation of a unit on or before a specific date. The date the unit was created or came into existence will be used to establish the applicability of the Fire Code or Building Code in conjunction with the registration of your unit.

### What must be included in my Second Unit Creation Date Affidavit?

The Second Unit Creation Date Affidavit must include specific information in accordance with the attached sample provided. The affidavit must be signed by all registered property owners with the appropriate words/dates inserted.

The affidavit must be commissioned by a lawyer entitled to practise law in the Province of Ontario. The City of Mississauga will only accept an ORIGINAL affidavit with the lawyer's stamp/seal or other identification.

The property owner(s) is advised that it is an indictable offence to swear or affirm a false affidavit and may be subject to prosecution, resulting in up to 14 years imprisonment and restrictions on travel outside the country (Sections 131 & 132, Criminal Code of Canada).
