Proposed Zoning By-law and Licensing By-law Amendments Subject Lands: All Employment Zone lands in the City of Mississauga

Proposal:

- To amend the Zoning By-law to address Health Canada's new *Marihuana for Medical Purposes Regulations (MMPR)* that allow for the commercial production of medical marihuana. Recommended amendments include:
 - A new "Medicinal Product Manufacturing Facility" definition;
 - A new "Medical Marihuana" definition;
 - A new General Provision for Medical Marihuana Production, to require that all uses, inclusive of waste destruction or composting, be located wholly within a building or structure;
 - Exception Zone amendments to prohibit medical marihuana production facilities on specific parcels designated "Business Employment" within the Lakeview, Port Credit, and Sheridan Neighbourhood Character Areas in the Mississauga Official Plan.
- To amend the Business Licensing By-law to license medical marihuana production facilities.

Planning Act Requirements

Bill 51 Applications

- If a person or public body does not make oral submissions at a public meeting, or make written submissions to the **City of Mississauga** before the by-law is passed, the person or public body is not entitled to appeal the decision of the City of Mississauga to the Ontario Municipal Board.
- If a person or public body does not make oral submissions at a public meeting, or make written submissions to the **City of Mississauga** before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
