Proposal:

Property Location:

 The applicant is requesting a change in zoning from "D" (Development) to "H-E1-Exception" (Employment in Nodes with a Holding Provision) and "H-E2-Exception" (Employment with a Holding Provision) to permit uses and built form standards consistent with the applicable "Business Employment" land use designation, approved Hurontario-Main Street Corridor Master Plan, and the proposed amendments to the Gateway Corporate Centre Character Area policies in Mississauga Official Plan.

Purpose of Meeting:

To present Planning and Building Department recommendations on the above-noted applications. (Note: A public meeting was held on January 13, 2014 and the details of the application were presented and the Information Report was received by the Planning and Development Committee.)

Planning Act Requirements

Bill 51 Applications

- If a person or public body does not make oral submissions at a public meeting, or make written submissions to the **City of Mississauga** before the by-law is passed, the person or public body is not entitled to appeal the decision of the City of Mississauga to the Ontario Municipal Board.
- 2. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the **City of Mississauga** before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
