

City of Mississauga Notice of Completion Municipal Class Environmental Assessment (Class EA) Study for Ninth Line

(Derry Road West to a point south of Highway 401/407)

The City of Mississauga has completed a Municipal Class Environmental Assessment (Class EA) Study for the section of Ninth Line from Derry Road West to a point just south of Highway 401/407. This study was undertaken to investigate pavement needs for Ninth Line, additional road capacity, safety improvements, and opportunities for cycling facilities, to address current and future needs.

The study was conducted in accordance with the planning and design process for "Schedule C" projects as outlined in the Municipal Engineers Association's Municipal Class Environmental Assessment, which is approved under the Ontario Environmental Assessment Act. The Class EA process includes public/external agency consultation, an evaluation of alternative solutions and alternative design concepts, an assessment of potential impacts associated with the proposed improvements, and the development of measures to mitigate identified impacts. The preferred alternative design (ultimate design) consists of a five-lane cross section, which transitions into two lanes at the north limits of the study area. Some of the features of this design include dedicated turning lanes and a center lane that can be used for queue storage and left turns into driveways. This design also recommends construction of a multi-use trail (MUT) and sidewalk infrastructure on the east and the west sides, respectively. In the interim, the design will only include pavement reconstruction, the addition of the turning lanes at intersections and the MUT on the east side. Transition from the interim to ultimate design is subject to traffic volumes warrant and the future development of lands, west of Ninth Line.

By way of this notice, the Environmental Study Report (ESR) will be placed on record for a 45-day public review period (beginning on July 11, 2014 and ending on August 25, 2014) at the following locations during normal business hours:



Anyone with an interest in the study is encouraged to review the ESR and provide comments to the City of Mississauga (see below for contact information). If any concerns cannot be resolved by the City of Mississauga during the 45-day review period, a request can be made in writing to the Minister of the Environment for project to comply with Part II of the Environmental Assessment Act (referred to as a Part II Order). Requests for a Part II order must be received by the Minister at the address below, by August 25, 2014. A copy of the request must also be sent to the City of Mississauga Project Manager. If no request is received by August 25, 2014, the City of Mississauga intends to proceed with the preferred alternative as outlined in the ESR.
