Applicant's Proposal:

To revise the official plan and zoning to permit two apartment buildings (32 and 25 storeys) consisting of 545 units with retail commercial uses on the ground floor, and 49 back to back townhouse dwellings.

Note: The applicant has acquired additional properties on Grange Drive and revised their proposal from the last Public Meeting held November 19, 2012 which proposed two apartment buildings (36 storeys and 22 storeys) consisting of 559 units with retail commercial units at grade, and 20 back to back townhouse units. While no access to Grange Drive was previously proposed, the revised proposal seeks an access to Grange Drive.

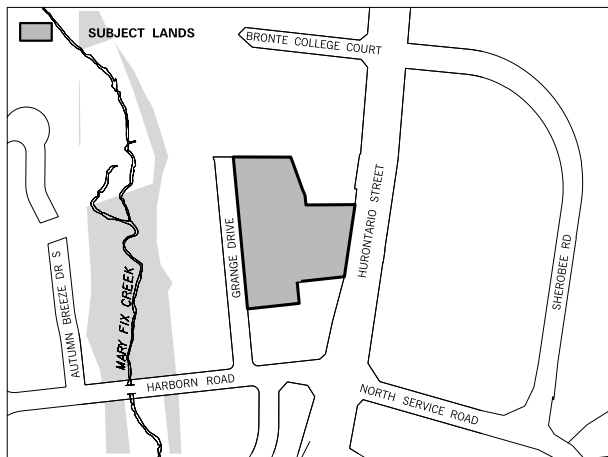
Purpose of Meeting:

Personal Information:

The personal information related to the consideration of any planning matter (including consideration of applications; comments and correspondence provided, whether written or verbal in relation to an application; comments and correspondence provided at, before or after a public or statutory meeting or a Committee or Council meeting) is collected under the authority of the *Municipal Act, 2001*, and the *Planning Act*. The City collects this information to enable it to make an informed decision on the relevant issue(s). Individuals who submit correspondence (as noted above) should be aware that any personal information in their communication will become part of the public record, unless the individual expressly requests the City to remove the personal information. Information about appeals:

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed, the person or public body is not entitled to appeal the decision of City Council to the Ontario Municipal Board, or be added as a party to an appeal of the decision to the Board. If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

The proposed Official Plan amendment is exempt from approval by the Region of Peel. The decision of the Council is final if a notice of appeal is not received on or before the last day for filing a notice of appeal.
