

CONSTRUCTION NOTICE

ROAD RESURFACING

Your street is scheduled to be repaved by the City of Mississauga under the Road Resurfacing Program. Work will commence within the next two weeks from receiving this notice and will include replacing asphalt on the road and repairs to curbs and sidewalks. The project is scheduled to be completed within six to eight weeks (weather permitting).

Construction Information & Details:

- Construction will take place in stages and there may be delays between each stage of work
- If your driveway curb is replaced, the asphalt between the curb and sidewalk (driveway boulevard) will also be replaced
- If there is no sidewalk on your street, typically two to three metres (six to nine feet), of the driveway boulevard will be replaced
- The City guarantees all workmanship and materials for one year after completion of the construction activity

Residents Please Note:

- **There is a potential for temporary disruption to cable, internet and/or telephone service. Please contact the City Inspector (information below) should your service be disrupted. Arrangements will be made to the utility company for repair**
- Access to your driveway may be interrupted for two to three days (please see below for parking information)
- Residents must remove fixtures such as sprinkler heads and sprinkler systems prior to the construction. **The City will not be responsible for any damage to fixtures**
- Avoid contact with hot asphalt or any construction material at all times
- Please water the sod in front of your property if it has been replaced to ensure proper growth

Parking Information:

- Residents can park on the street if their driveway is not accessible due to construction
- The City's parking enforcement officers will be advised **not** to issue tickets for "Parking in Excess of Five Hours" while your driveway is not accessible
- Parking tickets will still be issued for violations such as: parking against the traffic flow, parking too close to a corner, fire hydrant or other parking restricted areas

Driveway Widening - Boulevard Portion Only:

- If you are interested in applying for an Access Modification Permit (curb cut widening) visit: [https://www7.mississauga.ca/documents/FormsOnline/Access Modification Application Form.pdf](https://www7.mississauga.ca/documents/FormsOnline/Access_Modification_Application_Form.pdf), otherwise the curb will be replaced at its original width
- Applications are subject to approval based on the Zoning By-law
- A fee will be charged based on the amount of work required
- No widening will be done on patterned concrete/lock stone driveways or streets with ditches

- The completed application form must be submitted within **two** business days of receipt of this notice. Late submissions will not be accepted
