Subject: Referral of Region of Peel Projects to the Facility Accessibility Design Subcommittee - Update

Background

At its meeting on October 26, 2015 the Facility Accessibility Design Subcommittee (FADS) received a memorandum from Lawrence Franklin, Urban Designer regarding a recommendation to have a process through which Region of Peel projects to be built and located in the City of Mississauga would be forwarded via minutes of Regional Accessibility Advisory Committee to FADS for information and if desired by the Subcommittee, further review of the project.

This matter was referred to staff in Legislative Services to investigate the appropriate process for implementation of this recommendation.

Comment

Upon investigation, the appropriate process to request that the Region of Peel Accessibility Advisory Committee is as follows:

1. The Facility Accessibility Design Subcommittee (FADS) will make a recommendation to the Accessibility Advisory Committee (AAC) (as outlined below);
2. Upon approval by the AAC, subsequent approval by General Committee and eventual adoption by Council, the recommendation will be forwarded to the Region of Peel Accessibility Advisory Committee for consideration and response.
3. Upon approval from the Region of Peel, they will forward minutes pertaining to Regional projects in Mississauga to the AAC or to FADS for consideration, whichever meeting occurs first, allowing FADS to then request further review/presentation on a project, and to Planning and Building staff for their records.
