# Subject

Apportionment of Taxes

# Recommendation

That the recommended apportionment of taxes and payments set out in Appendix 1 of the report dated August 24, 2015 from the Commissioner of Corporate Services and Chief Financial Officer be approved.

# Background

Section 356 of the *Municipal Act* allows a local municipality to apportion taxes if land which was assessed in one block at the return of the assessment roll is subsequently divided into two or more parcels and to direct what proportion of any payment of taxes is to be applied to each of the parcels.

# Comments

The Municipal Property Assessment Corporation (MPAC) has advised of a number of properties that have been divided into parcels subsequent to the return of the assessment roll. Section 356 of the *Municipal Act* provides for taxes levied on the land to be apportioned to the newly created parcels. In addition, the municipality is to direct what proportion of any payment of taxes is to be applied to each of the parcels.

In accordance with section 356(1) of the *Municipal Act*, taxes levied on the land for the year in which the property is divided and any unpaid taxes for years prior to that year have been proportionately apportioned to the newly created parcels based on the relative assessed value of the parcels as determined by MPAC. Supplementary taxes levied for the year in which the property was divided have been allocated to the parcel to which they pertain.



Council

All payments applied to the property tax account being apportioned, from the year of the land division to date, must be allocated to the appropriate parcels. Payments have been allocated based on the parcel that payment was intended for or distributed proportionately among the parcels if the payment was intended for the entire block.

A Summary of Apportionment of Taxes listing newly created parcels and the recommended apportionment of taxes and payments is provided as Appendix 1.

Owners of the apportioned lands have been sent notification. Property owners have the right to appeal the decision of Council to the Assessment Review Board.

# **Financial Impact**

Not Applicable

# Conclusion

There are a number of properties that were assessed in one block at the return of the assessment roll and subsequently divided into parcels. The *Municipal Act* requires Council to approve the apportionment of taxes and allocation of payments subsequent to the division of property.

# Recommendation

That the tax adjustments outlined in Appendix 1 attached to the report dated August 25, 2015 from the Commissioner of Corporate Services and Chief Financial Officer for applications for cancellation or refund of taxes pursuant to Sections 357 and 358 of the *Municipal Act*, be adopted.

# Background

Sections 357 and 358 of the *Municipal Act, 2001, S.O. 2001, c.25* allow a property owner or the Treasurer to make an application for the cancellation, reduction or refund of taxes for a number of specific reasons. Taxes may be adjusted when a building has been demolished or razed by fire or if a property has become exempt, changed class or has been overcharged by reason of gross or manifest error.

# Comments

A total of 46 applications for tax adjustments have been prepared for Council's consideration. The total cancellation or refund of taxes as recommended is \$206,315.32. Appendix 1 outlines the tax cancellations being recommended by property and summarizes by appeal reason the number of applications and tax dollars recommended for reduction.

# **Financial Impact**

The City's portion of the cancellations resulting from the Section 357 and 358 tax adjustments is \$47,547.56.

# Conclusion

Tax appeals for 2013, 2014 and 2015 taxation years are listed in Appendix 1. The *Municipal Act* requires Council to approve the tax adjustments.

#### BACKGROUND:

Mississauga Zoning By-law 0225-2007 was passed by Council on June 20, 2007. Since the intent of the Comprehensive Zoning By-law review was to ensure the Zoning By-law remains up-todate and in conformity with Mississauga Official Plan, regular reports are prepared to deal with City initiated amendments to the Zoning By-law. The most recent amendment was passed by City Council on July 2, 2014.

Since the approval of the most recent amendment, it has been determined that a number of sections of the Zoning By-law need to be revised to clarify the wording. Amendments to the Zoning Bylaw are proposed to modify the following:

- Definition Section
- Parking and Loading Regulations

- 2 -

- Residential and Employment Provisions
- Zoning Maps

The details of these amendments are outlined in Appendix I-1 to this report. Of note are items outlined below, which are cross-referenced with Appendix I-1 in parenthesis:

#### Gross Floor Area – Restaurant (Item 2)

The City is encouraging complete neighbourhoods as part of the Strategic Plan. Multi-use buildings provide a mix of commercial and residential uses. Currently for a mixed use building consisting of residential, retail and restaurant uses, three parking calculations are required because there are three different definitions of gross floor area (GFA). To simplify the calculations, it is proposed that the definition of gross floor area – restaurant be deleted. The gross floor area for restaurants will use the same definition as all other non-residential uses.

#### **Pervious Material** (Items 1, 4, 6 and 12)

The Living Green Pillar in the City's Strategic Plan states that the City should lead and encourage environmentally responsible approaches. In the most recent amendments, a new definition and regulations were added to the residential zones to permit pervious materials, such as interlock, on residential driveways. To further this goal, changes to the definition and provisions are proposed to allow pervious material in commercial and industrial zones. Planning and Development Committee

Increase Driveway Width and Circular Driveway Provisions for Large Frontage Lots (Items 10 and 11)

The previous City initiated amendments changed the maximum driveway width requirement and added a requirement for landscaping in the front yard. These amendments were needed to ensure that the front yard of a dwelling unit remains partially unpaved for both stormwater management and aesthetic reasons.

Minor adjustments to the driveway provisions are proposed to permit a maximum driveway width of 8.5 m (27.9 ft) for lots with a frontage greater than 18 m (59.1 ft.). In addition, minor amendments to the circular driveway provisions are proposed to ensure the continued functionality of circular driveways.





We, the residents around Port Credit Secondary and Mineola Public school, feel strongly that there needs to be a 3 way stop sign at Crossfield Bend and Mineola Rd. East. This intersection is hazardous for several reasons:

1) there is a bus stop immediately to the East and cars routinely fly around buses, straight through the school cross-walk: a clear danger to the children and the crossing guard

2) there is limited sight-line coming from Crossfield Bend onto Mineola Rd East. Cars need to edge partly into the intersection to see around a thick telephone pole. This has resulted in accidents in the past.

3) There is no safe place for children to cross between Hurontario and Lakebreeze, a distance of almost one kilometre

4) the crosswalk is not well marked and is often missed by motorists

I realize that assessments have been done in the past and a stop-sign has been refused, but we urge you to re-visit this matter before the City Council before something tragic happens.





### **Re: Resolution for Fairness in Provincial Infrastructure Funds**

I am writing to inform you of my upcoming private member's resolution in the Ontario legislature and to formally request your support. It reads as follows:

That, in the opinion of this House, the government should guarantee that governmentheld ridings and opposition-held ridings be given equal and transparent consideration on infrastructure funding, and that when funding decisions are made, should guarantee that all MPPs, whether in government or opposition, be given fair and equal advance notice of the official announcement.

The basis for my resolution is simple: When municipalities apply for provincial infrastructure funding, you should expect that your application would be evaluated based on merit. You should expect that it would be evaluated promptly, based on well-defined and transparent criteria. Finally, you should expect that the decision to approve your application would never depend on your MPP's political stripe.

There is, after all, no such thing as Liberal, PC or NDP infrastructure money; there is only *public* money. That money comes from taxes that we all pay; everyone in the province should expect a similar quality of infrastructure and services, regardless of where they live.

Because municipalities rely on provincial partnerships to fund critical infrastructure projects, the consequences of provincial funding decisions can be far-reaching. The provincial government must respect this partnership and ensure that government and opposition-held ridings are given equal consideration when it comes to infrastructure investment decisions. Too often, however, there is at least a persistent perception that public infrastructure dollars have, in at least some cases, been directed according to politics and not according to need.

Having served as a municipal councillor, I know that the process to apply for infrastructure funding is a major—and sometimes frustrating—undertaking. It often entails significant red tape and investments of staff time and resources. Before making those investments, municipalities need some assurance that, based on clear criteria, your application has a reasonable chance of success. You also need to know that your MPP will advocate on your behalf and, most importantly, decision-makers will be receptive to that advocacy no matter if the MPP serves in government or opposition.

The final section of my resolution deals with infrastructure announcements themselves. These announcements must, I believe, be depoliticized in order to address the perception that opposition-held ridings are disadvantaged—or worse yet, being punished—for voting against the government.

If your municipality supports the intent of my resolution, I would encourage you to consider passing a formal resolution to support it. If your Council decides to proceed in this way, I would appreciate receiving a copy of your resolution as soon as possible. Debate on this resolution is scheduled for October 8, 2015.

I would appreciate your views on this matter, and your own experience in your municipality concerning access to provincial infrastructure funds.
