Mayor Hazel McCallion presented the International Association of Business Communicators (IABC) 2009 OVATION Award of Merit – Communication Skills Audiovisual for "Mississauga: Location of Choice for the Life Sciences Industry" to the Economic Development Office. Mayor McCallion complimented the Economic Development Office for their work in assisting businesses to locate and remain in Mississauga.

Larry Petovello, Director, Economic Development Office, showed the award winning video and provided Council with a brief explanation of the award. He pointed out that the video was produced in house by A/V and Creative Services staff. A photograph was taken of the award presentation.

(e) International Association of Business Communicators (IABC) 2009 OVATION Award of Merit for "Trust, Quality and Excellence – Living Our Corporate Values"

Mayor Hazel McCallion presented the International Association of Business Communicators (IABC) 2009 OVATION Award of Merit for "Trust, Quality and Excellence – Living Our Corporate Values" to the Communications Division and City Manager's Office.

Ivana DiMillo, Director, Communications Division, provided Council with a brief explanation of the award. Janice Baker explained that this award was presented to the City for their communication plan of the City's Corporate Values and complimented staff on their hard work. A photograph was taken of the award presentation.

**6. DEPUTATIONS****(a) Garbage/Litter at rear of Plazas**

Benita Grist, resident, addressed Council with respect to her previous deputation and petition (Council – December 10, 2008) regarding garbage and litter behind plazas. She advised that she was re-addressing the storage problem at the rear of plazas and requested that the By-law be amended to deter the rear of plazas from being used for storage.

Ms. Grist expressed disappointment that 4 months had elapsed before she was advised that there was a by-law in place, however, it was difficult to enforce. She stressed that if the rear of the Dreamcrest Plaza was now clean, it was because she has been complaining to the owners and by-law enforcement for the past 6 years and the plaza is cleared of garbage only after persistent complaints. Ms. Grist felt that the by-law should stipulate that the rear of the plaza should only be used for access and not for storage. Further, she felt that storage would increase from the current two crates to more unsightly storage if left unchecked. Also, Ms. Grist expressed disappointment that she had to bring this matter to Council's attention when such a problem is prevalent across the City.

Mayor McCallion explained that By-law enforcement deals with complaints when they are received and in many cases the area is cleaned after the complaint but property standard violations re-occur despite fines and charges being laid. She suggested that the resident speak directly with the store owner which may produce better compliance.

Councillor Carolyn Parrish advised the deputant that since her complaint, the plaza has been monitored on a regular basis and staff have provided her with reports on their visits and photographs but cannot find fault with the plaza. She noted that Ms. Grist raised objection to two milk crates which employees use to sit on during their breaks, a cigarette butt can and an outdoor toy which the tenants children play on.

Jamie Hinton, By-law Enforcement, explained that he has visited the plaza at midnight to check on Ms. Grist's complaint regarding overnight storage and found no storage issues. He stated that the department could not devote any more time to this complaint as there was no evidence of the plaza violating any by-laws.

Councillor Maja Prentice advised Ms. Grist has contacted her office as well and explained that since there are so many plazas across the City staff must rely on a complaint system.

In response to a request by Ms. Grist as to how she should deal with the problem, she was reminded that the plaza was private property and she would be responsible for her actions.

(b) Canada Day Events

The following individuals addressed Council with respect to the Canada Day events across the City.

- (a) Melissa Di Carlo, My Mississauga Manager, highlighted the Canada Day Events at the Civic Centre. She showed a short video of last years events stating that they had about 80,000 attendees and were expecting a much higher number this year. The evening will end with fireworks.

Mayor McCallion reminded that the Civic Centre is also host to Citizenship Court when many new Canadians get their citizenship that day. She suggested that it be added to the program. In this regard, Councillor Carolyn Parrish stated that since attendance to the Citizenship event is by limited invitation only, it is omitted from the brochure.

Further, Mayor McCallion wished that more people would carry the Canadian flag or fly it from their balconies and cars. She honoured the citizen who approached the City to celebrate Canada Flag Day in February, citing how a single individual can make a difference.

Councillor Parrish noted that this year the school principals were asked to recommend volunteers for the Canada Day event and the response was overwhelming.

Councillor Frank Dale advised that he was thrilled to see the program and that Port Credit nor Streetsville plans for Canada Day celebrations will not be impacted.

- (b) John Bozzo, Chair, Port Credit Paint the Town Red spoke on the Port Credit Celebrations, adding that they have a simple schedule to create a small town atmosphere with fireworks at the end. The day also included free BBQ and Strawberry Tea. He stated that they have purchased 6500 cloth flags through sponsorships. Also, he acknowledged the Lions Club for their assistance in the event.

Councillor Carmen Corbasson complimented Mr. Bozzo on his dedications and patriotism, particularly to the Canadian flag, adding that Mr. Bozzo supports every event in Port Credit. She also drew attention that Port Credit would be celebrating their 175<sup>th</sup> birthday next year and plans for the celebrations are underway.

- (c) Seema Theti, Guru Nanak Community Services Foundation, briefly provided the events planned for the Canada Day Celebrations in the Wildwood Park in Malton. She advised that the theme was “Proud to be Canadian” with representatives from the First Nations and many other countries. Ms. Theti advised that they are beginning this as an annual celebration with a simple schedule to include attendees sending a message of support to the Canadian Troops in Afghanistan and also collecting food/donations for the foodbank.
- (d) Lorraine Baddeley, General Manager, Streetsville Business Improvement Association spoke on activities planned for the 18<sup>th</sup>. year of Canada Day Celebrations in Streetsville. She introduced two other members of her team. This year, most of the events will take place at the newly renovated Vic Johnson Community Centre and will end with fireworks as well.

Ms. Baddeley brought to Council a poster which could be signed and then sent to the Canadian troops serving in Afghanistan.

Councillor George Carlson complimented the volunteers particularly the three ladies who attended Council, adding that they helped organizing many events in Streetsville.

- (c) Jefferson Salamanders

Don Barber, Friends of Cawthra Bush and Community Volunteer, addressed Council with respect to the Province’s Recovery plan for the endangered Jefferson Salamanders, comments to the Ministry of Natural Resources and the city’s response to the welfare of these species in Mississauga. He stated that he was incorrect when he suggested at the June 10<sup>th</sup>. Council meeting that there could be Jefferson Salamanders at the Riverwood Park.

Using overheads, Mr. Barber showed where the known population of these salamanders could be found in Mississauga. He felt that with some effort from the City, this was a great opportunity to show Mississauga’s commitment to the living environment.

Mr. Barber explained his past work on protecting this endangered species and spoke of the two submissions he made to the Ministry of Natural Resources and provided Community Services staff a copy of these submissions. Mr. Barber felt that staff did not follow the Management Plan at Cawthra as approved by council; the toad population had been dug up and his water monitoring efforts had been blocked. He hoped that staff would have taken this opportunity by providing comment to the Ministry and asking for financial support to address the Jefferson Salamanders as the Province was offering funding towards maintaining their habitat. Mr. Barber suggested that the Province be approached in this regard.

Further, Mr. Barber showed photographs of the area in question at the Cawthra Bush which he spoke about at the previous Council where the public had trespassed close to the habitat, adding that the fences should be replaced and the path moved away so that people do not stomp on the salamander habitat.

Janice Baker, City Manager, clarified that reference has been made that files and corporate reports can be referenced at Committee/Council through the screens in front of each member, however, these were simply monitors which provide ease in viewing and not computers.

Mayor Hazel McCallion made reference to a letter received at the Region of Peel from Mr. Barber and was advised that the City of Mississauga had not been copied on it. Also, the Mayor made reference to a letter from the Ministry which was sent to the City but not addressed to anyone in particular. This letter listed 14 assessment roll numbers and she has been advised by staff that the sites listed in the letter are already identified as protected sites in the Official Plan. Mayor McCallion also advised that AMO was looking into this legislation as the Ministry is seeking AMOs position on this matter. She asked staff to provide AMO with a copy of the City's position in this regard to assist them in providing comment to the Ministry.

Paul Mitcham, Commissioner, commended Mr. Barber for his active involvement in the protection of the salamanders. He advised that the Ministry of Natural Resources circulated for comment a policy document that would protect a wide range of endangered species. Staff are monitoring the process and once they know what was required to protect the species, a report to council would be prepared. Mr. Mitcham explained that the Ministry was considering a wide range of controls which would have an effect on how the City manages the area as it may have to broaden the protection. Mr. Mitcham also explained that the area in question at the Cawthra Bush was currently being repaired.

- (a) Alan Forde, resident, addressed Council with respect to Presentations 5 (c) – fDi Award presented to the Economic Development Office. He was disappointed that Mississauga did not place as high as Ottawa and Hamilton who placed 2nd and 3rd respectively for Best Quality of Life Award. He cited other rankings where Mississauga did not place as high and asked which 42 projects were tracked by the fDi since 2003. Staff from the Economic Development Office will provide him with a response.

- (b) Ursula Keuper-Bennett, resident, addressed Council with respect to the item on the Agenda listed under Unfinished Business relating to the Corporate Report on Security incidents. She stated that there were still issues she would like to bring forward. Ms. Keuper-Bennett provided council with a document containing copies of e-mails, quotes from e-mails, Corporate Policies relating to Trespassing, Vandalism and Corporate Security which she obtained through a Freedom of Information request for all records that led to the creation of the “Violence and Vandalism Policy and the subsequent Violence, Vandalism and Bullying Policy.

Ms. Keuper-Bennett expressed concern with how trespassing was being logged as she did not feel it was accurately described. She cited June 2006 as an example where she was aware that trespassing was logged but that was not the case. She also made reference to her previous deputations before Council but was not satisfied with the information that has been provided to her as they have resulted in more questions.

Mayor Hazel McCallion stated that she was at a loss at what the core of her concerns were and attempts have been made to provide her with the information she has requested but they seemed to result in more questions at Council when they are unable to provide the answers. Mayor McCallion suggested that a meeting be held with her, Janice Baker and appropriate staff to see what they could do to resolve her concerns.

Councillor Nando Iannicca advised that as Chair at General Committee, he gave Mrs. Keuper Bennett a generous amount of time to fully explain the points she wished to raise with respect to the above Corporate Report and its recommendation, however, she continues to have several more questions and issues which could not be simply responded to at Council or Committee.

Councillor Iannicca expressed concern that despite hearing several previous deputations at Council, General Committee and again at this Council, they were at a loss as to what end results she was looking for or what they could do to satisfy her concerns. Mayor McCallion recommended that the above matter be referred back to allow a meeting to be held with the deputant, City Manager and staff so that they can understand more clearly the wishes of the deputant and put some closure to her concerns.

- (c) Don Barber, resident, addressed Council with a copy of a photograph of the Council Chamber on the day he was arrested and asked identification of an individual in the photograph who was Annemarie Hagen, Museums Manager. She was at the Council meeting on another issue and is not in any way related to Corporate Security. Mr. Barber asked several questions and made suggestions relating to Corporate Security.

With regard to the Unfinished Business – Security Incidents, Mr. Barber made reference to the comments made by Ursula Keuper-Bennett relating to the accuracy in reporting security incidents and asked how many other people have been in the same situation and not accurately reported. He felt that based on the method of logging, Council may not be fully informed of Corporate Security's actions.. Mr. Barber listed several questions relating to the length of time security videos are kept and made suggestions to certain policies relating to these videos.

Mayor McCallion recommended that the presentation be received and his questions be referred to staff, however these questions and suggestions were not provided in written form at the meeting.

R-4 Single Source Acquisitions - Architectural, Construction Management and Project Management firms for the Infrastructure Stimulus Funding (ISF) Program

Report dated June 18, 2009 from the Commissioner of Corporate Services and Treasurer with respect to Single Source Acquisitions - Architectural, Construction Management and Project Management firms for the Infrastructure Stimulus Funding (ISF) Program

RECOMMENDATION:

1. That the report dated June 18, 2009 titled Single Source Acquisitions - Architectural, Construction Management and Project Management firms for the Infrastructure Stimulus Funding (ISF) Program from the Commissioner of Corporate Services and Treasurer be received.
2. That Council approve the following list of firms for single source contract awards for ISF projects managed by Facilities and Property Management, in accordance with the Purchasing By-law 374-06, by reason of Schedule A 1(b)(ii) of the By-law, where the immediate acquisition of the goods and services is essential to avoid serious delays which could impair participation in the ISF Program:
  - CS&P Architects for Civic Square - \$3,517,500.00;
  - ZAS Architects for Burnhamthorpe Library - \$1,141,875.00;
  - MJM Architects for Malton and Clarkson Community Centre Pools - \$882,000.00 each or \$1,764,000.00 total;
  - PCL Constructors for Construction Management at Civic Square, Burnhamthorpe Library, Clarkson Pool Addition and Malton Pool Addition as follows:
    - Civic Square - \$37,695,000.00
    - Burnhamthorpe Library - \$14,438,208.00
    - Clarkson Pool Addition - \$9,108,750.00
    - Malton Pool Addition - \$9,108,750.00
  - MHPM for Project Management Services for Port Credit, Lorne Park and Lakeview Branch Libraries - \$383,250.00.
3. That all necessary by-laws be enacted authorizing the Purchasing Agent to execute the necessary agreements with the Single Source firms.

In response to a request by Councillor Maja Prentice to allow for coordination of the proposed work at the Burnhamthorpe Library with the Dixie Bloor Neighbourhood Centre, Janice Baker, City Manager, explained that there were several teams working on these projects to meet the deadline of completion by March 31, 2011, and some of the project were complex. She advised that staff were looking at other alternative ways to include the residents including having one Ward meeting for all projects. She emphasized that they could not go through the normal thorough public process at the risk of not completing the project because the City would have not be eligible for the shared costs of the project if it was not completed on time. Janice Baker stated that it was staff's objective to leverage on every shared dollar to bring the City's infrastructure up to date.

In response to Mayor Hazel McCallion's question regarding the two pool projects that were included on the list knowing that they would not be completed by the March 31<sup>st</sup>. deadline, Janice Baker advised that the projects were approved even through the completion date was the summer of 2011. She stated that she would be highlighting this in the letter to the Province. Also, she advised that staff were working on a communication plan which they will bring forward possibly to the next Council meeting (July 8<sup>th</sup>). Councillor Carolyn Parrish requested that a copy be sent to her office before final printing.

With respect to seeking Council's approval of single source for the above projects, Ms. Baker assured Council that once they had a contractor for the project, they would bring back a report to Council for approval. The purpose of this report was to reduce some of the tendering process time.

Councillor Parrish felt that the City could be billed for work not completed on the two pools after the March 31, 2011 deadline and suggested that these monies be budgeted for in budget forecasts. She was advised by the City Manager that two of the above single source firms were to deal with the pools and that staff are fully cognisant of the tight time constraints particularly for these two projects. She again assured Council that they were attempting to leverage every shared dollar to maximize on the Federal and Provincial Government's contributions.

WHEREAS the Ontario Government recently passed the 2009 Provincial Budget which included the harmonization of the Federal GST and Provincial PST into a single sales tax of thirteen (13%) per cent;

AND WHEREAS the harmonized sales tax (HST) will be implemented on July 1, 2010;

AND WHEREAS Ontario businesses, municipalities and citizens are currently experiencing financial challenges due to the economic downturn;

AND WHEREAS the increased costs resulting from the harmonization of the Federal GST and Provincial PST may have a negative impact on the affordability of recreation, fitness, and other municipal programs provided generally throughout the City and reduce participation in such programs and activities which benefit the overall health and well being of citizens;

THEREFORE BE IT RESOLVED that:

1. The government of the Province of Ontario be requested to mitigate the impact of the implementation of the proposed HST in light of the current economic downturn, and until additional public consultation and input is received, and that implementation of the HST be phased in gradually as a means to mitigate against the cost increases that the HST will produce, and the negative impacts that will result;

- (b) Councillor Carolyn Parrish thanked Martin Powell, Commissioner, and his Assistant, Debbie Foley for their efforts in giving her a response to a previous enquiry relating to the street drainage into the Credit River and Etobicoke Creek. She expressed concern for the well being of the fish if salt from the roads, metal, oil, anti-freeze, etc. drained into the river as some of the low level bridges drained directly into the Credit River. She expressed concern that bridges in Brampton as well may be doing the same resulting in further impact on the water quality in the Credit River. Mr. Powell explained that the high level and newer bridges did not drain directly into the river, however, some sections of older bridges drain directly but to retrofit them now would not be feasible. He also explained that in new construction, storm water quality ponds were being built.

Councillor Parrish suggested that this report be referred to the Environmental Committee to see if they can approach the Province and Conservation Authorities with the hope that they could consider some funding.

(b) Moved By: Councillor Nando Iannicca, Ward 7

Whereas the global economic recession continues to harshly impact all Taxpayers;

And whereas those of us who have the privilege of serving in the public sector enjoy the job security that comes with providing essential services such that our employment, wages, benefits, and pensions have been largely unscathed;

And whereas the private and global market place has generated harsh re-adjustments with the Canadian Automobile and Parts Manufacturing sector as a dramatic example whose Union went so far as to re-open fairly bargained contracts to deal with the crisis, while the Public Service has avoided such dramatic and profound readjustment;

And whereas the time has come for those of us in the public sector to fairly and equally share some of the burden faced by our fellow taxpayers, but municipal councils are impeded and prevented from taking many actions due to the long term contracts with unionized staff signed in better times, the inability to reopen such contracts, and other impediments in the form of provincial legislation and bodies such as arbitration tribunals;

And whereas said restrictions with unionized public sector staff would force us to unfairly and disproportionately place the burden solely on our non unionized staff, or those unions with the unfortunate timing of having their contracts expire in the midst of this crisis, with some going so far as to threaten strike action when thousands harshly hit by the recession would gladly accept these jobs, or any other job in the public sector;

Therefore, be it resolved that the City of Mississauga Council petitions the Premier of Ontario to take a leadership role on behalf of all Ontarians and pass the enabling legislation to freeze all wages and benefits for all Ontario public sector employees for a one year period; respectfully making this request after having already ~~unanimously~~ approved such a freeze on our wages and benefits, and a 10% reduction on our expenses.

Councillor Nando Iannicca advised that the average taxpayer was heavily burdened with the current economy, people were in arrears in their taxes, and the Canadian Union of Auto Workers had voluntarily re-opened their union contracts, while the public sector did not have their income or pension benefits impacted, hence he felt that it was time for the public sector to show leadership and share the burden of the current downturn. Councillor Iannicca pointed out that Council has customarily given non-union staff the same cost of living increase as unionized workers. He felt that unless the Province legislated a wage freeze, Council would have to give Unions the COLA negotiated during better times and this could result in unfairness to non-union employees. Councillor Nando Iannicca requested support for his motion stating that he was making this request for a one year period. Further, he pointed out that Mississauga Councillor have already adopted a wage freeze to their salaries as well as that of the Leadership Team.

Councillor Carolyn Parrish stated that she believed in honouring negotiated contracts and it was unfair to penalize those staff whose contracts now became due. She felt that recommending Province-wide bargaining by a Province wide negotiating team would be more appropriate. Councillor Parrish indicated that she could not support the Notice of Motion as it was unfair to those whose wages would now be frozen because of timing while some unions have already received their negotiated wage increase. The Councillor suggested that perhaps shorter terms should be negotiated with the Unions.

Mayor Hazel McCallion explained that at LUMCO, a committee has been set up to work together on pay issues and benefits. She felt that Union views were heard at the Provincial level and this group was now created to work with the Province on behalf of employers and this would provide better coordination. Janice Baker is the chair of this group and is working on a series of HR issues at the municipal level so that there is a level playing field.

Ms. Baker explained that each of the municipalities have financially contributed towards costs as there is some legal work to be done and currently they are working on coordinated bargaining for fire and police and will report back in August.

At the request of Councillor Nando Iannicca, the Mayor called for a recorded vote.
