Richard Roberts, Project Manager and Stephanie Snow, Harrington McAvan discussed the Lakeshore Royal Windsor Hydro Corridor from Winston Churchill Boulevard to South Sheridan Way for a new multi-use trail. Event Date: Sept. 21, 2014

Objectives:

Formulate action plan to gain 5,000 participants How might we attract sponsors? How might we improve the experience?

Overview

- Tour is in its 7th year and is recognized as one of the cool tours in southern Ontario
- 2013 Tour had 2,300 participants
- City is starting to endorse this event now; tour is giving Mississauga a reputation of having a bike-friendly infrastructure
- \$15K received from Region of Peel, which was used to buy the food; \$3K from the city?
- Expenses: promo, police, city staff, reg. cards and other mktg materials, shirts, markings
- Past promos: word-of-mouth, Mississauga News, Mississauga Guide, Kinect, road signs, community centres, Robers channel 10, bike shops, booth at the Toronto Bike Tour, bike clubs
- 120 km route will be added in 2014

Tour of Detroit

- Got over 5K participants in the tour (\$40 pp)
- Went through the good and bad areas
- Interracial event
- Food tent and beer at the end
- People cheering

Cambridge Ride

- Paid \$30 for chance to ride and food at the end
- · People cheering all along the routes
- Over 6000 participants

Ideas

- Need to add to the experience if we are to increase participation
- People are looking for riding experiences which is why they are attending other tours throughout the summer. Good food and interesting routes means an exciting experience.
- Do we want to start charging for the event or keep it free (joy in a free event vs. paying a fee for the perceived value)? Philosophy has always been free for everybody, no closing of the street.
- Solution- keep the event free but charge for food and make the experience better
- Star power to raise profile? Canadian top cyclists, sponsored rides Clara Hughes, Steve Bauer
- Better food experience needed
 - o Charge food vendors to set up at the event
 - Optional for riders to buy food and beer
 - \$15K from Region of Peel can be allocated to other initiatives (e.g. PR)
- Election year receive a budget from councillors?
- BIAs get them involved, put something up for the riders Port Credit, Streetsville
- Booths for local communities/businesses
- Have routes that pass through Villages and combine routes to encourage the non-cycling population to get out and cheer.
- How to attract sponsors? nutrition, therapists, yoga, bike stores, more cycling-related sponsors
 - o Marquee sponsorship \$10K for the Tour to get the big tent, flag, bike parking
- Bike shops align with a promo activity that they'd pay for
- Get non-cyclists involved
- No change to the dates

2013 Cycling Network Program: Year-End Report

The City of Mississauga Cycling Master Plan outlines a strategy to build an integrated on-road and off-road cycling network as part of a multi-modal transportation system, as well as a wide range of accompanying programs and policies to enhance cycling.

The 2013 Cycling Network Program included the development of bicycle lanes, sharrows and multi-use trails in several locations. The project locations were aligned with the criteria contained within the Cycling Master Plan. For each location, consultation with the respective Ward Councillor and area residents was completed, where required.

This report provides a year-end summary of the status of 2013 cycling network projects. This work represents projects completed by the City's Transportation and Works Department and Community Services Department, as well as projects completed by the Region of Peel and the Toronto Region Conservation Authority where indicated.

OTHER NETWORK IMPROVEMENTS

In addition to expanding the cycling network, improvements have been made to the network such as:

- Bicycle loop detection installed at 5 additional intersections
- Automatic Bicycle Counter Equipment installed at the following locations:
 - o Bristol Road, temporary tube counter, various locations
 - o Burnhamthorpe Trail, active loop counter eastbound and westbound, east of Duke of York Boulevard
 - Confederation Parkway, active loop counter northbound and southbound, north of Dundas Street
- Wayfinding signage expanded along existing and new routes including:
 - o Creditview Road Trail
 - o Queensway Trail East
 - o Tenth Line West
- Pathway paving reconstruction (2.3 km) and/or pathway resurfacing / widening (0.6 km) was completed by the Community Services Department in the following locations:
 - o Castlegreen Meadows (Ward 9)
 - o Clover Meadows (Ward 6)
 - o Heatherleigh Park (Ward 6)
 - o Meadow Green (Ward 11)


