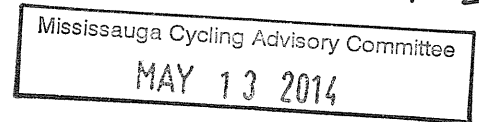

1.2 Minutes of Previous Meeting – April 8, 2014

2. Tour de Mississauga Subcommittee Update

Dorothy Tomiuk, Citizen Member provided a verbal update regarding the Tour de Mississauga. She spoke to the growth of the Tour, reviewed safety components, venue, registration systems and achieving set deadlines.

3. Network and Technical Subcommittee

No discussion took place regarding the Network and Technical Subcommittee.

Members of the Mississauga Cycling Advisory Committee (MCAC) engaged in conversation regarding the late start in this year’s street sweeping program as it has created hazardous conditions for cyclists and pedestrians.

Andy Bate, Supervisor, Traffic Operations spoke to traffic calming techniques that have been implemented. Jeff Wachman, Chair asked Mr. Bate to send the locations to MCAC.

RECOMMENDATION

That staff review and report back on the start date of the street sweeping program due to the volume of debris causing safety concerns for cyclist and pedestrians, with priority on cycling lane routes.

4. Phil Green Recognition Award

Jacquelyn Hayward Gulati, Manager, Active Transportation and Dorothy Tomiuk, Citizen Member advised Mississauga Cycling Advisory Committee (MCAC) members that no applications were received for the 2013 Phil Green Recognition Award.

Discussion ensued with respect to expectations for applicants, the need to select a candidate on yearly bases, the prestige of the award and the need to review the criteria.

RECOMMENDATION

That the Phil Green Recognition Award criteria be reviewed with Phil Green and that the Communications and Promotional Subcommittee report back to a future Mississauga Cycling Advisory Committee meeting.

5. Peel Region Bicycle Rodeo Initiative

He noted that a draft Bike Rodeo Kit has been produced as a resource for agencies to use to support children to cycle and that he would distribute it to the Committee for comment by April 25, 2014.

Discussion ensued with respect to incorporating a Bike Rodeo with the Tour de Mississauga, the Peel Safety Village and using Can Bike as a resource at the Tour de Mississauga.

Jacquelyn Hayward Gulati, Manager, Active Transportation noted that she would approach Can Bike staff to be present at the Tour.

6. 2014 Ontario Bike Summit

Jacquelyn Hayward Gulati, Manager, Active Transportation and Irwin Nayer, Citizen Member provided a verbal update regarding the 2014 Ontario Bike Summit. They spoke to the success of the summit and that the Minister of Transportation announced investing \$10 million over the next three years to help municipalities improve cycling infrastructure.

7. Bicycle Friendly Community – Go for Silver Strategy

Jacquelyn Hayward Gulati, Manager, Active Transportation distributed a memorandum dated April 22, 2014 regarding the Bicycle Friendly Community – Go for Silver Strategy. She spoke to the bicycle friendly community feedback, Cycling Master Plan and implementation strategy.

Irwin Nayer, Citizen Member spoke to a presentation at the Ontario Bike Summit that provided ideas to achieve silver such as; engaging the silent minority to cycle and being proactive. Mr. Nayer further spoke to other municipalities disengaging from Committees of Council and helping Council under benefits of cycling business cases.

Discussion ensued with respect to the perception of the Mississauga Cycling Advisory Committee (MCAC) to Council, engaging youth to provide feedback and social media.

RECOMMENDATION

That the City of Mississauga adopt the goal of achieving a “Silver” designation for Mississauga as part of the Bicycle Friendly Community award program and that Mississauga Cycling Advisory Committee Members and City staff work together to develop a “Go for Silver” strategy that identifies key areas of focus for 2014 and report back on progress.

ACTION NEEDED TO PASS IMPORTANT ROAD SAFETY BILL

As many of you know, on March 17, 2014, the Ontario government introduced Bill 173 the Keeping Ontario Road's Safe Act. This Act is a very important piece of Legislation with some key aspects that affect cycling.

We need your help to ensure that it gets passed before a potential election. Some of the important cycling advancements in the Bill include:

- The introduction of a one-metre safe passing law.
- Increased penalties for "dooring", including demerit points to those who open their vehicle door in the path of an oncoming cyclist.
- Enhanced tools for municipalities to improve safety -- contra-flow bicycle lanes, bicycle traffic signal leads that allow cyclists the opportunity to go ahead of motorized vehicles at intersections.
- The legalization of riding on paved shoulders.

Share the Road has drafted a template letter that you can use to send to your MPP to urge them to do

what they can to pass this Bill quickly.

This government Bill incorporates several Opposition-led Private Members Bills including: Cheri DiNovo (Parkdale High-Park) and Norm Miller (Parry Sound Muskoka), and enjoys strong Opposition support. However, given the possibility of an election on the horizon it is important that you email your MPP and urge them to ensure that Bill 173 receives the required debate and Committee discussion required for the Bill to pass.

The Ontario Bike Summit kicked off on Sunday, April 13th with two incredible concurrent workshops.

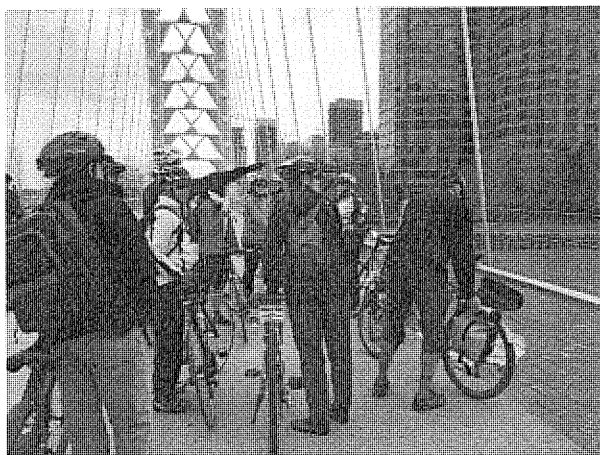


All in all, it was an incredible night of food, fashion and fun, and a fitting way to celebrate the incredible successes that have been achieved in cycling since last year's Summit.

Bill 182, An Act to proclaim the month of June as Ontario Bike Month, was tabled by Bob Delaney



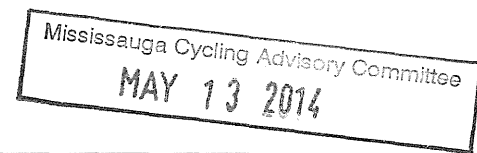
