2. Grant Opportunity – Ontario Cycling Training Fund

Ben Gomberg, Manager, Active Transportation spoke to a grant opportunity from the Ontario Ministry of Transportation for cycling safety education. He spoke to the grant application process and that the City would submit the grant application to create a peer to peer teen ambassador cycling training program.

Greg Symons, Citizen Member enquired who would train the trainers. Mr. Gomberg noted that staff are still in the development stages are creating the program.

Barbara Tabuno, Citizen Member expressed her support for engaging youth in cycling.

3. Lines on Heavily Used Trails

Members of the Mississauga Cycling Advisory Committee discussed painting lines on heavily used trails.

Jacqueline Hunter, Active Transportation Technologist spoke to the current Council approved Cycling Master Plan and that painted lines are at intersections as a directional tool to cyclist.

Irwin Nayer, Citizen Member expressed support for having painted center lines as it would bring a sense of order to cyclists and pedestrians and requested that priority locations be looked at.

RECOMMENDATION

That Transportation and Works staff and Community Services staff be directed to identify heavily used trails to paint central lines and to consider budget and maintenance implications.

4. Share the Trail Signage

Ben Gomberg, Manager, Active Transportation presented a recently produced way finding trail sign for Lake Aquitaine.

Members of the Mississauga Cycling Advisory Committee (MCAC) expressed concern with the top spacing and lack of information on the sign.

Councillor Fonseca noted that the Lake Aquitaine way finding sign was a direct response from the ward Councillor and that this sign was part of a pilot project and would be reviewed in one year.

5. 2nd Quarterly Update on the Proposed 2015 Network Program

Jacqueline Hunter, Active Transportation Technologist discussed the memorandum dated August 5, 2015 regarding the 2nd Quarterly Update on the Proposed 2015 Network Program. She noted a few projects were moved to be completed in 2016 and that altogether 26.2km of cycling infrastructure is proposed to be constructed in 2015.

Councillor Fonseca requested that staff review the Eastgate Parkway location from Eglinton Avenue to see if the lanes could be a multi-use trail.

Dorothy Tomiuk, Citizen Member made note that the Cycling Master Plan indicates that 30km of cycling infrastructure would be completed each year.
