A. Michael Gusche, Project Manager with respect to Park 302 Draft Master Plan.

Michael Gusche, Project Manager spoke to Park 302 Draft Master Plan and outlined the location, characteristics of the four season park, a mountain bike circuit, pedestrian trail, leash free area and outlined the proposed timeline.

Discussion ensued with respect to the opportunity to create connectivity with adjacent roadways to develop a complete cycling network.

### 2. <u>Tour de Mississauga Subcommittee</u>

Dorothy Tomiuk, Citizen Member provided a verbal update regarding the upcoming Tour de Mississauga. She spoke to registration, promotion/communications plan, sponsorship, start/finish line enhancements, t-shirts and jerseys, bike plates, letter to the Region of Peel, food, route design, mapping, and volunteers.

### 3. <u>Network and Technical Subcommittee</u>

Donnie Morris, Citizen Member and Irwin Nayer, Citizen Member provided a verbal update regarding the Network and Technical Subcommittee. Mr. Morris and Mr. Nayer spoke to the subcommittees review of on-road and off-road cycling infrastructure priorities, gaps in the network, development priorities, routes, multi-use trails and addressed challenges for commuters. Mr. Irwin noted that prioritizes should focus on building commuter facilities.

Committee members engaged in conversation regarding the need for appropriate commuter routes going north-south in the west end and east-west in the north end of the corridor, Lakeshore Royal Windsor Trail, Lakeshore Road, BRT bikeway and safety concerns at busy intersections.
