PRESENTATIONS/DEPUTATIONS

- A. Angelo Ambrico, Active Transportation Intern with respect to cycling collision analysis.

Angelo Ambrico, Active Transportation Intern spoke to the bicycle-automobile collision study. Mr. Ambrico spoke to the studies objectives, data collection, study variables, spatial characteristics and the study scopes limitations. He further outlined that 60% of reported cycling collisions involved cyclists riding on a sidewalk and 25% involve cyclist on the roadway.

Discussion ensued with respect to creating a program to specifically educate the male cyclist demographics between 16-19 and 40-50years old on passing cars and on riding at intersections on the curb side.

2. Mississauga Cycling Advisory Committee Strategic Planning for 2015

Members of the Mississauga Cycling Advisory Committee discussed their goals and vision for 2015. Comments included;

- Create a formal Community Ride Subcommittee which would create schedules, routes and coordinate refreshments
- Create a formal Bicycle Friendly Community Award – Go for Silver Strategy Subcommittee
- Create a formal Tour de Mississauga Subcommittee
- Look for future opportunities and structures for the Tour de Mississauga
- A transition plan for the 2016 Tour de Mississauga
- Increased focus on safety and youth
- Engage youth
- Determine a main focus for the Committee
- Enforcement blitz
- Cycling Master Plan review

3. Network and Technical Subcommittee

Donnie Morris, Citizen Member provided an overview of the Network and Technical Subcommittee and noted the main focuses of the subcommittee are the Community Ride program and the gap study analysis.

Committee members engaged in conversation regarding creating a Community Ride during youth week, involving the GTAA in the 2015 Community Rides and for the Mississauga Cycling Advisory Committee to work with the Traffic Safety Council to look at opportunities in creating a cycling route for students to ride to school.

4. Communications and Promotions Subcommittee

Joanne de Cloe, Citizen Member noted her current involvement in the Youth Engagement Committee and her continued support of promoting cycling.

5. Bicycle Friendly Community Award – Go for Silver Strategy

Irwin Nayer, Citizen Member noted that the Bicycle Friendly Community Award application had been delayed and that the new deadline is February 20, 2015. Mr. Nayer noted the need for solid communication between the cycling communities and Share the Road Coalition.
