## PRESENTATIONS/DEPUTATIONS

#### Hurontario-Main LRT

Matthew Williams, Project Leader provided an overview regarding the Hurontario-Main LRT project and noted that the LRT is currently in the design and environmental process and that the next public meeting would be held on May 14, 2013 in the Great Hall for public input. He outlined various cycling options to be considered for the LRT including cycling along the corridor through multi-use trails or bike lane connections, cycling on the system and cycling locations along LRT stops. He noted that certain areas along the LRT corridor cannot accommodate cycling lanes due to the width of the road.

Members of the Mississauga Cycling Advisory Committee (MCAC) expressed support of the proposed Hurontario-Main LRT project and were encouraged with the amount of cycling progress. Jeff Wachman, Chair expressed concern with no available funding for the LRT. Dorothy Tomiuk, Citizen Member inquired when the opening day would be anticipated for. Mr. Williams noted that they anticipate opening day would be in 6 - 7 years.

## 2. <u>Communications and Promotions Subcommittee</u>

Jacquelyn Hayward Gulati, Manager, Cycling Office spoke to the Phil Green Recognition award and noted that the Communications and Promotions Subcommittee need to hav a meeting to discuss the nomination that was received.

## 3. <u>Tour de Mississauga Subcommittee Update</u>

Dorothy Tomiuk, Citizen Member provided an update regarding the 2013 Tour de Mississauga and noted that she is working with the Region of Peel to possibly create a mobile app for the Tour. She noted that Donnie Morris would be in charge of the sponsorship list and that MiWay still needs to be confirmed as a sponsor for the 15km family ride.

## 4. <u>Network and Technical Subcommittee</u>

Donnie Morris, Citizen Member provided an update regarding the 2013 Ward Rides and confirmed all Ward Ride dates have been finalized and that route maps are currently being created. Jeff Wachman, Chair noted that all Mississauga Cycling Advisory Committee (MCAC) members should participate in at least two Ward Rides and that the Ward Councillors should also be present. MCAC members engaged in conversation regarding Councillors' Offices contacting local ice cream shops to promote Ward Rides, local bicycle shops promoting Ward Rides, cycling related swag to be handed out at each ride, Corporate Security to participate in Ward Rides and photo opportunities at the start of each ride.

## 5. Quarterly Update on Proposed 2013 Cycling Network Program

Jacquelyn Hayward Gulati, Manager, Cycling Office discussed the quarterly update on the Proposed 2013 Cycling Network Program. She outlined construction progress for onroad cycling routes and multi-use trails and the proposed 2013 work plan for on-road cycling routes and multi-use trails. Jeff Wachman, Chair inquired if the way finding signage font sizes have increased as previously mentioned by MCAC members. This was addressed by Ms. Hayward-Gulati that yes the sizes would be look at.
