#### PRESENTATIONS/DEPUTATIONS

#### A. <u>Significant Tree Program</u>

Sarah Jane Miller, Forest Ecologist Assistant, spoke with respect to the Significant Tree Program. Ms. Miller indicated that the program was developed in 2007 through the Heritage Advisory Committee. She also advised that any tree that has historical significance, unique form, is rare in a region or has extraordinary height or diameter is eligible to be nominated for Significant Status.

Ms. Miller advised that there is a database where information about all trees of significance is stored. Web site development is currently in progress which lists significant trees and provides a link to the nomination form. It is hoped that the web site will be launched in April to coincide with Earth Day.

Currently all trees in the program are on public property. The committee explored the feasibility of including privately owned trees but was advised by Legal that it was not an option due to privacy issues. Ms. Miller explained that a letter of recognition is sent to a person who nominates a worthy tree and demonstrated how she adds a tree of significance to the database.

Committee members inquired whether there would be some sort of identification near the tree that would indicate it is a tree of significance and Ms. Miller confirmed that they are looking into providing a plaque at the base of identified trees. It was also suggested that significant trees could be added to a cycling map.

#### B. <u>EcoBuzz</u>

Lucas Krist, Peel Environmental Youth Alliance and Rahul Mehta, EcoSource spoke with respect to the 10<sup>th</sup> Annual EcoBuzz Conference which was held on October 24, 2012 and took place at Sheridan College. Mr. Krist and Mr. Mehta indicated that there were

approximately 300 participants who attended the conference from eighteen secondary schools.

Fourteen unique workshops with en environmental focus were offered to attendees, which were well received. There was media coverage of the conference and Rogers TV created a video of the event. Mr. Krist expressed thanks to Rogers TV and to City of Mississauga staff who attended as exhibitors. Mr. Krist also mentioned that Whole Foods generously donated food, as did Ontario Turkey Farmers.

Committee members expressed praise to Mr. Krist and Mr. Mehta for a job well done. Councillor Carlson advised that he would contribute to the 2013 EcoBuzz budget.

C. Expanding Natural Heritage Through Greening Hard Infrastructure

Dr. Brad Bass, Citizen Member, spoke with respect to methods of greening hard infrastructure. Dr. Bass explained that this involves utilizing the landscape that has been developed and mentioned bioswales, biofilter cells and rain gardens. Dr. Bass also explained how Green Roofs were being developed and the tremendous positive impact on energy efficiency.

Mary Bracken, Environmental Specialist requested to receive the PowerPoint presentation to share with Planning and Building staff. The committee inquired about how the Planning and Building Department educates developers and the architectural community. Ms. Bracken described the Green Development Strategy noting that it is a voluntary program that encourages new development to "go green". Ms. Bracken also advised that as part of the strategy a web site is being created to provide applications and resources to developers.

Councillor Tovey noted that the Urban Design Awards should include green building and Ms. Bracken noted that the categories and criteria would have to be strengthened. It was suggested that a report could be written to make a recommendation with respect to creating a green award in Urban Design.

Discussion ensued with respect to funding, policies and current by-laws. A member of the Credit Valley Conservancy spoke at this time with respect to the creation of demonstration areas and noted that there was one in Lakeview. Dr. Bass noted that a cost analysis would have to be completed and Ms. Bracken noted that there were a number of pilot projects in place and that the public needs to be educated to encourage such initiatives.

REPORT HIGHLIGHTS:	<ul> <li>On April 10, 2012, the Environmental Advisory Committee (EAC) received correspondence from Mayor Hazel McCallion and a deputation from a Mississauga resident concerned about wood smoke from indoor wood burning in her neighbourhood. EAC directed staff to further review this issue, prepare a draft by-law, and research short- and long-term policy options to address smoke from indoor wood burning and report back to EAC.</li> <li>In October 2012, the Canadian Council of Ministers of the Environment (CCME) released a "Code of Practice for Residential Wood Burning Appliances" which provides a review of the issue, existing standards, initiatives and regulations, as well as options for</li> </ul>

governments designing policies and programs to reduce wood smoke emissions.

• Staff from the Environment Division, Community Services Department, conducted additional research and met with staff across the Corporation and from the Region of Peel Public Health Unit to evaluate the options to address smoke from indoor wood burning.

#### **BACKGROUND:**

At the April 10, 2012 meeting of the Environmental Advisory Committee (EAC), the Committee received a Memorandum dated March 13, 2012 from Mayor Hazel McCallion with respect to concerns from Ward 1 resident Lydia Pawlenko Lobos regarding smoke from residential wood burning appliances. At the same meeting, Ms. Pawlenko Lobos provided a deputation outlining her concerns around the potential health and environmental impacts of wood burning appliances. Staff from the Region of Peel Public Health Unit also provided information related to the issue.

As a result of the discussion, EAC made the following Recommendation: "That the Memorandum dated March 13, 2012 from Mayor Hazel McCallion with respect to smoke from home wood stoves be received and referred to Environmental Management staff for further review and preparation of a draft by-law, in consultation with Legal staff, and a Corporate Report on short- and long-term policy options (including addressing the improper use of home wood stoves and regulation by the provincial government) for home wood stoves for consideration at a future Environmental Advisory Committee meeting."

#### PRESENT STATUS:

In October 2012, the Canadian Council of Ministers of the Environment (CCME) released a "Code of Practice for Residential Wood Burning Appliances" which provides a review of the issue, existing standards, initiatives and regulations, as well as options for governments designing policies and programs to reduce wood smoke emissions.

The CCME report lists the most common types of wood burning appliances on the market as: wood stoves, pellet stoves, fireplaces (conventional fireplaces, advanced technology fireplaces and fireplace inserts), wood-fired central heating, wood cook stoves, and masonry heaters.

In Canada, the Canadian Standards Association's (CSA) Performance Testing of Solid Fuel Burning Heating Appliances (CSA B415.1) is the emission standard that exists for advanced residential wood burning appliances. Appliances that meet this standard are less likely to create air quality concerns. Compliance with this standard is voluntary, except where regulated provincially or municipally. In Ontario, this standard is not part of the requirements related to wood burning appliances in the Ontario Building Code.

In Mississauga, it is unknown how many residential wood burning appliances exist of any type and whether they are conventional or advanced standard appliances.

Currently, no provincial regulation in Ontario exists regarding residential wood burning appliances and no municipal by-law exists in Mississauga that addresses indoor residential wood burning. City staff conducted additional research and are not aware of municipalities regulating indoor residential wood burning in Ontario.

The City of Mississauga's Open Air Burning By-law regulates the setting of outdoor open air fires.

Over the years, the Region of Peel Public Health Unit (Peel Public Health) has promoted the practice of smart and safe wood burning through various tactics. Peel Public Health has recently updated information on the Region of Peel's website regarding residential wood burning best practices.

#### **COMMENTS:**

Staff from the Environment Division, Community Services Department, met with staff from the Legal Services Division, City Manager's Department, the Building Division, Planning and Building Department, the Enforcement Division, Transportation and Works Department, the Fire and Emergency Services Division, Community Services Department, and Region of Peel Public Health staff to review a number of options related to indoor residential wood burning. The following is a summary of the main points discussed by staff:

- The smoke from wood burning appliances can contribute to poor air quality and impact human health. Children, the elderly and those with underlying health conditions are more at risk to the effects of wood smoke.
- In Mississauga, indoor residential wood burning is assumed to be mainly for aesthetic and social reasons and minimally for home heating.
- Very few complaints are received by the City of Mississauga or the Region of Peel related to indoor wood burning in Mississauga.
- Staff from the Enforcement Division, Transportation and Works Department, does not have the authority to enter private homes to determine suitability of indoor wood burning appliances.
- Staff from the Fire and Emergency Services Division, Community Services Department, does not have authority to enter private homes to determine suitability of indoor wood burning appliances unless there is a fire safety concern.
- Little education is occurring in Mississauga regarding the environmental and health issues of wood burning, proper wood burning techniques, or the correct use of wood burning appliances.
- Staff from the Fire and Emergency Services Division, Community Services Department, currently conducts a door-to-door outreach program to educate homeowners on fire safety called "Home Safe Home".
- Building inspectors currently review new installations of indoor wood burning appliances according to the requirements in the Ontario Building Code.

The CCME report identifies best management practices for governments to consider in reducing residential wood smoke emissions.

#### **OPTIONS:**

The following summarizes the CCME seven best management practices that were considered by City of Mississauga staff.

#### **Short-Term Options**

**1. Curtail Wood Burning During Times of Poor Air Quality** During times of poor air quality, the City of Mississauga and Peel Public Health can discourage wood burning.

Messaging to curtail wood burning could be incorporated into the City of Mississauga's existing Smog Response Plan which is triggered during Air Quality Advisories as determined by the Ministry of the Environment. Traditionally, Air Quality Advisories occur during the summer months, however, occasionally there are advisories issued during the colder seasons.

#### 2. Increase Public Outreach and Education

Communication tools, such as websites, can increase public awareness around the health and air quality impacts associated with wood burning. Outreach programs also provide a way to educate homeowners with respect to the proper operation and maintenance of their wood burning appliances.

New tactics for this option could include creating a web page on the Mississauga Living Green website to educate on proper wood burning, along with utilizing the current door-to-door outreach program delivered by the Fire and Emergency Services Division, Community Services Department, by adding messaging on the proper use of wood burning appliances.

#### 3. Emissions Reporting

The City can encourage residents to report wood smoke concerns to the Ministry of the Environment (MOE) Spills Action Centre (SAC). The SAC operates 24 hours a day and can be reached through a province-wide toll-free number.

The role of the SAC is to receive reports of spills and other environmental matters and initiate or co-ordinate a response as required. All complaints are registered and the appropriate response determined by the officer on duty. A complaint may result in a site visit or warning letter.

The MOE has limited legislative tools to address wood smoke from indoor appliances.

#### **Long-Term Options**

### 4. Limits on Installation or Operation of Wood Burning Appliances

In jurisdictions that experience significant episodes of air quality degradation from wood smoke, municipalities can limit the use of certain types of wood burning appliances.

Before considering limits, municipalities need to assess the wood smoke risks by considering the number of complaints, appliance inventories, appliance usage, ambient air quality monitoring information and visible haze.

The success of this approach depends on the capacity for a municipality to carry out appliance inspections. Mississauga is not resourced to carry out these types of inspections at this time. There is also a low number of complaints received and there is no information available regarding appliance inventories or appliance usage along with detailed air quality information. This option is not practical at this time.

#### 5. Incentives to Change

Municipalities can reduce wood smoke emissions by providing incentives to encourage homeowners to remove uncertified conventional appliances from use. Options for incentives include: rebates for wood burning appliance replacement, rebates for wood burning appliance fuel switching, or financial compensation for wood burning appliance removal.

Jurisdictions that have tried this option report low participation rates largely due to limited awareness of the environmental and health impacts of wood smoke, concern about out-of-pocket costs, reluctance to change habits and insufficient rebate funding.

#### 6. Regulate Appliance Efficiency

This option would require the City to enact and enforce a by-law which makes all new wood burning appliances meet either the CSA B415.1 advanced standard or the United States Environmental Protection Agency's (US EPA) Standards of Performance for New Residential Wood Heaters, Section 60-532 of the 1988 Clean Air Act. Enforcing this standard would be over and above the requirements of the Ontario Building Code.

Staff from the Legal Services Division, City Manager's Department, has advised that because the Ontario Building Code Act (BCA) specifically allows wood burning appliances, creating a stricter requirement or a limitation on such appliances would cause a conflict between the provisions of the BCA and the Municipal Act. Although the Municipal Act provides municipalities with the authority to pass by-laws for the well-being or health of residents, in the event of a conflict, the provisions in the BCA would take precedent.

The MOE has been pursuing an amendment to the Building Code to include requirements for cleaner wood burning appliances under CSA B415.1. The Ministry of Municipal Affairs and Housing (MMAH) is responsible for considering such amendments to the Code. The CSA standard is expected to be considered in the next interim amendment or final draft of the Code.

#### 7. Enact a Nuisance By-law

Enact a municipal nuisance by-law that requires indoor wood burning appliances to be regularly maintained so that they do not create a nuisance.

This is not considered a practical option as every wood burning appliance in Mississauga would need to be inspected and the by-law would be extremely challenging to enforce.

#### STRATEGIC PLAN:

Increasing education and outreach efforts will help to achieve the Strategic Goals of the Living Green Pillar to "Lead and Encourage Environmentally Responsible Approaches" and "Promote a Green Culture".

FINANCIAL IMPACT: Not applicable.

#### **CONCLUSION:**

In response to EAC's recommendation, due to the resources required to enact and enforce a by-law, given that the City has only received a few complaints regarding smoke from indoor residential wood burning, and given that little education regarding the air quality and health issues of wood burning, proper wood burning techniques, or the correct use of wood burning appliances is occurring, staff feel the best option is to follow the CCME recommendation to increase public education and outreach.

City staff recommend that the most efficient and cost-effective recommendation is to work with the Fire and Emergency Services Division, Community Services Department, "Home Safe Home" program to educate homeowners on proper wood burning techniques, increase messaging to curtail wood burning during poor air quality events, increase the information available on the City of Mississauga's Living Green website, and promote the information available on the Region of Peel's Public Health website.

The "Home Safe Home" program provides door-to-door outreach to approximately 30,000 homes in Mississauga every year. Additional tips regarding wood burning can be included in this program, including, but not limited to:

- Burn clean wood only
- Use the right type of wood
- Properly maintain and use a wood burning appliance
- Use an appliance that is certified to either the CSA B415.1 or US EPA standards for low emissions
