Karen Morden, Legislative Coordinator, Office of the City Clerk called the meeting to order in the absence of a Chair of the Environmental Action Committee.

APPOINTMENT OF THE CHAIR

Ms. Morden, Legislative Coordinator, called for nominations for appointment to the office of the Chair of the Environmental Action Committee for the term ending November 30, 2018.

Councillor Carlson nominated Councillor Mahoney and Councillor Mahoney accepted the nomination.

DEPUTATIONS

A. Christopher Davidson, Evidence for Democracy with respect to Climate Change and Stormwater.

Mr. Davidson made a PowerPoint presentation with respect to Climate Change and Stormwater, commenting on responding to climate change, stormwater design, impacts and risks, solutions and next steps.

Mr. Davidson briefly explained stormwater design noting that pipes and overland flow were used and that sizing was based on risk and needs using Intensity Duration Frequency (IDF) Curve statistics from Environment Canada, which are based on historic records. Mr. Davidson spoke to the risks of property damage, the health and safety of residents and the liability involved and noted that Environment Canada is in need of updated IDF Curve statistics, yet are not mandated at this time to do so.

Discussion in support of requesting Environment Canada to update IDF Curve statistics ensued amongst members and a recommendation was agreed upon.



Update on Community Environmental Appreciation Event

Background

On May 7, 2013, the Environmental Advisory Committee received a report that outlined options for community recognition. The Committee agreed to move forward with the option to host an annual celebration and networking event in the spring of 2014.

The first annual Community Environmental Appreciation Event was held on June 4, 2014, in partnership with Forestry staff from the Parks and Forestry Division to recognize both environmental and forestry initiatives. About 100 people attended including representatives from community groups, schools, businesses, and City staff.

2015 Event Details

The second annual Community Environmental Appreciation Event is scheduled to be held at C Banquets from 7:00 p.m. to 9:00 p.m. on Thursday, June 11, 2015.

This is an invitation only event that will recognize and thank Green Leaders in communities across the city for their environmental work. An invitation for project submissions has been sent out through a survey to non-profit organizations, school groups, businesses, individuals, and more. Projects will be assessed based on their community involvement and impact as well as their support of the priorities and actions in the Living Green Master Plan.

The evening will feature opening remarks by the Mayor and/or Members of Council, project presentations and networking opportunities. Additionally, projects and initiatives will be highlighted through exhibits and a slide show. Light refreshments will be available.
