



Dear Mayor McCallion and Mississauga City Council Members:

I'm writing on behalf of PETA, the world's largest animal rights organization, with more than 3 million members and supporters worldwide. Our office has received calls and e-mails from concerned Mississauga-area citizens about the need for stronger animal protection laws in Mississauga, specifically banning continuous chaining and penning of dogs. We understand that the council is considering restricting dog chaining and recently received a recommendation from an appointed committee to limit chaining to four hours in any 24-hour period. We applaud the council's attention to this important issue. However, I am writing today to urge you to altogether ban this cruel and dangerous practice in your city.

The Ontario SPCA, one of the largest animal welfare organizations in Canada, says of chaining, "Dogs should NOT be chained. Severe physical injury, even death, can easily result. Chained dogs also suffer psychologically and they are 80% more likely to bite." As concerned Mississauga residents have brought to your attention, chained dogs are often deprived of adequate food, water, and veterinary care—in addition to having their emotional and social needs completely ignored. Many are denied proper shelter and have nothing but an overturned trash bin or plastic barrel—or nothing at all—to shield them on freezing winter nights. Numerous chained dogs have frozen to death during cold snaps or died of heatstroke on sweltering summer days. Canada is no stranger to these cases. The following are just a handful of the many reported cases of neglect and cruelty in which chained dogs have been the victims:

- Twenty-five emaciated Scandinavian hounds were discovered earlier this year chained at a site in Waterford with no home or buildings nearby. Officials questioned the regularity of their feeding because they observed that the dogs had poor body condition. The Welland & District SPCA seized the dogs as a result of frigid temperatures and a fear that the dogs would not survive the night.
- In 2013, a Renfrew woman was charged with cruelty to animals when the Ontario SPCA discovered a <u>severely emaciated hound chained</u> on her property, in addition to more than two dozen neglected chickens.
- A guard dog from Cape Breton died when he <u>froze on his chain</u> in the bitter winter cold in 2010
- Also in 2010, Ontario chained dog Stanley, who was unmonitored, <u>hanged to death</u> on his chain, which is a disturbingly common way for chained dogs to die.

Addressing this blatant cruelty, Canadian municipalities <u>Calgary</u> and <u>Victoria</u> have completely banned unattended tethering.

Chaining dogs is a public-safety hazard because it turns otherwise friendly dogs into ticking time bombs. Hundreds of individuals—most of them young children—have been attacked, some fatally, by chained dogs. In fact, a 4-year-old boy in Shelburne was bitten in the face while approaching a neighbor's chained dog earlier this year. Experts on animal behavior agree that chaining causes aggression in dogs. Dr. Nicholas H. Dodman succinctly states, "Chaining dogs makes them more aggressive—the shorter the chain, the greater the aggression." Dogs are highly social pack animals, and according to Annapolis Valley dog behavior expert Silvia Jay, "Dogs are not made to live alone, they need social companionship." She adds, "In my opinion, dogs should be inside the house."

We understand it has been suggested to the council that working dogs be exempt from the protections of a new animal-related ordinance. We implore you to extend the protections of this ordinance to include working dogs, considering that all dogs, regardless of breed or whether they are kept as companions or as working animals, are susceptible to the physical and psychological suffering caused by chaining. Working dogs, who dedicate their lives to serving others, would seem to be especially deserving of protection.

A full ban on chaining is simple and easy to enforce. With this type of restriction, identifying and assessing a potential violation requires very little effort. It's easy to train enforcers to recognize signs of continuous tethering as opposed to momentary attachment, such as when dogs are taken outside to relieve themselves. The longer the period of time that tethering is permitted within a 24-hour period, the harder it is to enforce. However, the discussed four-hour chaining restriction would certainly be better than no ordinance at all.

We respectfully urge the council to pass an <u>ordinance</u> that would ban the continuous chaining of dogs.
