Good morning Madam Clerk,

Re : ITEM 20 proposed street name for future commercial/residential development Ward I page 121

I read with interest the Agenda for the above meeting and I would like to suggest that the road be named **Admiral Street** or **Admiral Rd.** and the reason for that is that while I was at University and working part time at the Toronto Star in the 50's I had the privilege of attending a stormy meeting at Clarke Hall because the taxes in Toronto Township had zoomed so drastically, the public gathered there were throwing lightbulbs at the elected council of the day. Out of that meeting came a young lawyer Mary Fix who recognized the importance of a well grounded tax base set out to bring in Industry and one of the first ones was via her brother an executive with **Admiral Corporation** and they moved into that location at 501 Lakeshore Rd. E, Reeve Mary Fix was also instrumental in bringing in Industry to Dixie Rd. and Stanfield Rd. 501 should be remembered for its historical value to who we are today. contiuing to bring in commercial and residential mixed development. which supports the tax base. and creates employment/residential.

I met Mary Fix later on at the Inaugural of the first Peel Region Council when Lou Parsons+ was appointed its first Chair and we shared some many memories of which I gained a better understanding as a married woman with three children and a resident of this City since 1962.

Another suggestion comes from historian Dave Cook which I embedded here

"Just a footnote to the Admiral plant. A former AVRO engineer went to Rockwell following the shut down of the AVRO Arrow pgm. He headed up the development and design team of the first space shuttle. His name was John Sandford. Following his retirement from Rockwell he ended up becoming president of Canadian Admiral at that location. The company was then owned by Rockwell. Just a little trivia. "
