#### DEPUTATIONS

A. Item 1 Geoff Wright, Works Operations & Maintenance

Mr. Wright provided an overview of the ARRASC and noted that he would like feedback from Committee to take forward to the ARRASC.

Members of Committee spoke to the matter and raised the following concerns:

- The delay in transferring road maintenance of Winston Churchill Boulevard to the Region of Peel and the status of the negotiations.
- The importance of Mississauga establishing their position on the matter.
- The matter should be addressed again at Regional Council to review the Mississauga model for road maintenance.
- The possibility that the upgrading of the traffic signals in the Hanlan Project will not be in place like the City planned.

Martin Powell, Commissioner, Transportation and Works spoke to the issue of transferring Winston Churchill to the Region of Peel and noted the difference in opinion with Regional staff.

Mr. Wright advised that the Region of Peel has oversight of the roadway on Dixie Road, but the City is in charge of the operation and maintenance of the signals and getting the plans approved by the Region. Mr. Powell reiterated that the Region retains jurisdiction over their roads and are involved with the traffic and capital planning. Janice Baker, City Manager spoke to the matter and noted that Mississauga and Brampton could move forward at looking at the Regional roads.

Councillor Fonseca arrived during discussion at 9:08 am.

# 2. <u>Amendment to Fireworks related By-Laws to make Exceptions for Diwali and Chinese New</u> <u>Year Celebrations</u>

Corporate Report dated October 6, 2015 from the Commissioner of Community Services with respect to an amendment to fireworks related By-laws to make exceptions for Diwali and Chinese New Year Celebrations.

Tim Beckett, Fire Chief spoke to the subject report and noted that the matter would go to the Diversity and Inclusion Advisory Committee (DIAC) for further recommendations following the trial period of one year.

Councillor McFadden spoke to the matter and noted that DIAC would look at any further recommendations at a future meeting.

# RECOMMENDATION

That all necessary by-laws be enacted to allow for a temporary exception that would permit the setting off of fireworks for Diwali (November) and Chinese New Year (January) in accordance with the Corporate Report dated October 6, 2015 from the Commissioner of Community Services and that the said exemption be effective as of November 1, 2015 for a period of one year.

- 2. That the cost of the additional notification of property owners beyond the statutory 60.0m (196.85ft.) circulation area be the actual cost of the additional properties circulated and be borne by the applicant.

- 3. That the Planning Act Fees and Charges By-law 0246-2015, be amended, to reflect the additional fee requirement for circulation of applications that seek relief from a separation distance identified in Table 2.1.2.1.1 of Zoning By-law 0225-2007, as amended.

10. <u>Municipal Act, 2001, Five-Year Provincial Review</u>

Corporate Report dated October 7, 2015 from the City Solicitor with respect to the *Municipal Act, 2001,* Five-Year Provincial Review.

Members of Committee spoke to the matter and raised the following concerns:

- Municipalities should get the same taxation powers as the Province.
- The heads and beds tax at the hotels is of concern because all of the money that is received from Mississauga hotels goes to Tourism Toronto which does provide funding to Mississauga tourism. However, the tax is optional and most of the hotels in Mississauga don't sign on to charge the tax. It would be ideal to have the taxation authority for hotel rooms where the money goes directly towards Mississauga tourism.
- Uber and how it relates to the shared economy aspect under the legislation amendments.
- Income tax should be shared with municipalities and not just the Federal and Provincial Governments.
- Regulation of internet dispatching businesses in the legislation is needed.

Janice Baker, City Manager spoke to the matter and noted that it is the position of staff that precedence has been set that Toronto has been given special levy abilities. In response to a question, Ms. Baker explained that Uber is an asset that people choose to share with other people. Mary Ellen Bench, City Solicitor explained that there are different companies with similar ideas and we are concerned with safety etc. This is a good time to clarify jurisdiction and who regulates it.

#### **RECOMMENDATION**

That the report titled "Municipal Act, 2001, Five-Year Provincial Review" by the City 1. Solicitor be received for information;

# **COUNCILLORS' ENQUIRIES**

Mayor Crombie requested that staff discuss with Metrolinx with respect to GO buses that park on Duke of York Boulevard and City Centre Drive and don't use their 4-way flashing lights and block the site lines from the retail driveways.

Councillor Parrish spoke to a matter where a company is requesting to build 2 bus shelters on the road allowance for the chartered transit shuttles for their employees. She further noted that they were told they can't build the bus shelters due to liability issues. Martin Powell, Commissioner, Transportation and Works noted that staff could review it.

Councillor Parrish spoke to the Sportsman Show that displays the heads of dead animals and noted that she would be sending letters to the sponsors to discourage supporting the show. She noted that the City should take a position that this show is unacceptable.

Councillor Saito noted that she has received concerns that the Busway station at Erin Mills is being used by GO Transit and not by MiWay buses. She noted that she would like staff to look into this as there is no connection from MiWay to the GO buses at the station.

Councillor Saito spoke to a recent coyote attack near the central Erin Mills community. She requested that Communications staff work with Animal Services to put out alerts to the media and residents.

Councillor Mahoney spoke to a timing and safety issue with traffic signals at Redstar and Dundas and Sherwood Forest and Dundas on the other side. He requested that staff look into when the signals will be fixed by the contractor and clarification on "one and done" with a contractor for an emergency issue.

Councillor Tovey enquired about the timing for the report regarding a request for an all-way stop at Helene Street and Port Street. Mr. Powell advised that he would look into it.

Councillor Fonseca noted an issue with idling school buses at Tomken Public School. Mr. Powell noted that he would speak with Enforcement staff and Councillor Fonseca with respect to the Noise By-law. Councillor McFadden noted the same issue for Lisgar Middle School where the buses are parking on City property abutting the Lisgar Fields Park.

Councillor McFadden noted that there was a hold and secure at 2 schools in Ward 10. She enquired if there is an emergency management or communications protocol for what response to have. Janice Baker, City Manager noted that staff can contact the School Boards to include members of Council in their communication.

Councillor Saito expressed concern with the Sign By-law with respect to regulating banners on residential property. Ed Sajecki, Commissioner, Planning and Building advised that he would look into it.

#### **OTHER BUSINESS/ANNOUNCEMENTS**

Mayor Crombie spoke to the Federal election. She further spoke to Lifeline Syria and the Foodbank Challenge.

Councillor Parrish announced the Raptors 905 open practice.

Councillor Mahoney spoke to attending a university lecture on the City budget.

Councillor Carlson spoke about the Hallowe'en cycling ride hosted by the Mississauga Cycling Advisory Committee.
