DEPUTATIONS

A. Al Sousa, Manager of Traffic Engineering and Operations, to provide a project overview and update on the Advanced Transportation Management System (ATMS).

Al Sousa, Manager of Traffic Engineering and Operations spoke to the Advanced Transportation Management System (ATMS). He outlined the current transportation challenges and highlighted the benefits of investing in the ATMS. He noted that the ATMS project structure is partnered with the Region of Peel and the City of Brampton.

Mayor McCallion and Councillors Iannicca, Saito and Mullin spoke to the importance of moving goods and people in an efficient manner, the need to work with surrounding municipalities and the need to an open technology system that can grow in the future.

2. Speed Limit - Shawnmarr Road (Ward 1)

Councillor Tovey spoke to residents' concerns with the current posted speed limit and requested Members of the Transportation Committee to support a reduction in speed to 40km/h. He spoke to the need to enforce the posted speed limit and for the Peel Regional Police to complete a speed blitz.

Members of Committee spoke to the need for enforcement, community involvement and the success in reducing speed limits to 40km/h in warranted areas.

RECOMMENDATION

That a by-law be enacted to amend By-law 555-2000, as amended, to reduce the speed limit to 40km/h on Shawnmarr Road.

RECOMMENDATION

- 1. That, in accordance with Purchasing By-law 374-06, as amended, the Purchasing Agent be authorized to extend the current Street Lighting Services Agreement with Enersource Hydro Mississauga Services Inc. (EHMS) for a 2-year period from January 1, 2014 to December 31, 2015 and to execute an amending agreement to extend the provisions of the current agreement, with such changes as are made necessary or advisable by the extension and are approved as to form by the City Solicitor.
- 2. That the Purchasing Agent be authorized to amend the existing City purchase order (Contract No. 4600011546) issued to EHMS for street lighting services by extending the contract period by a 2-year period from January 1, 2014 to December 31, 2015 and by amending the contract upset limit for 2014 and 2015 subject to funding approval and satisfactory negotiation of operation and maintenance fees.

COUNCILLORS' ENQUIRIES

Councillor Tovey spoke to the issue of cyclists on the sidewalks and enquired what is being done to educate cyclist around safety. Joe Pitushka, Director, Engineering and Works requested that this matter be referred to staff to implement no cycling on sidewalks along Lakeshore Road and Bristol Road.

Madam Mayor and Councillors Fonseca, Carlson and Crombie spoke to signage on sidewalks, the involvement of the Mississauga Cycling Advisory Committee, enforcement, and the need to educate cyclists. Members of Committee requested that staff review the current by-law related to bike tire sizes allowed on sidewalks.

Councillor Iannicca spoke to the Council Code of Conduct and requested that the matter of Council Members not being allowed to make a deputation before the Committee of Adjustment be added to the Governance Committee agenda. Janice Baker, City Manager indicated that the City's Integrity Commissioner would be attending the next Governance Committee meeting and could deal with the matter.
