

MATTERS TO BE CONSIDERED

1. <u>Minutes of Previous Meeting</u>

Minutes of the Public Vehicle Advisory Committee meeting held on October 25, 2013.

<u>Approved (A. Cormier)</u>

2. <u>2010 and 2012 Taxicab Plate Issuance</u>

Mickey Frost, Director, Enforcement spoke to the Corporate Report dated November 25, 2013 from the Commissioner of Transportation and Works, with respect to the 2010 and 2012 taxicab plate issuance. He indicated that staff are looking for feedback from members of the Public Vehicle Advisory Committee (PVAC) and industry members.

Karam Punian, Resident enquired about the timeframe for the new plates to be issued. Daryl Bell, Manager, Mobile Licensing Enforcement noted it would depend on Councils decision but approximately 30 days for Staff to issue the plates.

Peter Pellier, Resident expressed concern with the proposed recommendation and to bring the report back to a future PVAC meeting.

Mark Sexsmith, Resident enquired if the proposed new taxicab plates include accessible taxicab plates. Darryl Bell, Manager, Mobile Licensing Enforcement noted that yes it includes accessible taxicab plates.

Harsimar Singh Sethi, City Area Taxicab Drivers expressed concern with the proposed recommendation as the industry cannot support 33 new taxicab plates and suggested reducing the number to 15 or 20 taxicab plates.

Gurvel Singh, Taxicab Brokerages spoke to the cost of insurance and monthly fees associated to taxicabs.

Councillor Starr, Councillor Iannicca, Nabil A. Nassar, and Baljit Singh Pandori noted that input needs to be received from industry members on the issuance of 33 new taxicab plates within the next 30 days before a decision can be made and spoke to a meter rate increase.

Paramvir Singh Nijjar, City Area Taxicab Owners expressed concern issuing 33 taxicab plates at one time.

RECOMMENDATION

- That the report from the Commissioner of Transportation and Works dated November 25, 2013 entitled "2010 and 2012 Taxicab Plate Issuance" be tabled, pending input from the Public Vehicle Advisory Committee and other stakeholders.

3. <u>Scope of Work for Consulting Services re Taxi Plate Issuance Model</u>

Mickey Frost, Director, Enforcement noted that Council had approved a budget for hiring a consulting service to review the taxi plate issuance model.

Members of the Committee engaged in conversation regarding timeframes of the study, terms of reference, scope of work and the need for input from industry members.

Harsimar Singh Sethi, City Area Taxicab Drivers expressed concern with hiring a consultant and suggested to use the expertise of Public Vehicle Advisory Committee members.

RECOMMENDATION

That the Public Vehicle Advisory Committee provide comments to staff on the draft scope of work for consulting services to review the issuance model for taxi plates and accessible taxi plates as outlined in the report from the Commissioner of Transportation and Works dated November 27, 2013 entitled "Scope of Work for Consulting Services re Taxi Plate Issuance Model".

Dear sirs or Mme.

I'm attaching the letter from Mark Sexsmith regarding the issuance of new plates. Mark has stated clearly and distinctly our position on the issuance of plates. And I concur with his findings.

The only addition I might add is that Trans help in their moving forward proposal has indicated changes in their system which will affect your taxi industry at large and I to believe that waiting for the consultant report is an important factor.

The Report from Staff presented at the December 9, 2013 PVAC meeting indicates that there should be, under the current formula for plate issuance, 33 extra plates issued.

The figures for this calculation include all taxi orders taken by brokers, including all accessible orders. Since the accessible taxis service the accessible orders, and also service regular orders, the accessible taxis must be included in the mix when totaling the number of taxis.

I believe that there are currently 34 accessible taxis on the road; therefore, if we use the current issuance formula, we have 635 regular taxis, plus 34 accessibles, for a total for 669 vehicles being used as taxis in Mississauga. Therefore, there is currently an excess of 1 vehicle on the road, and no further issuance of taxi plates is warranted under the current formula.

Given the current sad state of driver income, the recent 40% increase in the cost of propane, this year's massive increase in insurance costs for multiple driver and accessible taxis, and uncertainties about the direction the taxi market at P.I.A. with the opening of the downtown train link and the Mississauga Rapid Bus Route, I am of the opinion that the industry should hold off issuing any more plates until the economic climate has had a more sophisticated analysis. Additionally, we must also consider the implications of addressing the AODA requirements. Moving ahead on this file may require looking at different choices in restructuring the industry vehicle

mix. Better not to supersaturate the market place in advance of decisions that must be made on this topic.

Please add this presentation to your report on industry input for the next PVAC meeting.
