Talent & Employment

This profile presents information on Mississauga's current labour force characteristics. It also includes statistics on graduates from colleges and universities and information pertaining to payroll conditions in Mississauga.

Current Labour Force and Characteristics

- The City of Mississauga is part of the largest labour force market in Canada, the Greater Toronto Area (GTA). Within the GTA, employees can be recruited from a large employment base of over 4.6 million people.
- Because of the magnitude and diversity of the industrial and commercial base located in Mississauga, this city has become one of the most significant employment growth centres within the GTA. More than 62,000 businesses in Mississauga employ over 420,000 people.

Employment Statistics

- In 2014, Mississauga's population was 757,000 and had an employment ratio of .56 which means that for every 100 residents of the city, there were 56 local jobs.
- Mississauga has an participating resident labour force of more than 418,000 people.
- The following table illustrates the city is a net importer of 36,655 employment opportunities.

- Sheridan Institute of Technology & Advanced Learning Hazel McCallion Campus opened in downtown Mississauga during summer 2011.
- Expansion of Sheridan's Hazel McCallion Campus (HMC) began in the Fall of 2014, with completion slated for September 2016. The expansion project will result in a new facility housing state-ofthe-art classrooms, studios, labs and production spaces, a Centre for Creative Thinking, and a gallery space to showcase students' creativity and innovation. The new space will accommodate an additional 3,200 full-time students for a total enrollment of approximately 5,500.

Payroll Overhead/Fringe Benefits

- Employers are required to make certain deductions from the employee's pay and remit them to various government agencies for: employment insurance, income tax and the Canada Pension Plan. Other government-specified benefits includes vacation pay and workers' compensation.
- In addition to standard payroll overhead, employers frequently
 offer fringe benefits which are often a combination of employee
 and employer contributions. These fringe benefits commonly
 include paying all or part of life insurance, major medical and/
 or dental benefits, pension plans and longer vacations for long
 service employees.

Encourage employers to hire individuals whom they would not normally hire in the absence of a subsidy. Subsidies to a participant's wages help to defray the costs associated with an individual's orientation to the work site and the job.

Ontario Self-Employment Benefit

Assists individuals currently in receipt of EI benefits or have received EI in the past 3 years or 5 years for maternity benefits, to create jobs for themselves by offering income support, advice concerning accessing capital, coaching and technical assistance while they launch their own business.

Ontario Job Creation Partnerships

Provides individuals currently in receipt of EI benefits or have received EI in the past 3 years or 5 years for maternity benefits, with opportunities to gain work experience leading to on-going employment. It involves broad community participation, planning and agreement in the creation of sustainable employment strategy.

Ontario Labour Market Partnerships

Encourage and support employers, employee and/or employer associations and communities to improve their capacity for dealing with local human resource requirements.

Job Opportunities for Youth Program

Employers are subsidized a portion of the wages to hire a young person (15-30 years) for a permanent full-time position.

Employment Assisted Services

For unemployed individuals they provide employment related activities to encourage a quick return to work for the clients; i.e. Job Finding Clubs, Resource Centres and Counselling.
