Application Criteria and Deadlines:

Applicant Information

- 1. An Application for a compliance audit must be received by the City Clerk within 90 days after the latest of the following dates:
 - I. The filing date under section 88.30 of the Municipal Elections Act, 1996 (the Act).
 - II. The date the Candidate or Registered Third Party filed a financial statement, if the statement was filed within 30 days after the applicable filing date under section 88.30.
 - III. The supplementary filing date, if any, for the Candidate or Registered Third Party under section 88.30.
 - IV. The date on which the Candidate's extension, if any, under subsection 88.23 (6) expires or the date on which the Registered Third Party's extension, if any, under subsection 88.27 (3) expires
- 2. The applicant must be an elector, which is entitled to vote in the City of Mississauga, in accordance with the Act.
- 3. The application must be made to the City Clerk in writing in person, by mail or electronically to:

Failure to do so may result in the committee refusing to consider the documents.
- If I wish for individuals to speak on my behalf at the meeting, the individual must register with the Legislative Coordinator administering the Election Campaign Finances Committee by 4:30 pm, no less than two (2) business days prior to the meeting.
- Individuals addressing the Committee will be permitted to speak for no more than fifteen (15) minutes.
