


- June 27, 2016 Public Meeting held to consider a proposed City initiated Official Plan Amendment to the Mississauga Road Scenic Route Policies (Section 9.3.3.11; Schedules 1 & 1c)
- PDC asked that staff report back on comments made
- Heritage staff were asked to review a request that this Scenic Route be designated a Heritage Conservation District



Study Area & Key Features

- Mississauga Road between Streetsville and Port Credit
- Strengthen policies to protect key features along Study Area













Summary of Proposed Policy Changes

- Residential development only detached homes fronting Scenic Route with 40 m (131 ft.) lot depths
- Development cannot result in pavement width increases for Mississauga Road
- Consistent building massing, design, setbacks and lot frontages
- Stronger wording for several policies (e.g. from "should be" to "will be")
- New policies to achieve the highest design and architectural quality development for non-residential uses at the north end of the Study Area





- Several comments made by the community are listed and addressed in the staff report
- Planning & Development Committee asked staff to review 3 items related to the Mississauga Road Scenic Route



PDC Comments

Heritage staff should review the potential for designation as a Heritage Conservation District (HCD)

- Heritage and Planning staff met with 4 residents who had requested the HCD. Heritage staff recommend that no further action be taken at this time as:
 - the residents could not identify the heritage elements/significance that should be protected through legislation
 - no property owners fronting Mississauga Road had indicated an interest in pursuing an HCD



PDC Comments

Does the City have a long term plan for tree replacement along Mississauga Road given the impact of the Emerald Ash Borer and Gypsy Moth?

- The City's Forestry staff monitor & manage trees along Mississauga Road annually impacted by Gypsy Moth to ensure they do not have long term negative impacts to trees
- Ash trees removed along Mississauga Road will be replaced close to where they are removed (or if not feasible, in the neighbourhood)
- Staff are continually monitoring for opportunities to plant trees City wide



PDC Comments

Enhanced streetscape policies or guidelines should be considered as part of this policy review

- Staff propose streetscape and urban design guidelines be prepared for the Study Area
- These guidelines will be brought forward to a future PDC meeting for consideration



Policies

- Only change in the recommended Official Plan policies since the June 2016 Staff Report is deletion of wording that would have modified the "Residential Low Density I" land use policies in two Neighbourhood Character Areas
- This recognizes that the policies apply to different land use designations along the Scenic Route



Recommendation

- That the proposed Official Plan amendments be approved in accordance with Appendices 2 and 3
- That Urban Design Guidelines be prepared by staff and brought forward to a future PDC meeting for Council endorsement
