- The Members of the Design Team (ie. Architect/Urban Designer, Landscape Architect) including proper company identification (ie. Co./Company, Ltd./Limited) must be identified by the Nominator, as submitted information may be used for presentation and/or publication purposes.

- Images (5 minimum) to illustrate the project significance, function, aesthetics, innovation, context and execution must accompany the submission.
- Images should be submitted in:

 - or digital images (preferable) with high quality resolution (minimum 300 dpi) saved on CD or flash memory.
- Images will not be returned and become the property of the City of Mississauga.
