
canopy. Watch for updates and please join me at our next Ward 4 tree planting event!

Improvements to Syed Jalaluddin Park

Last year, the City of Mississauga celebrated Canada's 150th Anniversary of Confederation. The City was awarded approximately \$5.6 million in funding through the **Canada 150 Community Infrastructure Grant Funding Program** from the Government of Canada. One of these projects chosen for infrastructure redevelopment was a playground at Syed Jalaluddin Park, located at 490 Mississauga Valley Blvd. in Ward 4.

Along with the playground redevelopment, the park will be renamed Syed Jalaluddin Memorial Park this spring, as proposed by Councillor Kovac during a City Council session on Sept. 13, 2017. Please join us for the grand re-opening and plaque unveiling:

Date: May 12th, 1:30 p.m. – 3 p.m.

Location: Syed Jalaluddin Memorial Park (Mississauga Valley Blvd., just south of Cliff Road North)

The park name commemorates the courageous act of Syed Jalaluddin, a Mississauga resident from Ward 4, who lost his life saving a 5-year old girl from drowning in the Credit River in 1979.

Councillor Kovac to Introduce the City's Second Boxed Soccer Pitch



Through Councillor Kovac's efforts, the City of Mississauga will construct a second boxed soccer pitch in Ward 4, as part of a community benefit, at Mississauga Valley Park. A first of its kind in Mississauga and across Canada, the original field (located on Living Arts Drive) has become a well-used 'pick-up' soccer location in the downtown core. Children and youth use the field on a drop-in basis and expectations are that the second field will be just as popular.

"A densely-populated downtown is one reason for the first field's success – an amenity like it was needed in the core. We couldn't have hoped for a better response from the community. Kids and youth are using it in almost all weather conditions – they're physically active, having a great time and making friends. Best part is that the

field is for everyone, requires no booking permit and little maintenance. It's been great for the downtown and promises to be a win for the Mississauga Valley community as well!" said Councillor Kovac.

The second field will be placed in the northeast portion of the park near Mississauga Valley Gymnasium, within sightlines from both Mississauga Valley Boulevard and the Community Centre building. Many townhouse and apartment dwellings are within close walking distance. Just like the first field, the second will not be programmed and will be open to the public from 7 a.m. – 11 p.m., seven days a week. The boxed soccer pitch is a 15 metre x 30 metre artificial turf surface, built using a durable welded-aluminum frame including soccer boards, two goals and netting.

Free Basic Dental Services for Eligible Seniors

The Seniors' Dental Program provides free basic dental services, such as cleanings, fillings and dentures, to low income seniors who qualify.

To be eligible, seniors must meet all six criteria:

1. be 65 years or older
2. live in Brampton, Caledon or Mississauga
3. be a Canadian citizen or permanent resident
4. have no access to any form of dental coverage (including government programs such as Ontario Disability Support Program (ODSP), Ontario Works (OW), and Non-Insured Health Benefits)
5. have no previous dental care that was paid for by the Region of Peel's Seniors' Dental Program
6. have an income of less than \$20,675 for a one person household or \$25,163 for a two person household (effective July 1, 2017)

The Active Adult Centre of Mississauga

On Jan. 15, the Active Adult Centre of Mississauga (AACM), formerly known as the Square One Older Adult Centre of Mississauga, celebrated the Grand Opening of its new facility at Central Parkway Mall, in Ward 4 along with current board member and Councillor, John Kovac.

The space has been transformed to host a number of programs like fitness, Zumba, dancing, card games and music classes.

Approximately one quarter of Mississauga's 55 plus population lives within Central Mississauga. The City's downtown older adult population is expected to grow within the next decade. The City of Mississauga has partnered with AACM to update its current resources and provide members with a brand new facility. The new location meets the needs of the existing membership and will allow for increased growth in the future.

Located at 377 Burnhamthorpe Rd. E., on the second floor, the 8600 sq. ft. space is convenient and accessible. It allows for current and new social, educational, recreational, health and multicultural programs and services. Amenities include:

- kitchen and multi-purpose café space
- technology centre
- smaller private rooms for health and wellness services/clinics
- large auditorium
- multi-purpose program rooms

AACM aims to enrich the lives of Mississauga's seniors by keeping them active, independent, and involved in the community. The Centre will now offer more than 80 social, recreational, health and multicultural programs weekly. AACM currently has more than 1,700 members.

Investing in Better Community Outcomes with the 2018 Budget

The Region's annual budget process involves serious discussion and prudent and responsible decision-making. On Nov. 16, 2017, Regional Council approved the 2018 Budget driving the achievement of our vision of a **Community for Life** with investments balanced between the needs of residents and businesses and the infrastructure needs of the broader community. It also balances the current Term of Council priorities, the Strategic Plan's long-term objectives and the overall consideration of affordability.


The 2018 Budget invests in better outcomes for residents and businesses as we continue to build a healthy, safe and connected community, strengthening a solid foundation to build a **Community for Life**.

Community investments in the 2018 Budget include:

- Providing accessible transportation so residents can travel without barriers with 39,000 more accessible transportation trips.
- Expert, reliable pre-hospital care with two additional ambulances and more paramedics to address 6,000 additional 911 calls.
- Preventing homelessness in Peel with additional beds in the Brampton Youth Shelter.
- Providing reliable, safe and environmentally friendly waste collection service to 4,000 new households and safe, reliable and high quality drinking water to 4,750 new water customers.
- Delivering quality, person-centred care for residents with complex needs with additional caregivers for Peel Manor Long Term Care residents.
- Additional police staffing to maintain our safe communities.

TransHelp, Peel's Specialized Public Transit

The Region of Peel's TransHelp buses and contracted vehicles provide specialized transportation for eligible residents with physical, cognitive, visual, sensory and mental health disabilities.

This door-to-door service is:

- pre-paid
- pre-arranged
- shared with other passengers

Eligibility is based on an individual's barriers to using conventional public transit, due to his or her disability. If a barrier is preventing you, or someone you know, from being able to travel using Brampton Transit or MiWay, please fill out an application online at peelregion.ca/transhelp

Did you know?

MiWay offers a high level of accessibility, including:

- Fully accessible fleet with low floor, kneeling buses equipped with ramps and two wheelchair/scooter securement areas
- Both voice and visual announcements at all stops
- Shelters at accessible stops have large entrance openings and platform areas to ensure sufficient room for maneuvering wheelchairs and scooters



Apply for a discounted MiWay monthly bus pass

If you live, work, or go to school in Mississauga and can't afford a monthly bus pass for travel, you can apply for a discount.

As of February 2018, the Region of Peel offers a 50 per cent discount off the regular cost of a monthly MiWay pass to eligible applicants.

To be eligible for a transit discount, you must:

- be a Canadian citizen, a landed immigrant, or have applied for permanent residency, sponsorship, or refugee protection in Canada
- live in Mississauga
- have an after-tax income that matches or is lower than the amounts shown in the table below

The Region of Peel's Priority to Increase Affordable Housing

Finding affordable housing in Peel continues to be a challenge for more and more individuals and families. That's why Regional Council has made it a priority to increase the supply of affordable housing. Specifically, we are focused on helping people on Peel's centralized wait list for subsidized housing obtain a permanent place to live.

While the Region of Peel continues to address the community's affordable housing and homelessness needs, the demand for affordable housing continues to increase:

- One in five Peel residents live in poverty
- The cost to own a home continues to be out of reach for many Peel residents
- Low rental vacancy rates keep the supply of rental housing low and rental rates high
- One in five Peel residents rent housing, but private sector housing starts aren't addressing the demand
- More individuals are accessing Peel's emergency shelter system
- Approximately 13,000 people are on Peel's waiting list for subsidized housing

Peel continues to push forward in its affordable housing investments:

- The Region invests about 12 cents of every dollar of the Region's tax levy to increase affordable housing and reduce homelessness
- The Region administers close to 20,000 subsidized housing units in Peel, and owns **7,935 affordable housing units** (Regional and Peel Living units)
- The 10-year Peel Housing and Homelessness Plan guides the work of the Region's Housing and Homelessness Services
- The Region continues to advocate with the federal and provincial governments for policy changes and appropriate funding that will help to increase the supply of affordable housing.

Vision Zero sets out to create safer roads

Imagine a community where everyone could travel safely on our roads. Peel has created a plan to help us get there. In partnership with various stakeholders, the Region has reviewed traffic accident information, pinpointed the key problem areas and has set actions to make improvements in each of these areas.

As part of **Peel's Road Safety Strategic Plan (RSSP)**, the Region has adopted a "Vision Zero" framework which originated in Sweden, and conveys the key message that no loss of life is acceptable. The plan sets out the vision, goals, and action plan to create safer roads, by reducing, and ultimately eliminating, motor vehicle collisions causing injury and death.

Vision Zero is based on the simple fact that we are human and make mistakes, and that life and health can never be exchanged for other benefits in society. It is based on shared responsibilities among everyone involved in the road system, including planners, police, public health, politicians, community organizations, vehicle manufacturing companies and all road users.

In the next five years, the RSSP will build on the Region's existing road safety programs by enhancing and expanding the key areas of the programs that are most effective in reducing collisions for each of the top improvement areas:

- intersection related collisions
- aggressive driving
- distracted driving
- pedestrian collisions
- impaired driving
- cyclist collisions

A number of countermeasures identified through activities such as engineering, enforcement, education and empathy will be applied to these areas to help reduce fatal and injury collisions.

The Region of Peel encourages all road users to be a safety ambassador and promote Vision Zero and traffic safety.

Property Tax Rebate Program



Together with local municipalities, the Region of Peel provides annual property tax rebates to eligible low-income seniors and low-income disabled persons to provide relief from financial hardship.

Eligible low-income seniors and low-income persons with disabilities must apply annually to receive the rebate. Application forms must be completed and returned to the local municipality in which the property is located.

New Dog Waste Containers at Community Common Park


Mississauga is launching a one-year pilot program that will convert dog waste into renewable energy and fertilizer. Starting this spring, 15 in-ground dog waste containers will be installed across eight City parks including two containers in Ward 4 at Community Common Park, 355 Princess Royal Drive.

Dog waste is frequently placed in recycling bins where it contaminates the entire bin and then has to go to a landfill. Dog owners are encouraged to use these new bins to avoid contaminating recyclables and ensure dog waste is diverted from the landfill. These innovative fully in-ground concrete containers can hold dog waste for up to six weeks. The waste will be emptied by a vacuum truck and taken to an organic waste plant where it will

be safely converted into energy and fertilizer.
