<ul> <li>Maintain the swimming pool enclosure in compliance with the provisions of the By-Law and the City of Mississauga Property Standards By-Law 654-98, as amended.</li> <li>The Certificate of Approval will only be issued where a Request for Swimming Pool Enclosure Inspection form has been signed by the owner and the</li> </ul>
