Applicant's Proposal:

To revise the official plan and zoning and approve a proposed plan of subdivision to permit a mixed-use and multi-phase project that will create a waterfront community with 2,995 new residential units (townhouses, mid-rise and high-rise), retail and amenity spaces, parkland and campus uses.

The remediation of on-site contamination will be evaluated through the review of these applications and addressed in the Corporate Report.

The applications have been appealed to the Local Planning Appeal Tribunal. A hearing has not yet been scheduled.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the City before the by-law is passed, the person or public body is not entitled to appeal the decision of City Council to the Local Planning Appeal Tribunal, or be added as a party to an appeal of the decision to the Tribunal.

The proposed Official Plan amendment is exempt from approval by the Region of Peel. The decision of City Council is final if a notice of appeal is not received on or before the last day for filing a notice of appeal.
