DEPUTATIONS

A. Mississauga Climate Change Overview

Julius Lindsay, Community Energy Specialist, Environment Division provided an overview of climate change in Mississauga. Mr. Lindsay noted that in its Fifth Assessment Report, the Intergovernmental Panel on Climate Change stated that the increase in greenhouse gas emissions are extremely likely to have been the dominant cause of the warming of temperatures and noted Provincial initiatives such as a discussion paper released in February 2015 and their work on the development of a Climate Change Strategy that would include carbon pricing. Mr. Lindsay commented that by the year 2050 there would be a 2-3 degree increase in average annual temperatures and that by 2100 it would increase an additional 3-6 degrees.

Mr. Lindsay further commented on the mitigation and adaptation of climate change and the related community and corporate initiatives to address both including a Community Energy Plan, a 5 Year Energy Conservation Plan, Region of Peel/TRCA Climate Vulnerability Assessments, and a Corporate Climate Risk Assessment that had identified 125 risks. Mr. Lindsay advised that the City of Toronto had developed a Risk Tool and would be seeking Council approval to receive licence rights to use the tool.

Mr. Lindsay noted that the City's 5 Year Energy Plan targets a 1% decrease in energy consumption per year corporately and that the greenhouse target was the same. He further noted that by 2012 the Green Fleet Phase 1 initiative was reducing greenhouse gas emissions by approximately 200 tonnes of equivalent carbon dioxide annually and had avoided approximately \$400,000 to \$500,000 in fuel costs cumulatively over the program's seven years.

B. Stormwater Charge

Michelle Berquist, Stormwater Charge Project Manager provided an overview of the stormwater charge in Mississauga.

Ms. Berquist provided an update on Council decisions with respect to stormwater and noted that the stormwater charge will start in January 2016. Ms. Berquist advised that there is a video on the City's web site (www.mississauga.ca/portal/stormwater/charge) for residents that explains the new stormwater charge.. Ms. Berquist indicated that the charge was necessary to invest in the stormwater system of 2000 kilometres of underground pipework, 1000 water outlets, 60 stormwater main facilities and 48,000 catch basins in Mississauga with the focus on the renewal of pipes, flood mitigation, debris removal, and stormwater cleanout pools.

Ms. Berquist outlined the stormwater charge calculation noting that the rate would be based hard surfaces (rooftops) on the property, that the rate would be \$100 per billing unit in 2016 and advised that there is a Stormwater Estimator tool online (www.stormwatercharge.ca). Ms. Berquist also noted that the charge would be applied to all properties serviced by the City of Mississauga with the exception of places of worship and veterans organizations. Ms. Berquist advised that an application for technical exception would be available in Fall 2015 for residents seeking exceptions to the stormwater charge.

Wal van Riemsdyke, Applewood Residents Association inquired about an exemption due to his rooftop draining into a swale and then into Lake Ontario and Ms. Berquist advised that an application for exemption would be considered, noting that properties on the Lakeshore drain into Lake Ontario.

Ed Bavington, Resident spoke regarding his property, noting that all water goes onto his lawn and further noting his dissatisfaction with the Stormwater Charge.

Brad Bass, Citizen Member provided information on stormwater charges in Washington D.C. and the credit sharing/trading option for residents. Ms. Berquist noted that there are several precedents that the City could look to for best practices.

Councillor Carlson noted that a rebate for homeowners had been considered as had a partnership with the Region of Peel and recognition programs for those who participate. Councillor Tovey noted that the stormwater program and associated costs is a utility that has to be upgraded and maintained.

C. City of Mississauga Environmental Outreach Program

Diana Suzuki, Environmental Outreach Coordinator, Environment Division provided an overview of the City of Mississauga Environmental Outreach Program.

Ms. Suzuki noted that the Outreach Program stems from the Strategic Plan – Green Pillar and the Living Green Master Plan that consists of 49 actions. Action 42 outlines the need to develop a public education campaign that encourages community action in environmental priority areas focusing on making environmental information accessible, providing information on environmental action that residents can take, that links residents to City environmental programs, and to attend events across the City.

Ms. Suzuki provided a review of the 2012-2014 campaign-based outreach program, Let Your Green Show, which focused on growing local, eating local, using less water and giving your car a break and made note of the various events that the Environment Division was in attendance and how the campaign had promoted volunteerism. Additionally Ms. Suzuki provided an overview of the 2015 upcoming events and the 2015 Outreach Program that focuses on the City of Mississauga Environmental Priorities that include transportation, natural heritage/biodiversity, urban form, energy, water/stormwater, waste and and made note of the Community Green Leader Volunteers.

Ms. Suzuki outlined the actions that EAC is encouraged to partake in, including:

- Attend the Community Environmental Appreciation Evening on June 11, 2015;
- Let us know about community events;
- Volunteer to help at a display/event;
- Help to promote City of Mississauga environmental programs through your networks;
- Help identify groups doing environmental work in the community;
- Coordinate EAC participation in Earth Markets.

Joanne Deidun-Roork, The Little Green Schoolhouse inquired as to how local school boards and children are being involved and Ms. Suzuki noted that the Environment Division is involved with the Mississauga Youth Action Committee (MYAC), the Peel Environmental Youth Alliance (PEYA) and Ontario Eco-Schools.

Carolyn Bailey, Ecosource made note of the Green Chair Program focused on waste reduction.

Councillor Tovey suggested hosting an environmental conference and there was consensus from the Members that a conference would be a worthwhile action for EAC.

Dave Beaton, Credit Valley Conservation commented on exploring opportunities to cross-train volunteers, ways to connect and collaborate with other community groups, and a strategy to share information.

Nishila Mehta, PEYA commented that they often partner with community organizations and made note of the EcoBuzz event as an avenue to connect with youth. Ms. Bailey was in agreement and suggested the creation of a "cheat sheet" that would list opportunities for youth to become involved in environmental events and activities.

 6. Be the Change/Lead By Example

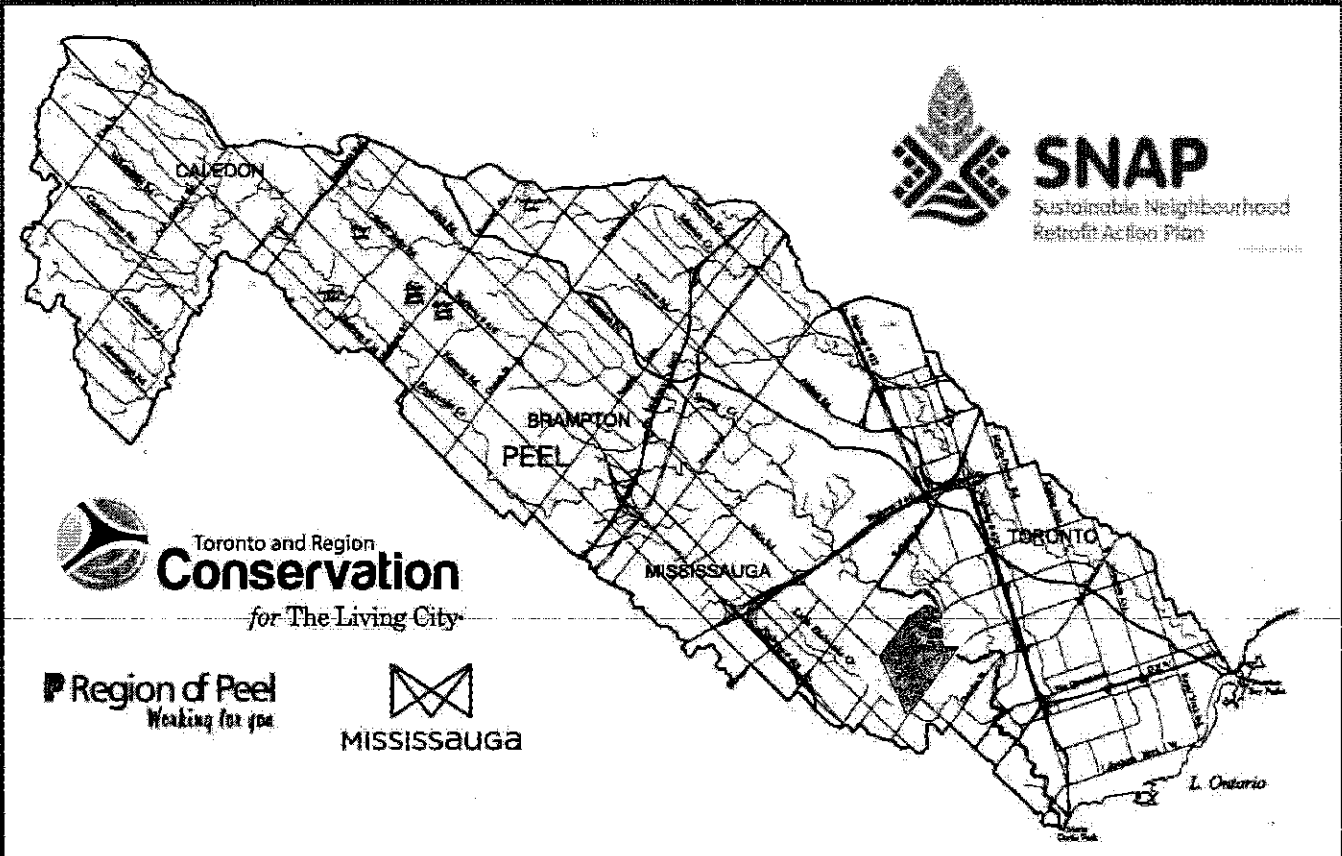
Ms. Stock-MacDonald advised that the next session would focus on how to achieve the six priority areas that the Committee had identified.
