1. Payment of all fees and charges may be made by Visa, MasterCard, American Express, debit card, bank draft, certified cheque or cash. The full payment for the total of refundable deposits and non-refundable fees combined must be made by bank draft or certified cheque only. Uncertified cheques will not be accepted.
2. No discounts will apply for early payment of any fee set out in Schedules “B-1” to this By-law.
3. The City’s current Road Occupancy, Lot Grading and Municipal Services Protection Deposit By-law sets out the deposits that are payable in respect of permits for construction on land abutting a highway or for construction that may affect drainage or grading.
