6. MATTERS TO BE CONSIDERED

6.1. <u>ACCESSIBILITY FOR ONTARIANS WITH DISABILITIES ACT, 2005 (AODA)</u>
Diana Simpson, Accessibility Coordinator provided a brief verbal update with respect to the Accessibility For Ontarians With Disabilities Act, 2005 (AODA).

6.1.1. Repeal of Section of *Ontarians with Disibilites Act (ODA)*

Email dated December 15, 2015 from the Association of Municipalities Ontario (AMO) with respect to recent changes to accessibility laws in Ontario.

Ms. Simpson spoke to proposed changes to the Accessible Customer Service section of the *AODA* and encouraged Members to provide feedback to the Province on their website by the end of March, 2016.

Naz Husain, Citizen Member inquired as to whether Accessible Customer Service would be integrated into the Integrated Accessibility Standards Regulation, to which Ms. Simpson advised that it would. Ms. Simpson further noted that there is a summary on the Ministry's website and those with specific questions could contact her for assistance. RECOMMENDATION

That the email dated December 15, 2015 from the Association of Municipalities Ontario (AMO) with respect to recent changes to accessibility laws in Ontario, be received for information.

6.2. Region of Peel Accessibility Advisory Committee Update

Naz Husain, Citizen Member, Accessibility Advisory Committee and Chair, Region of Peel Accessibility Advisory Committee provided a brief verbal update noting that the Regional AAC would be meeting the following week, that there would be an additional meeting to review evaluations of International Day of Persons with Disabilities to measure successes, that the Regional AAC would be presented with several strategic plans in the coming year, and commented on the waste/recycling bins that were implemented in the new year. Ms. Husain further noted that there are safety concerns with the bins as they are too large and too deep.

Rabia Khedr, Citizen Member expressed agreement regarding the bins and further noted the inability to line the organics bin causing it to be difficult to clean.

Councillor Saito noted the large size and depth of the bins, the challenges that the contractor faces in collecting and emptying the bins, and that there would be an opportunity in April 2016 to exchange the bins to a more appropriate size at no cost, commenting that after April 2016 there would be a \$25 charge to do so. Councillor Saito further commented that the Region does have a courtesy service to assist those who are unable to safely move the bins to the end of the driveway and that with a doctor's note, the contractor will pick up and return bins to the front of the house.

Councillor Saito spoke regarding a Ward 9 Resident who is blind and was refused TransHelp service as he doesn't have a mobility disability and inquired as to whether the Region was pursuing expanding the definition of "disability".

Ms. Husain noted that the Accessible Transportation Master Plan is changing, but how it will change and when the change will occur is yet to be determined. Ms. Khedr noted that the Taxi Scrip Policy is also in need of review.

Melanie Taddeo, Vice-Chair advised that blindness doesn't qualify one for TransHelp, nor does an intellectual/cognitive disability and commented that all disabilities should qualify a person for TransHelp, to which Ms. Husain suggested having a TransHelp staff person attend the April 4, 2016 AAC meeting. Councillor Saito expressed agreement and further commented that this issue should be dealt with in 2016 instead of 2017.

RECOMMENDATION

- That the Region of Peel Accessible Transportation Office be requested to accelerate the expanded eligibility criteria for persons with visual, intellectual and cognitive disabilities to access TransHelp as outlined in the Region of Peel Accessible Transportation Master Plan, to mid-2016;

Diana Simpson, Accessibility Coordinator spoke to her memorandum dated February 1, 2016 with respect to the 2015 City of Mississauga Annual Report on the Multi-Year Accessibility Plan, including the MiWay 2015 Accessibility Report.

Ms. Simpson spoke to the report highlights and successes and advised that the report would be considered by General Committee on March 23, 2016.

Alana Tyers, Team Leader – Transit Planning spoke to the MiWay 2015 Accessibility report noting the improvements made in 2015 including a focus on infrastructure, passengers exiting through the back doors being able to step onto a hard surface, the work done on real-time communications with respect to service disruptions, and the Transitway accessibility features.

Mashkoor Sherwani, Citizen Member inquired as to whether drivers were provided with accessibility training to which Ms. Tyers explained the training that MiWay employees are provided with. Mr. Sherwani noted that a family member had experienced a customer service issue and that sensitivity training was needed.

Rabia Khedr, Citizen Member requested further information regarding driver training and suggested that a mock training session could be held for participating AAC Members in order to obtain feedback and guidance.

Councillor Saito noted the importance of reporting incidents with details such as route number, date, and time so that MiWay could follow-up on the report.

Ms. Tyers advised that she would take the feedback provided back to the training department.

Virginia Kalapaca, Project Manager – Park Development advised that the trail is in the early stages of development, that there were issues with the lease agreement process, and that the matter had been flagged for follow-up due to the awkward intersection connections and signage.

Councillor Saito advised that if there was an outstanding issue with a project, the Facility Accessibility Design Subcommittee (FADS) should state that in their recommendation, and that ORT #7 should be brought back to FADS for further review.

The Accessibility Advisory Committee shall act in an advisory capacity to Council through reports to General Committee and shall advise, recommend and assist the City of Mississauga in promoting and facilitating a barrier-free Mississauga for citizens of all abilities (universal accessibility), including persons with disabilities. AAC's mandate will work to further the City's commitment mainly to its 'Belong' and 'Move' Pillars (although, accessibility planning needs to be integrated into all pillars to create a universally accessible community).

Question:

- Providing a "lived experience" as a person with a disability
- Creating awareness about the great accessibility work in the City
- Providing support to City staff

- Facility accessibility audits

- Youth representative on Committee
- Need to look at intersectionality of accessibility
