- 4.1. Minutes of the February 6, 2017 Accessibility Advisory Committee meeting

Members reviewed the Minutes of the February 6, 2017 Accessibility Advisory Committee meeting and noted amendments.

- 5. DEPUTATIONS
- 5.1. Pauline Craig, Cycling Master Plan Coordinator, with respect to Cycling Master Plan

Ms. Craig introduced Jelmer Stegnik, Marketing Consultant, Education, Transportation and Works, who is responsible for the promotional and educational strategies of the Cycling Master Plan.

Pauline Craig, Cycling Master Plan Coordinator, spoke to the Cycling Master Plan's project purpose and scope, public consultation and project schedule, project milestones and other projects. Ms. Craig, highlighted the projects objectives to develop a bicycling network to encourage more cyclists, which includes developing promotion and education strategies to reach out to all cyclists, strategies for parking and bike sharing and monitoring and evaluating the projects progress, public consultation to include a project website, City of Mississauga Facebook and Twitter page, participation from Members of the Advisory Committees and other stakeholders, and, conducting public meetings.

Carol-Ann Chafe, Chair, advised that she has been attending the Mississauga Cycling Advisory Committee's and recently attended The Bike Show. Ms. Chafe further advised that she has done research on the various types of accessible cycling with a focus on enhancing accessible and inclusive cycling, as well as looking at opportunities to work with Handcycling Association of Canada and Trailblazers for tandem cycling. Ms. Chafe further noted that the Cycling Master Plan should include the Lakeshore Connecting Communities project as issues relating to safe cycling issues have been raised at the community meetings.

Rabia Khedr Citizen Member, advised that the youth support services agency that she is involved in has applied for funding for the purchase of a few bikes (either side-by-side or tandem) for the youth program as well as implementing a bike loaner program. Mr. Stegnik, advised that the Region of Peel started a community bike centre pilot in 2015 and that the Region of Peel will be looking for organizations in Mississauga to roll out the community bike centre program this year in September and October 2017 which would provide funding. Mr. Stegnik will look into this program further and provide Ms. Khedr with further information and the application to apply for funding.

Councillor Pat Saito noted that in conducting public meetings, that they be mindful of the perspectives of the avid cyclist versus the casual cyclists. Councillor Saito noted that the majority of cyclists on the trails are families, children, and older adults.

Members of the Committee engaged in further discussions regarding public engagement, community outreach, safe cycling education and promotional materials reflect inclusive cycling.

## 7.3. <u>Citizens with Disabilities - Ontario Report on the Fed's Consultation on Accessibility Legislation</u>

Darren Cooper, Accessibility Specialist spoke to the Citizens with Disabilities Ontario Report on the federal government's consultation on Accessibility Legislation which was held on February 8, 2017 and was attended by Carol-Ann Chafe and Naz Husain. The Citizens With Disabilities – Ontario released a report on the overview of the consultation which reviewed 3 key questions; what are key barriers; how to address those barriers; and how to make the attitudes toward people with disabilities more positive. Mr. Cooper further advised that the federal government was interested in hearing whether a prescriptive approach to the legislation, or an outcomes based approach is preferred.

Mr. Cooper reported that the issues raised were focused on employment for persons with disabilities and the social and economic impacts of high unemployment around housing and transportation. There was also a suggestion to adding ASL and LSQ as official languages to the long form census.

Mr. Cooper advised that the federal government will be compiling all the feedback and data and will release a report in the fall 2017, and will have an initial draft of the Legislation in the winter 2018.

### CALL TO ORDER – 1:37 PM

Clement Lowe, Chair called the meeting to order at 1:37 PM and requested that all present at the meeting introduce themselves.

### **ITEMS CONSIDERED**

### 1. SQUARE ONE OLDER ADULT CENTRE RELOCATION PROJECT

Fernando Moraes Project Manager, Facility and Property Management spoke to the Square One Older Adult Centre Relocation Project. Mr. Moraes advised that the Older Adult Centre will be renamed to the Active Adult Centre and will be relocating from its current location at Square One Shopping Mall, B1 level to 377 Burnhamthorpe Road West, 2<sup>nd</sup> floor of the Central Parkway Mall. Mr. Moraes commented on the accessibility of the new location noting that public transit services this area well, and that there is an elevator to the 2<sup>nd</sup> floor from the street level as well as from the underground parking garage.

Mr. Moraes provided an overview of the floor space explaining each room location and purpose, electronic door functionality, LED lighting and occupancy sensors, and universal washrooms. Mr. Moraes also explained in detail the colour contrasting from the hallways to the rooms, and the materials that are being used. Mr. Moraes brought sample materials for Members to view and touch.

Comments from Members and staff that were raised included, concerns with chair/hand rails only being on one side; emergency call system, visual alarms, the need to obtain a key to operator the chair lift, and installing audible crossing signals at Central Parkway and Burnhamthorpe West.

Clement Lowe, Chair, thanked Fernando Moraes for his presentation to the Facilities Accessibility Design Subcommittee.
