## 4. <u>DEPUTATIONS</u>

4.1. <u>Jeff Jackson, Director, Finance with respect to Mississauga's Long Range Financial</u> Plan (LRFP).

Mr. Jackson provided an overview of Mississauga's Long Range Financial Plan. He noted the key challenges, the LRFP model results, the assumptions with respect to long range financial planning, debt charge repayment forecast and next steps.

Members of Committee spoke to the matter and raised the following concerns:

- The City should communicate more on the spending rates to be more transparent as an organization.
- In the future there may be changes in the services that are provided by the Region and the City. The challenges going forward with respect to support from senior levels of government, more downloading from senior levels of government and significant new infrastructure projects.

In response to a question from Mayor Crombie, Mr. Jackson advised that he would look into the debt load of neighbouring municipalities.

Mr. Jackson provided an overview of the reserves and reserve fund management. During the detailed review process of the reserves it was found that there are too many reserves, the Reserve By-law needs to be updated and that many of the reserves are not required anymore. Mr. Jackson explained the reserve fund reorganization and the three (3) larger reserves: General Contingency Reserve, Tax Capital Reserve and Employee Benefits Reserve Funds. He further spoke to strategies for funding reserve gaps and the next steps.

In response to questions from Councillor Starr regarding storm water funding, Mr. Jackson and Janice Baker, City Manager and CAO spoke to the Storm Water Management Program.

In response to a question from Councillor Ras with respect to the tax capital reserve fund and the Rattray Marsh, Mr. Jackson explained that the widening gap would account for the costs of the aging infrastructure. He advised that he would look into the funds collected for the Rattray Marsh.

## 4.2. Jeff Jackson, Director, Finance with respect to the 2017-2020 Business Plan and 2017 Budget Outlook.

Mr. Jackson provided an overview of the 2017-2020 Business Plan and the 2017 budget outlook. He spoke to the economic outlook, federal/provincial initiatives, advancing the City's strategic plan, 2017 highlights, efficiencies, cost savings and the proposed 2017-2020 operating budget. Laurel Schut, Manager, Corporate Communications spoke to the budget engagement and noted the success with the tools that were used in 2016.

Members of Committee spoke to the matter and noted the following:

- Concerns were expressed with respect to the proposed tax increase of 2.2%. It was suggested that an increase under 2% should be considered and what it would take to achieve it.
- It was suggested that for the budget engagement, the budget request highlights should allow residents to rank them and provide comments on the new initiatives.
- Concern that it may be premature to request a tax increase under 2% and it was noted that it depends on what happens at the Region of Peel.

Mr. Jackson and Ms. Baker responded to questions from Committee with respect to property tax rates, the cost of fuel, budget cost drivers, non-labour costs and WSIB claims. Direction was given to the City Manager to prepare a list of items for Budget Committee to review and make a decision on whether it should be included or removed from the budget.

Chris Mackie, MIRANET noted that it appears that the Region of Peel is more successful in containing the rate of growth in the tax budget than Mississauga and asked why. Mayor Crombie and Mr. Jackson explained that some of the cost pressures at the Region have been uploaded to the Province. Ms. Baker noted that Mississauga has made significant investments in transit.

In response to further questions from Mr. Mackie, Gary Kent, Commissioner, Corporate Services and Chief Financial Officer explained the Enersource dividend and the return on City investments in 2015. Ms. Baker spoke to employee salaries, more specifically labour contracts that were settled. Mr. Kent further responded to Mr. Mackie and explained the surpluses, assessment growth and labour gapping.
