WHEREAS Transportation Network Companies ("TNC"), such as UBER, have developed online enabled platforms (Apps) through the use of cell phones which connect passengers with drivers in order to transport the passengers for a fee;

AND WHEREAS UBER is operating within the City of Mississauga connecting passengers with drivers;

WHEREAS Uber and Uber drivers are currently operating within the City of Mississauga as a taxi broker and taxi driver respectively using names like UBER X, UBER XL and UBER SELECT App ("UBER X APP") without being licensed according to the City's Public Vehicle Licensing By-law 420-04, as amended and as such are operating contrary to the requirements of the By-law;

AND WHEREAS General Committee is concerned that Uber and Uber drivers will continue to contravene the City's Public Vehicle Licensing By-law as General Committee considers the regulation of transportation network companies ("TNC") including any possible amendments to the Public Vehicle Licensing By-law;

NOW THEREFORE BE IT RESOLVED:

- 1. THAT the Director of Enforcement be directed to send correspondence to Uber (including all related companies that in any way participate in the operation of Uber in the City of Mississauga) and any other TNC operating in the City, directing them to suspend operation within the City of Mississauga and for Uber to advise any drivers using the Uber App in the City of Mississauga that the Uber App will no longer be available for use in Mississauga until any enabling amendments to the Public Vehicle Licensing By-law are made;
- 2. That City staff continue to enforce the By-law and charge all drivers.
- 3. THAT the City of Mississauga send out a communication that Uber drivers or drivers for other TNCs in the City of Mississauga cease operating in the City of Mississauga until any enabling amendments to the Public Vehicle Licensing By-law are made;

He presented photographs which showed the location of the washroom immediately adjacent to a home looming over a fence, with the ventilation exhaust aimed toward the swimming pool. Other pictures showed double-decker GO buses 15 feet away from fences with views into backyards and 12 to 15 metre tall lights around the bus platforms and parking lots that shine brightly into the residential homes all night. He inquired if Metrolinx received site plan approval prior to construction of the building. Martin Powell, Commissioner of Transportation and Works indicated that Metrolinx did not submit a site plan prior to construction as the lands are provincially owned. And Whereas the source protection authorities (SPAs) have reduced the committee size from 15 members plus a chair to 9 members plus a chair; the committee will have 3 municipal members, with 1 member from each representing the 3 municipal groups Regions of Niagara, Halton and Peel, cities of Hamilton, Burlington, Mississauga, Towns of Grimsby, Oakville, Milton and Halton Hills, County of Wellington and Township of Puslinch;

And Whereas the remaining 6 committee members will comprise of 3 representatives of the economic sector (agricultural, industrial and commercial) and 3 respresentative of other interests (environment, health and general public) which will be appointed after established recruitment processes;

And Whereas each municipality is asked to submit a name of support for the SPC and may choose to nominate an elected official, a staff member or a citizen representative that complies with the eligibility requirements;

# 16. **INQUIRIES**

16.1 <u>AirBnB</u>

Councillor Ras requested that a report be brought forward in regards to AirBnB accommodations similar to the issues with UBER and other economy businesses. Martin Powell, Commissioner of Transportation and Works indicated that a report is being prepared in conjunction with Legal Services regarding AirBnB.

# 16.2 Garbage Bins

Councillor Parrish inquired about whether property standard changes are required to enforce the placement of garbage bins in neighbourhoods. Councillor Carlson requested that the Region of Peel and the City of Mississauga collaborate in promoting the exchange of the garbage bins. Martin Powell, Commissioner of Transportation and Works indicated that the Region of Peel has a by-law that governs the garbage bins and that staff are preparing a report on the issue for a future General Committee meeting. Gary Kent, Commissioner of Corporate Services and Chief Financial Officer indicated that the City is promoting the exchange of the garbage bins on the City website.

### 16.3 Dixie Road

Councillor Tovey inquired if the Ministry of Transportation (MTO) required a site plan for their work on Dixie Road. Martin Powell, Commissioner of Transportation and Works indicated that MTO is going through an Environmental Assessment and any issues would be discussed at that time. He further indicated that staff will review the issues and come to Council with a report.

# 16.4 <u>Utility Vans</u>

Councillor McFadden inquired about utility vans being able to park outside condominium buildings to provide service to residents of the building as the vans are unable to access the underground parking area because of their size and are receiving parking tickets when on the street. She further indicated that her office will be bringing forward a motion similar to the one that was passed at the City of Toronto that allows utility vans to be parked outside condominium buildings.

Councillor Fonseca inquired about snow removal on crescents, cul de sacs and courts. Martin Powell, Commissioner of Transportation and Works indicated that he would meet with staff regarding the issue.

# 16.7 Heights for Parking Garages and 311 Process

Councillor Starr inquired about the minimum heights for parking garages. Ed Sajecki, Commissioner of Planning and Building indicated that he would inquire with staff and provide a response. He further inquired about the call centre process when receiving a call. Gary Kent, Commissioner of Corporate Service and Chief Financial Officer indicated that staff follow the knowledge base that they receive from departments.
