5. **PRESENTATIONS**

5.1. Government Finance Officers Association Award

Councillor Ras requested that each part be voted on separately. Councillor Saito requested that a recorded vote be taken on the motion regarding PVAC-0006-2016 and the creation of the subcommittee.

Mayor Crombie and Councillors Tovey, Ras, Fonseca, Starr, Iannicca, Mahoney, Saito and McFadden spoke in support of the motion regarding the creation of the subcommittee. Councillors spoke about the industry changing and the need for the City to regulate the transportation network companies for the health, safety, consumer protection and nuisance of the residents. Councillors further spoke about the turnaround time being a time constraint and suggested that the date of September 21, 2016 for the subcommittee to return with a report of recommendations to General Committee and inquired about the feasibility of enforcement. Mickey Frost, Director of Enforcement indicated that he will speak to enforcement during closed session. Councillors requested a response to ceasing operations in the City of Mississauga from Mr. Shafer, a representative of Uber. Councillors Parrish and Carlson spoke against the motion in regards to the creation of the subcommittee and indicated that the issue should stay within the realm of the Public Vehicle Advisory Committee, which has been studying and debating the issue and further indicated that the transportation network companies should be coming forward to the City and inquiring as to how to integrate into the City's existing by-laws, instead of the City negotiating with companies that are contravening the City's existing by-laws. Councillor Parrish requested an amendment to the motion regarding the creation of the subcommittee to add to paragraph 16 "and non-compliance will result in the committee being disband".

Councillor Parrish requested to extend public questions period for an additional 15 minutes and Councillor McFadden seconded the request. The motion was passed and public question period was extended.

Each offer was analysed using the methodology that was established by Realty Services, placing emphasis on the highest purchase price offered, unconditional acceptance of the proposed Heritage Easement Agreement and the number and nature of conditions included in the Agreement of Purchase and Sale, if any.

AND WHEREAS an offer was received from Robert Ness and Rosalind Murray for a purchase price of \$685,000, without conditions.

AND WHEREAS an offer was received from Morgan Sinclair for a purchase price of \$699,100, subject to conditions.

AND WHEREAS an offer was received from Karen Scott-Booth for a purchase price of \$465,000, subject to conditions.

THEREFORE BE IT RESOLVED as follows:

- 1. That Morgan Sinclair replace her offer with an unconditional offer, including no revisions being made to the Agreement of Purchase and Sale for a purchase price of \$699,100.
- 2. That Morgan Sinclair's unconditional offer in the amount of \$699,100 must be received by the City of Mississauga, Material Management, by 4:00 pm on Monday May 9th, 2016; and

Whereas other cities in Ontario and across Canada have regulated TNCs in a variety of different ways based on the needs of their local residents; and

Whereas some TNCs have successfully undertaken pilot programs in major cities in the United States, such as Anchorage and Detroit to showcase and demonstrate their technology and services;

Whereas the City of Mississauga has undertaken an extensive review of the for hire vehicle industry and engaged in thorough public and stakeholder consultation on proposed changes to the Public Vehicle by-law; and

Whereas some TNCs have provided feedback to the Public Vehicle Advisory Committee and Council that they would be open to a pilot program; and

Whereas Mississauga City Council has a long history of making policies that are in the best interests of its residents and our businesses; and

Whereas City Council has approved the Capture option as recommended by PVAC on April 19, 2016...

Now therefore be it resolved that that a committee be created with the aim to developing a terms of reference for a limited one-year pilot program to allow Transport Network Companies (TNCs) to operate in Mississauga to determine how TNCs can operate within the Mississauga marketplace and under Council regulation; and
