5. **PRESENTATIONS** -Nil

6. **DEPUTATIONS**

6.1. Janaya Lo

Perry Lo and Janaya Lo spoke about her accomplishments as a pianist and showed a video of Miss Lo performance. Mayor Crombie presented Ms. Lo with a certificate in recognition of her accomplishments. Councillors Tovey, Fonseca and Iannicca spoke about the young girl's accomplishments and invited her to the Mississauga Youth Orchestra.

6.2. Autism Therapy - Intensive Behaviour Intervention (IBI)

Lina Pezzo, BCaBA, Sara Elkami, BCaBA and Josie Chaves a parent with a child on the spectrum spoke about Intensive Behaviour Intervention Therapy (IBI) and its importance for all children regardless of age and the scientific evidence that supports that this therapy is just as beneficial for autistic children 5 and older. They asked Council to endorse a motion to send to the Province of Ontario to reinstate adequate funding for children regardless of their age. Councillors Parrish, Starr, Saito and McFadden spoke in support of the motion to be sent to the Province of Ontario regarding the reinstatement of the funding to children regardless of age. Councillor Starr requested a recorded vote.

6.3. Mississauga Waterfront Festival (MWF) – June 17-19, 2016

Patricia Anderson, from Mississauga Waterfront Festival provided an overview of the 2016 programming for the Mississauga Waterfront Festival which runs from June 17 to June 19, 2016. Mayor Crombie, Councillors Tovey and Ras thanked Mississauga Waterfront Festival Committee and congratulated Ms. Anderson for receiving the Citizen of the Year Award.

6.4. Transportation Network Companies (TNCs)

Marcel Wieder, Peel Taxi Alliance spoke about the crippling effect of TNCs in Mississauga and provided a response indicating that the taxi industry is not interested in being part of the subcommittee with Uber or any other TNC until they stop operating in Mississauga. Councillors Ras and Parrish requested that the discussion and notice of motion be brought forward at this time. Members of Council inquired about the status of the cease and desist of the TNCs, how many transit users, what would happen with an increase of taxi drivers in the City and inquired about the cost to the customer. Mr. Wieder indicated that the taxi industry is not interested in working with TNCs because there has been no good faith shown by them. He further indicated that the driver receives a portion of the cost of the ride and TNC receives the rest.

7.1 Transportation Network Companies

Sami Khairallah indicated that Council passed a Resolution that the City would be using the capture option and if TNCs cannot follow the by-laws then an injunction needs to be filed. Mary Ellen Bench, City Solicitor indicated that the City could not file an injunction with the existing by-law as the by-law has not been amended. Councillor Starr requested that staff report back to Council in regards to the City pursuing an injunction. Mickey Frost, Director of Enforcement and Daryl Bell, Manager of Mobile Licensing Enforcement indicated that staff is enforcing the existing by-law with over 300 charges in the court system. Councillor Parrish inquired about the timeline for the amendments to the by-law. Ms. Bench indicated that staff are working on the amendments to the by-law. Mayor Crombie inquired about the success of those charges. Ms. Bench indicated that the matters are in pretrial and there are a number of charges where the City may be successful and others they will not be successful.

7.2 Stigma Superheros

Robert McKay, inquired about presenting to Members of Council regarding the stigma that is placed on people with mental health issues at school, in the workplace and in public. Councillor Iannicca indicated that he would be in contact with Mr. McKay in regards to the issue. Councillor Saito requested that Mr. McKay make a presentation at the Accessibility Advisory Committee in June.

7.3 Transportation and Network Companies

Mark Sexsmith spoke about the dismissal of Council's Resolution that was passed at the last Council meeting and requested a clear official statement. Mayor Crombie read out the motion. Members of Council raised concerns regarding the amended motion requesting to keep the cease and desist section so that if TNCs do not cease and desist the subcommittee is disband, that TNCs are disregarding Council's Resolution and that both industries should be represented in the subcommittee. Councillor Fonseca requested an amendment to paragraph three of the motion to include no later than June 29, 2016 General Committee. Councillor Saito requested an amendment to paragraph

five to include by Monday, May 30, 2016 and if not the Committee will proceed. Members of Council spoke about how Quebec is dealing with TNCs and how the province is involved. Councillor Tovey requested a recorded vote. Councillors Parrish, Starr, Mahoney and Carlson did not support the motion.
