Report Highlights

- The Strategic Plan, and its associated actions, guides Council and staff in building a great global city.
- In 2015, progress was made on 118 actions from the Plan, with 14 now completed.
- The annual Report on the Strategic Plan lists 19 key projects from 2015. The Report will be available on the City's website following the Council meeting on June 8, 2016.

Background

In April 2009, Council endorsed the Strategic Plan titled "Our Future Mississauga". The Plan plays a key role for Council and staff in shaping decision making, priority setting and building a great global city. It contains a number of Strategic Goals accompanied by action items. The goals and actions are categorized into five Strategic Pillars: Move; Belong; Connect; Prosper; and Green. To demonstrate the City's commitment to the Plan, an annual report is issued outlining the actions taken the previous year to advance it.

Comments

2015 Update

Each of the Strategic Pillars has a number of actions associated with it. Together these total 118, of which 14 are complete and the remainder are in progress. In some cases, the actions are long term and will take many years to accomplish. For example, the action to "attract five

new post secondary educational institutions" continues to be explored, but this work may take significant time to complete. However, Council and staff's continued efforts to address all actions in the Plan demonstrate the City's commitment to achieving its goals.

Moving from Vision to Action

In 2009, the City of Mississauga embarked on an ambitious journey – to launch a Strategic Plan and a 40 year vision for the city. More than 100,000 residents were engaged in Our Future Mississauga, the development of the plan. Six years later, the City has moved from vision to action and this progress is having a positive effect in our community.

As the Strategic Plan advances, we are committed to sharing our actions with residents. This helps the community monitor our progress and keeps our plan on track.

There are 100 actions currently underway from the Action Plan and 14 are complete. In 2015, we progressed on 25 major City projects, each relating to an action of the Strategic Plan and highlighted in this report. These projects include Mississauga's first city-wide transportation summit, the introduction of an Age-friendly Action Plan, development of a long-term vision for the booming Cooksville neighbourhood and more. These projects are making Mississauga a place where people choose to be.

Our progress in 2015 reflects the work being done to create a vibrant, global city where people of all ages can thrive. In the pages that follow, you will see how our work is helping Mississauga to Move, Belong, Connect, Prosper and Green.



Our Vision for the Future

Mississauga will inspire the world as a dynamic and beautiful global city for creativity and innovation, with vibrant, safe and connected communities; where we celebrate the rich diversity of our cultures, our historic villages, Lake Ontario and the Credit River valley. A place where people choose to be.

Strategic Pillars for Change



Each of these Strategic Pillars for Change has its own unique direction statement and principle, along with specific strategic goals to ensure that this Vision is achieved. The Plan provides a sound framework for action and vision to move our city forward for the next 40 years.

Achieving the Plan

Within the Strategic Plan, each Strategic Pillar for Change is connected to specific action items which will drive the Plan forward. These items are outlined in the Action Plan – a complementary document that includes key indicators, targets, actions and funding options for each Strategic Pillar for Change. The Strategic Plan comes alive through the work that is created through these key actions.

Measuring Success

The success of the Strategic Plan will be measured by the level of transformation and energy that we will be able to see, feel and hear all around our city.

Our annual Report on the Strategic Plan is delivered to Council and the community to help monitor progress and to keep the Plan on track. Reports are an important part of our pledge to continue working closely with our community partners to ensure that their voices are heard and that we stay grounded in the key actions that support our goals.

As we progress, we continue to see change all around us, as Mississauga becomes a world class city that attracts people, jobs and opportunities. It will be a location of destinations; a city with a variety of events and festivals supported by a vibrant downtown and a spectacular waterfront. It will be a location of choice for people who want to live, learn, work, play and visit. It will be a city where people choose to be.

Read on to see highlights of the progress we made in 2015 and how our Strategic Pillars for Change are making a real difference in our city.

How we moved the Strategic Plan forward in 2015



Hurontario Light Rail Transit Project (HLRT)

The HLRT Project is a light rail system that will bring approximately 20 kilometres of reliable, rapid transit to Mississauga. This is the largest infrastructure project in Mississauga's history.

Advanced Transportation Management System (ATMS)

As our population grows, the ATMS helps provide reliable travel times, minimal delays and accurate and timely travel information. The system allows the City to actively monitor travel conditions, better control traffic signals, share information and interact with other transportation modes.

Dundas Connects

In a move to transform the diverse, mixed-use Dundas corridor, the City has launched Dundas Connects – a project to create a Master Plan that will help this bustling street achieve its full potential as a link in the regional transit network.

Mississauga Moves 2015 (Transportation Summit)

The City's first-ever transportation summit brought together residents, business owners, stakeholders as well as members of City Council and staff, to discuss the city's current and future transportation needs with transportation experts. Over 250 people attended the event.



MiWay 5: Transit Service Plan 2016-2020

MiWay is working to meet the growing needs of transit riders across the city. MiWay 5 will provide a comprehensive review of where transit operates, when it operates and how frequently, resulting in a more streamlined and efficient service.

Lakeshore Road Transportation Master Plan and Implementation Strategy

This two year project was lanched in 2015 to engage local communities, special interest groups and other stakeholders in developing a vision for the Lakeshore corridor. The plan will determine the long-term transportation role, function and needs of the corridor based on projected growth.

Port Credit GO Station Southeast Area Master Plan

The master plan was the first step in Metrolinx's proposed redevelopment of the Port Credit Go Station southeast parking lot and new parking structure. The plan will build upon Port Credit's success as a transit-friendly community, while supporting the existing GO line and the future Hurontario Light Rail Transit system infrastructure.

🖞 Belong

Action Plan for an Age-friendly Mississauga

The City of Mississauga aspires to be a place where people choose to spend their entire lives. Our Age-friendly Action Plan will ensure that residents of all ages belong and thrive in Mississauga.

Diversity and Inclusion Advisory Committee

The creation of the Diversity and Inclusion Advisory Committee (DIAC) speaks to the City's commitment to inclusion for all residents of our community and awareness of diversity matters.

Ridgeway Community Courts Project (Colonial Terrace)

In partnership with the Region of Peel, the City is building a multi-sport court in the Colonial Terrace neighbourhood, giving youth and families access to free sports programming. Funding partners include the MLSE Foundation, Canadian Tire Jumpstart and Mississauga West Rotary Club.





Beach Volleyball Venue at Lakefront Promenade Park

Mississauga will proudly host the 2016 Ontario Summer Games. In preparation, the City is constructing a new beach volleyball facility at Lakefront Promenade Park, the first of this magnitude in Mississauga.

Connect

Mississauga Celebration Square Strategic Plan

This plan provides a ten-year vision for the Square as a premier venue for outdoor events, creative expression and memorable experiences for residents and visitors. It will lead the Square in growing and attracting events with tourism appeal and fostering a stage for creative development.

Fire Station 119 Relocation

This project created an opportunity for co-location with Peel Paramedics. Sharing the same building helped both Fire and Paramedic Services improve their response time goals and customer service. The new building was designed and built to achieve LEED Silver certification.

Environmental Study, Access to the Western Pier, OPG lands

The Access to the Western Pier Project is a response to community desire for public access to the water's edge along the Lakeview waterfront. The City has received provincial funding towards the project which will create a future public space that connects neighbourhoods and offers an experience of lake and city.





MyMalton Community Visioning (Phase 1)

The City-initiated review of Malton's planning policies will shape the look and feel of the community. In the project's first phase, the City engaged with the community of Malton to create a vision for its future growth and revitalization.

Increased Public Engagement (Budget Engagement)

The City is taking steps to educate residents on how the budget works to foster engagement with their local government. Tools such as an online budget allocator, teletown sessions and social media offer residents innovative, cost-effective collaboration and engagement.



ePlans

ePlans is an online 24/7 service that allows developers, contractors and consultants to submit applications for review and approval of site and building plans. ePlans has the potential to reduce overall review time and improve customer service, making it seamless for the public to do business with the City.

Inspiration Port Credit - 70 Mississauga Road South

The master planning framework for 70 Mississauga Road South, the Imperial lands, was developed with the community and approved by Council. It ensures revitalization of this site into a sustainable community to live, work, learn and play.





Sheridan Park Corporate Centre -Implementation of Land Use Master Plan

The implementation of the Land Use Master Plan will provide for more varied development in the Sheridan Park Corporate Centre. The proposed policies and regulations will help to attract innovative businesses such as the new Advanced Material Manufacturing Centre, a partnership between the National Research Council of Canada and Xerox.

Vision Cooksville

Downtown Cooksville is a busy urban, mixed-use community and major transportation hub. Vision Cooksville was launched in 2015 to develop a long-range community vision to guide revitalization and growth for this area based on extensive community input.

Launch of Mississauga International Partnership Program Committee (MIPP)

MIPP focuses on creating new and existing connections with cultural groups. These connections will help attract foreign investment and improve the City's global competitiveness.

Green

Stormwater Financing Study and Implementation Project

The City's new stormwater charge provides a dedicated source of funding to keep the infrastructure in good working order. This initiative supports the City's approach to environmental sustainability and promoting a greener culture.

LED Street Lighting Conversion Project

By using LED technology, Mississauga is a leader in promoting technology for a greener environment, in conserving energy and reducing harmful gas emissions. The project will convert approximately 50,000 streets lights to LED lights and include a state-of-the-art Street Lighting Monitoring System.

REPORT:	I was appointed Integrity Commissioner by agreement commencing on July 1, 2012 for a term of 5 years, expiring on June 30, 2017. This report covers the period from July 1, 2014 to June 30, 2015.	
	The duties assigned to me by the agreement are as follows:	
	 Advise confidentially members of Council or Council as a whole on their ethical obligations and responsibilities under the <i>Council Code of Conduct</i> and <i>Complaint Protocol</i>. ("Code") Upon receipt of a complaint, to determine whether the allegations made would, if substantiated, constitute a breach of the Code and if so to carry out an investigation. Upon the request of Council, to provide educational sessions 	
	regarding the role of the Integrity Commissioner and the	

ethical obligations of Council.

4. To report directly to Council on all of my activities.

The members of Mississauga Council continue to stand out among most of the other municipalities in Ontario served by an Integrity Commissioner, including many of my other clients, as having the most cooperative and harmonious relationship with each other and with staff. I have never received a formal complaint in Mississauga from any member of Council or staff.

At the commencement of the period covered by this report, the municipal election was in full swing and the Code required me to stay, until after the inaugural meeting of the new Council, complaints which request an investigation and are received by me from and after August 1.

I received 4 complaints during this period all of which were stayed as required. After the election, one of them was resolved, two of them were against members of Council who were not returned and the other one was dismissed by me.

Accomplishments during the Year

- A recommendation to amend the Code was accepted by Council in changing certain "Rules" to become general principles which, by themselves, cannot form the basis of an investigation. A principle such as diligently serving constituents must be judged by the electorate and not ruled on by the Integrity Commissioner.
- The City web site was expanded by the Clerks Department and IT in respect of information about accountability and transparency. Clear explanations on how to access the codes of Conduct and the Integrity Commissioner. All integrity documents, including my reports, are now posted on the site.
- I conducted an orientation workshop for the new members of Council attended by all and an educational session on the Code of Conduct for all members of Council.

Councillor Gift Information Statements

During the year, all members of Council are required by the Code to file with me quarterly Gift Information Statements which identify any gifts received which are valued at more than \$500. I received Declarations for each quarter from all members of Council that no such gifts were received during the year and three information statements identifying three gifts of more than \$500. I examined those gifts and found two not to create a conflict between a private interest and the public duty of the Councillor and the other I reported to Council as an inappropriate gift related to the Councillor's duties. Reports from all Councillors were filed for each quarter and they have been made part of the public record.

Requests for advice from Members of Council

Regularly throughout the year I spent time advising members of Council. Several of the requests for advice were concerning their support of charitable organizations and my interpretation of Rule 2, which encourages Councillors to support community groups. My overriding concern in this area is where community fund raising is done with lobbyists of the City who might expect favours in return. Many requests related to the election and requested me to distinguish between what activities of a ward office might be regarded as ward business and not campaigning. Several inquiries related to the use of social media during the election and after. Many other subjects were covered including concerns about participating in various activities that may amount to a conflict under the *Municipal Conflict of Interest Act.*

Public Contact

I receive E-mails and telephone calls from members of the public, several each week, which I respond to by providing information on the Code and answer other questions about ethics in municipalities. I try to be helpful and have found the majority of these contacts to be polite and respectful of the process. I do not assist them with filing complaints but if requested, I will send them a copy of one of the Codes which contains a complaint form.

Complaints Requesting an Investigation

During the year under review, I have received 12 complaints requesting an investigation including the 4 which were stayed

during the election and referred to earlier. Of the 8 remaining, I summarily dismissed 5 of them without an investigation. Several of them were based on confusion regarding my powers as Integrity Commissioner and the others were politically motivated.

The balance of three complaints were also dismissed:

- One complaint stemmed from a letter written by Mayor McCallion supporting the Liberal Government during the provincial election. The complainant was annoyed by the Mayor's use of City resources, including her letterhead, for partisan politics at the Province. The letter gave her opinion comparing the benefits that the liberal government had given to municipalities in general, with the harm caused by the former conservative governments. I came to the conclusion that the Mayor was expressing an opinion as Mayor, for the benefit of the City and such activity was part of her official duties. I dismissed the complaint.
- Another complaint was over the disrespectful comments made by one member of Council to a deputation opposing the zoning for a mosque in the City. The Councillor referred me to the website owned by the deputation which had clear racial overtones and I dismissed the complaint.
- The third complaint was a claim that a purely personal party arranged by the husband of a Councillor was paid for by the City. The evidence was that the party was fully paid for by the husband and the complaint was dismissed.

PROFESSIONAL DEVELOPMENT:

Municipal Integrity Commissioners of Ontario ("MICO")

As a founding member of the Municipal Integrity Commissioners of Ontario, I continue to participate in meetings where we identify and discuss broad issues within our mandate. The last meeting of the Association was hosted by the City of Vaughan on April 26, 2016 and in attendance were the newly appointed Ombudsman of Ontario, Paul Dubé and the Ontario Integrity Commissioner, J. David Wake. The Ombudsman delivered a message of support for local integrity officers and encouragement for all municipalities to appointed one. All complaints against councilors received by him will be referred to the local integrity officer and he describes the Ombudsman's office as the office of last resort for complaints relating to municipalities. **CONCLUSION:**

This report outlines the activities of the Integrity Commissioner from July 1, 2014 to June 30, 2015.

AGCO Special Occasion Permit holders must adhere to all provincial and municipal laws, by-laws, regulations and guidelines, and must select ONE of the areas above. Written permission from the City of Mississauga is required to license more than one area. Whereas the Provincial Government implemented the *Ontario Climate Change Strategy* to reduce greenhouse gas emissions to 80% below 1990 levels by 2050, and build a prosperous low-carbon economy;

Whereas increasing cycling can play an important role in meeting our climate change goals;

Whereas Ontario's daily cycling mode share is currently 1%.

Whereas an Ontario wide poll shows that 4.5% of Ontario residents ride a bike at least monthly and that 54% of Ontario residents want to cycle more than they currently do.

Whereas of the 54% polled, 67% would be encouraged to cycle more if there were more and better cycling infrastructure available (Share the Road, 2014);

Whereas Mississauga Cycling Advisory Committee (MCAC) is very focused on cycling and climate change;

Whereas MCAC have implemented a very successful Community Ride Program which has increased cycling greatly throughout the City;

Whereas the City of Mississauga has a Living Green Master Plan and Cycling Master Plan of which MCAC feels cycling needs to be a major component;

Whereas there is a strong interest among municipalities in building and investing in cycling infrastructure, as demonstrated during the first funding round of the Ontario Municipal Cycling Infrastructure Program, which received 150 applications from municipalities;

Whereas Mississauga has made great progress closing gaps in our cycling infrastructure. Closing these gaps will increase the safety of our residents and encourage more cycling as a means of transportation;

Whereas an investment in cycling infrastructure will complement the investments in public transit being made at both the provincial and federal levels;

Whereas an investment in cycling infrastructure will improve and enhance the multi-use trail system;

Whereas cycling plays an important role in promoting public transit helping Ontarians make the journey to and from the nearest transit stations more convenient and accessible;

Whereas an investment in cycling would support and promote cycling for all trips under 5k including walking and cycling routes to schools;

Whereas a funding commitment will help to achieve the goals set out in *Ontario Climate Change Strategy* and also contribute to meeting objectives in the Province's CycleOn Strategy and Action Plan 1.0;

Whereas these funds would be in addition to and not impact any other funding provided by the Province for infrastructrure;

Therefore be it resolved that Council moves to:

- 1. Urge the Provincial Government to recommend that the provincial cap and trade programs be leveraged to provide \$200 million for cycling infrastructure across Ontario over the next 4 years;
- 2. Urge Mayor Crombie to write a letter of support to the minister of the Environment and Climate Change;
- 3. Encourage other municipalities across Ontario through the Association of Municipalities of Ontario, to join with Mississauga in calling on the Province to act.
