**Applications for the Canada 150 Community Infrastructure Program (Intake 2)**

## Recommendation

1. That the Commissioner of Community Services be authorized to submit grant applications for CIP 150 Recommended Projects as listed in Appendix 1, and in accordance with the terms and conditions of the Canada 150 Community Infrastructure Program Intake Two (CIP 150), as outlined in the report dated June 7, 2016, from the Commissioner of Corporate Services and Chief Financial Officer titled "Applications for the Canada 150 Community Infrastructure Program (Intake 2)"
2. That staff report back to Council on projects approved for the CIP 150 Intake Two funding, including necessary City capital contributions and additional project delivery costs, upon notification of any successful application.

## Report Highlights

- On May 24, 2016 the Government of Canada announced the launch of Intake Two of the Canada 150 Community Infrastructure Program (CIP150).
- The program provides \$150 million nationally over two years with an allocation of \$88.8 million over two years for Southern Ontario. \$44.4 million is now available for this year under the program. The deadline for submission is June 24, 2016, 5:00 pm EDT.
- Appendix 1 provides a list of 80 eligible projects seeking 50% project funding in the amount of \$10,801,157.

## Background

On May 15, 2015 the Government of Canada announced the launch of the Canada 150 Community Infrastructure Program. Through this program the City of Mississauga was successful in securing \$2.1 million in grant funding to support 25 projects.

As part of the Federal Government's commitment to infrastructure, as announced in the 2016 Federal Budget, the Honorable Navdeep Bains, Minister of Innovation, Science and Economic Development and Minister responsible for FedDev Ontario, announced on May 25, 2016 the launch of Intake Two of the Canada 150 Community Infrastructure Program (CIP 150) in Southern Ontario.

Canada 150 Intake Two responds to the significant demand for community infrastructure improvements. The program has been designed to assist municipalities in making important investments in projects that renovate, expand and improve existing public infrastructure assets such as community centres, recreational facilities, cultural centres, trails, playground equipment and other community infrastructure as part of the Government of Canada's approach to celebrating the 150th anniversary of Canada's Confederation.

The program focuses on projects that are construction ready, and are of a rehabilitation, or renovation nature. Expansion of existing community infrastructure assets will also be considered. New assets or amenities are not eligible. Further, work completed must be for facilities that are that are open for public use.

The program provides \$150 million nationally over two years with an allocation of \$88.8 million over two years for Southern Ontario. \$44.4 million is now available for Intake Two. Qualified recipients may receive contributions of up to a maximum of \$1,000,000 per eligible project. The program funding recipients may receive up to 50 percent of total eligible project costs. Priority will be given to projects that require a federal contribution of 33.3% of total eligible project costs. The focus of CIP150 is on smaller-scoped projects to ensure projects can be completed within the required timeframes and to ensure that the program benefits are broadly shared. All projects must be substantially completed by March 31, 2018. The deadline for applications is 5:00 p.m. EDT on June 24, 2016.

All project applications must be prioritized by the City as part of its submission. This report recommends a prioritized list of projects, attached as Appendix 1, which can offer the city the best chance for success in obtaining funding while meeting the required criteria.

## Present Status

### Eligible Projects

Projects must fall within the following project categories to be eligible for funding under the program:

- Community centres
- Cultural centres and museums
- Parks, recreational trails, including fitness trails, bike paths and other types of trails
- Libraries
- Recreational facilities including local arenas, gymnasias, swimming pools, sports fields, tennis, basketball, volleyball or other sport-specific courts, golf courses, ski hills or other types of recreational facilities
- Tourism facilities
- Docks
- Cenotaphs, and
- Other existing community infrastructure assets for public benefit that have a local community impact, such as local roads, drinking water treatment and distribution systems, connectivity and broadband, local airports, solid waste management and wastewater infrastructure.

Further, examples of eligible projects include:

- Replacing windows and doors in a community centre to improve energy efficiency
- Expansions such as new entrances and ramps to improve accessibility to a facility
- Upgrading heating, cooling or electrical systems to meet safety standards
- Adding a roof or lighting to an outdoor rink, and
- Extending a trail or bike path by no more than 50 percent of its existing length.

### Application Requirements

Applications and supporting documentation must be submitted to FedDev Ontario no later than 5:00 p.m. EDT on June 24, 2016. An application form and supporting documentation must be submitted for each project.

### Assessment Process

FedDev Ontario will review all applications following the application deadline. Applicants will be notified of the results of their application in writing. In addition to the criteria as outlined above, projects will further be assessed on the following criteria:

- Project readiness and completion by March 31, 2018
- Project scope

- Extent to which other funding is leveraged; priority may be given to projects that leverage 66.6 percent or more
- Extent to which the project supports a clean growth economy
- Link to Canada's 150<sup>th</sup> Anniversary, and
- Incrementality; applicants must be able to attest that the work to be undertaken is an incremental construction activity that would not otherwise have been constructed as quickly if not funded through this program.

#### Recommended Submission Approach

Similar to Phase One of the C150 Grant program, staff have reviewed the consolidated list of potential eligible grant projects, attached as Appendix 1 to determine potential eligible projects for this grant program. The strategy for submission is focused on projects that leverage the existing forecasted capital budget as well as securing the maximum available funding of 50 percent of eligible costs.

Understanding that there is a small pool of funding, staff will be submitting projects taking into consideration the following:

- Infrastructure that will require lifecycle maintenance
- Projects that will improve accessibility
- Infrastructure that serve a large number of residents
- Projects that have historical significance or that can be linked to Canada's 150<sup>th</sup> Anniversary, and
- Projects which can be completed by March 31, 2018

#### Recommended Projects

A list of 80 prioritized recommended projects totalling \$23,862,957 can be found in Appendix 1. These projects best meet the criteria and timelines of the CIP 150 Intake Two Program. Each project must be submitted individually, thereby increasing the number of projects.

#### Implementation, Coordination and Procurement

At this time the city has not been advised as to when the Federal Government will be notifying applicants of any successful funding submissions. Based on last year's program, funding announcements were not made until the Fall, 2015. Should this be the case for this program, in order to meet the March 31, 2018 construction deadline, staff may be required to expedite the procurement process through sole sourcing. Additional staff resources may be required to complete the projects and meet the necessary deadlines. Once notification of the grant awards are received, staff will report back to Council to acquire the necessary approvals.

## **Strategic Plan**

The CIP 150 Intake Two Program assists in advancing the city's strategic goal to Build and Maintain Infrastructure under the Completing our Neighbourhoods Pillar. This program will allow the city to improve its infrastructure and provide additional benefits to the community.

## Financial Impact

There are 80 projects recommended for funding under the CIP150 Program which cost a combined total of approximately \$23,862,957. Certain costs under the program are ineligible such as overhead costs and HST. Therefore, applications for funding will be in the amount of 50% of \$21,923,539.

Original funding for the majority of these projects were primarily forecasted through tax based reserves in the approved capital budget. It should be noted that there are still a number of projects being submitted which are outside of the City's approved capital budget forecast. These projects are being submitted for consideration as grant funding will provide an opportunity for 50 cent funding on projects which may have not been constructed or constructed as quickly. If the grant funding is approved for all 80 projects, the City will have to commit an amount of \$13,061,800 in funding and reduce the capital budget forecast accordingly.

Upon notification of successful applications, staff will bring a report forward to Council identifying any updated project costs and any financing transactions required to fund any approved projects.

## Conclusion

The CIP 150 Intake Two program offers an opportunity for the City to complete projects of historical significance that will help celebrate Canada's 150th Anniversary. Based on the information and recommendations provided in this report, staff will complete grant applications for the projects endorsed by Council prior to the submission deadline 5:00 pm EDT, June 24, 2016.

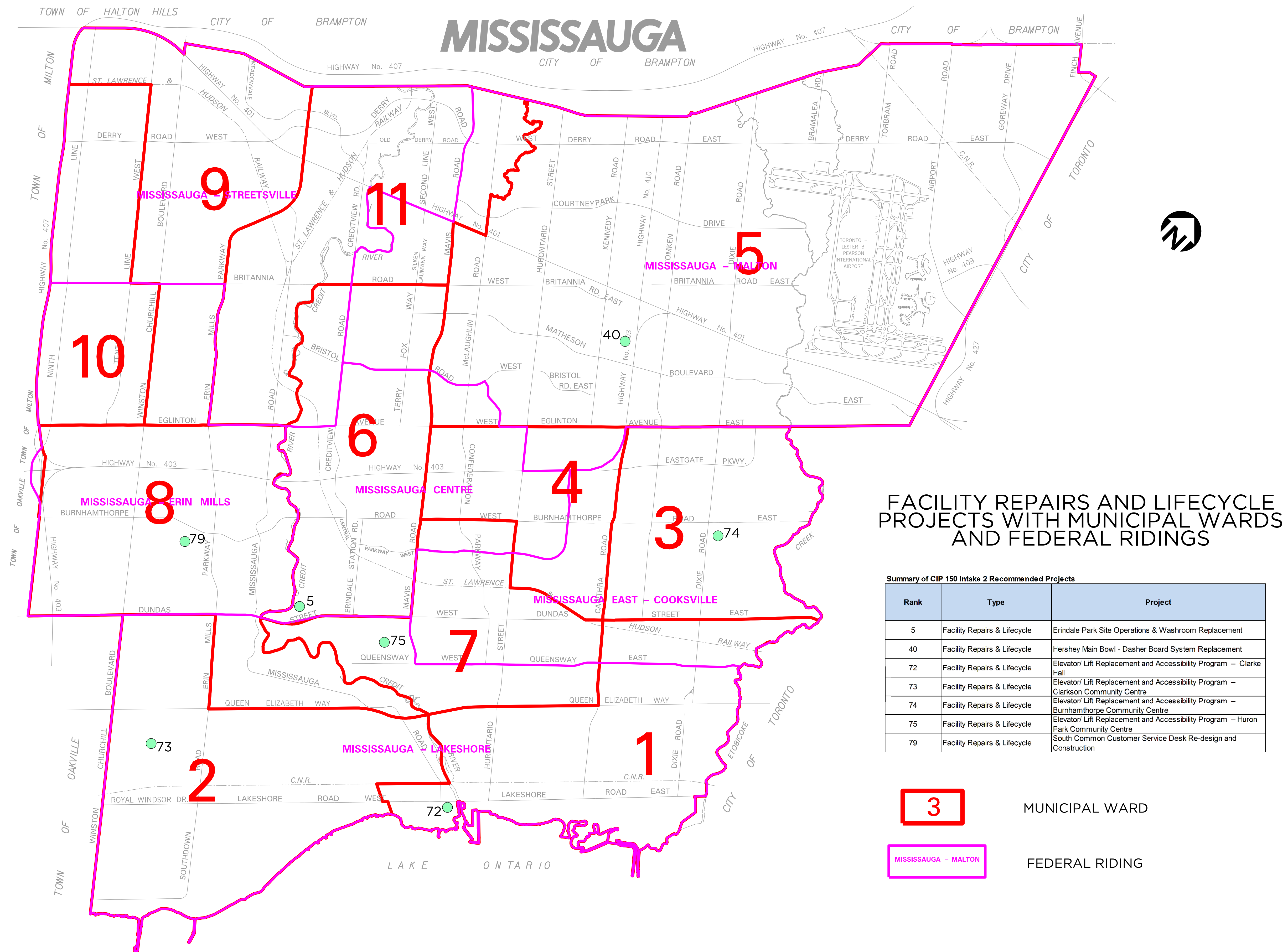

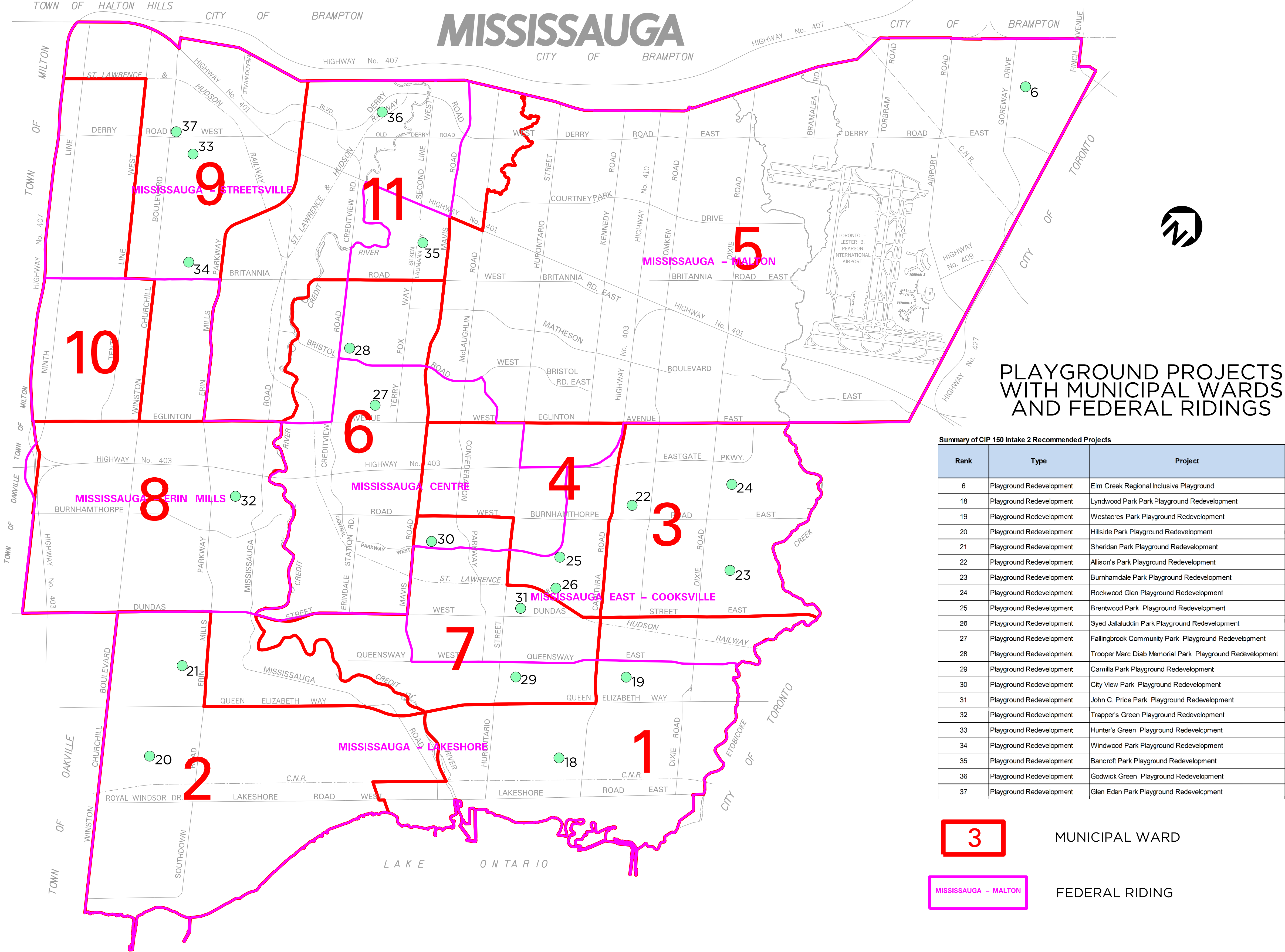

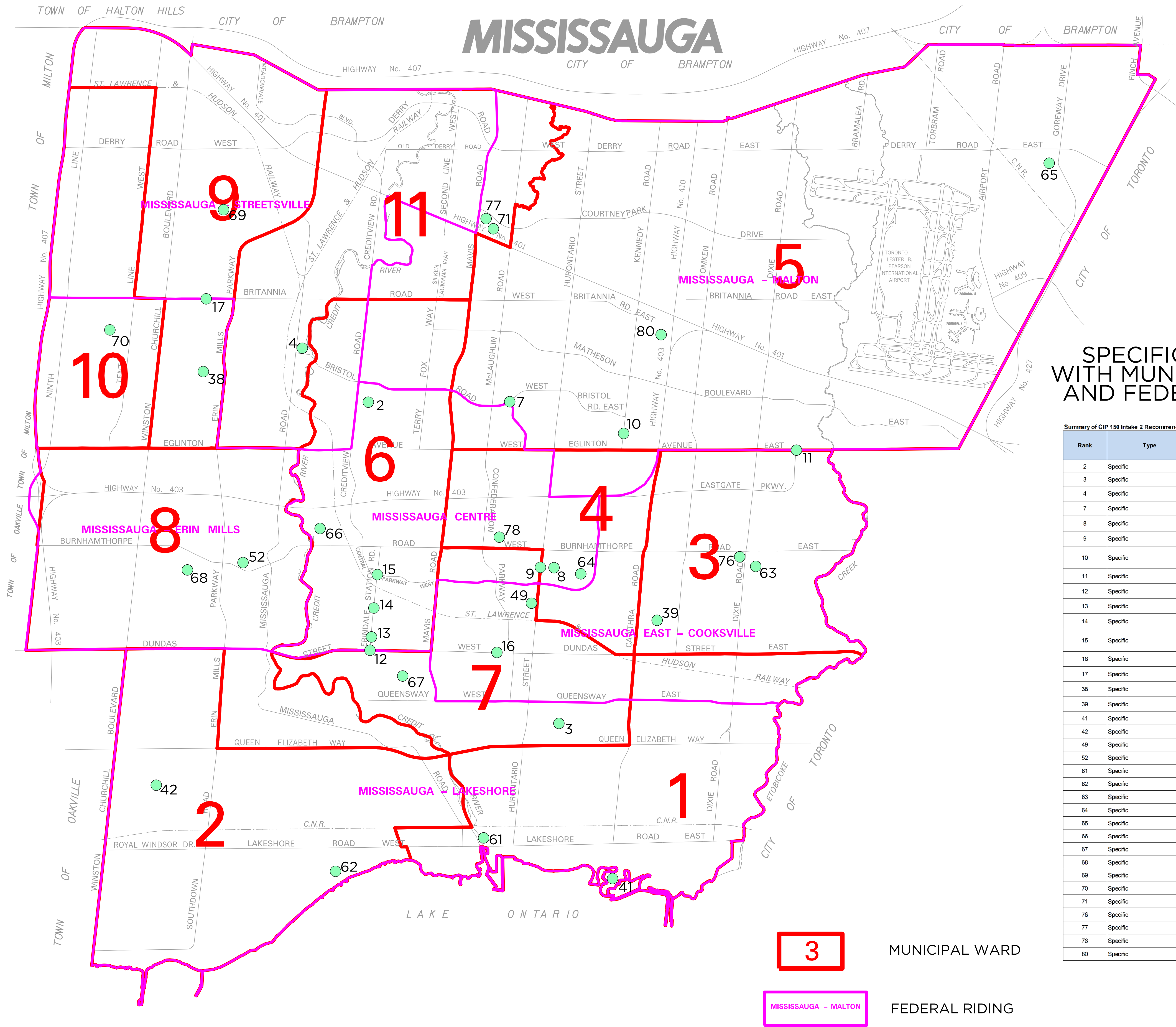

FEDERAL RIDING



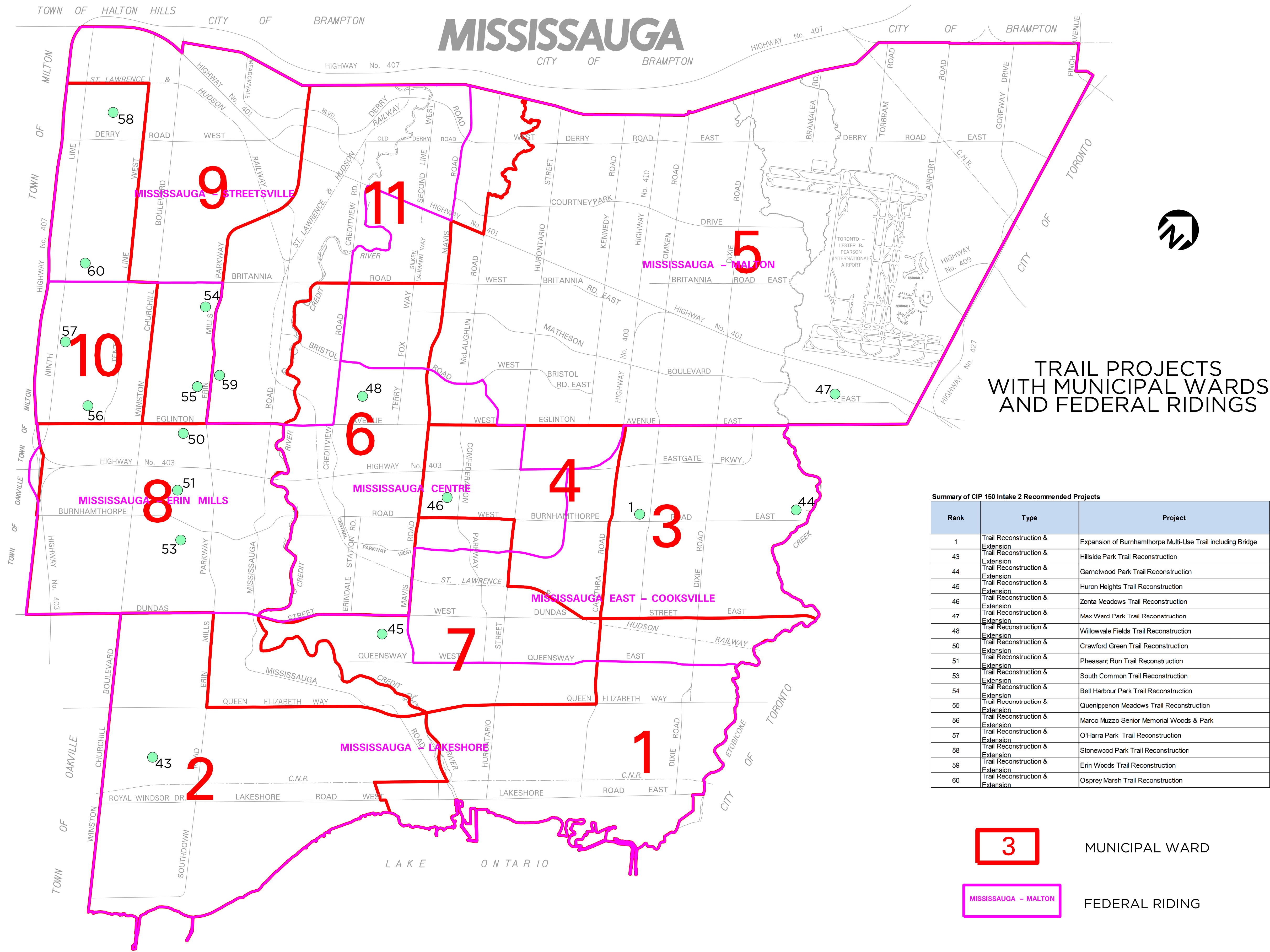
