**Tax Adjustments Pursuant to Sections 357 and 358 of the *Municipal Act*.**

## Recommendation

That the tax adjustments outlined in Appendix 1 attached to the report dated September 6, 2016 from the Commissioner of Corporate Services and Chief Financial Officer for applications for cancellation or refund of taxes pursuant to Sections 357 and 358 of the *Municipal Act*, be adopted.

## Background

Sections 357 and 358 of the *Municipal Act*, 2001, S.O. 2001, c.25 allow a property owner or the Treasurer to make an application for the cancellation, reduction or refund of taxes for a number of specific reasons. Taxes may be adjusted when a building has been demolished or razed by fire or if a property has become exempt, changed class or has been overcharged by reason of gross or manifest error.

## Comments

A total of 60 applications for tax adjustments have been prepared for Council's consideration. The total cancellation or refund of taxes as recommended is \$761,302.91. Appendix 1 outlines the tax cancellations being recommended by property and summarizes by appeal reason the number of applications and tax dollars recommended for reduction.

## Financial Impact

The City's portion of the cancellations resulting from the Section 357 and 358 tax adjustments is \$157,175.50.



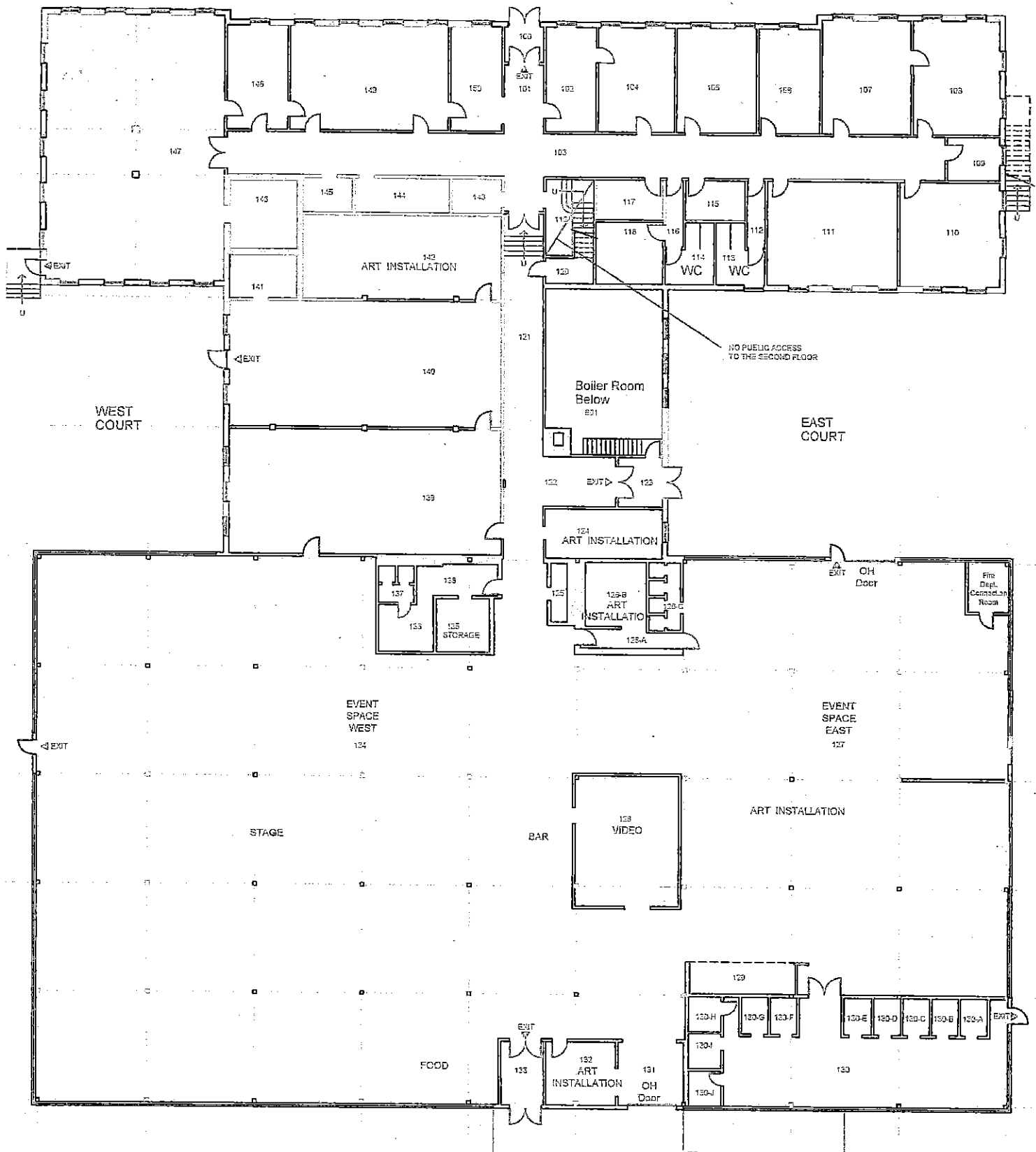

Dear Madam Premier,

I write to you today on behalf of Mississauga City Council about the proposed amendments to the *Municipal Elections Modernization Act* in particular the proposal to remove the ability of municipal candidates to accept donations from corporations and unions. We feel this amendment has been moved without proper consultation and will have adverse effects on municipal election campaigns. Moreover, we have concerns that other measures have not been put in place to supplement these changes and offset their effect.

In 2015, the Ministry of Municipal Affairs and Housing asked municipalities to provide feedback on the modernization of legislation, including the Municipal Elections Act. Mississauga City Council studied the proposed legislation and provided our feedback to the Minister and the Ministry (see attached). At no time were we asked to comment on the province-wide banning of corporate and union donations to municipal candidates.

As such, we have been taken by surprise by the Minister's recent amendments to the legislation on May 18, 2016 and ask that you and your government reconsider or at the very least delay these amendments until such time as proper consultation with all municipalities, as well as organizations like the Association of Municipalities of Ontario (AMO) can be undertaken. You have no doubt received AMO's response to these proposed amendments. They share similar concerns to the City of Mississauga Council, and likely other municipalities across the province.

Our Council feels strongly that while the idea of eliminating corporate and union donations is worth further debate, there needs to be an additional discussion about how municipal campaigns will be financed if these types of donations are eliminated. Our Council has the following concerns:

- The transparency of election donations will be compromised as it will become increasingly difficult for the public to know who is actually donating money will be lost. For instance, donations will still come personally from CEOs of business, but the public won't readily know the link between the individual and the company they represent;

- Those who are personally wealthy will be in a much better position to finance their own campaigns than those who are not. This may compromise the democratic process by precluding some candidates from running due to a lack of funds;
- Incumbents will be given more of an advantage as challengers will be unable to raise the initial funds necessary to mount a strong campaign and develop name recognition, especially for mayoral campaigns in larger municipalities;
- While the federal and provincial governments have banned corporate and union donations, political parties at both levels are permitted to fundraise between writ periods, and a per vote subsidy is provided to all parties who achieve a certain threshold of the vote. Neither option is provided to municipalities; and
- The \$750 donation limit, which has not been changed since 1991, provides yet another hurdle for municipal candidates to overcome. This limit needs to be raised to match the demands of modern campaigns with higher spending limits.

We respectfully ask that your government reconsider this last minute amendment and defer it until such time as proper consultation can be undertaken with municipalities. As well, we ask that you reconsider raising the donation limit, especially for mayoral campaigns in large cities. Had we been informed in advance that such amendments were being considered, I and other municipal leaders would have likely made a deputation to the Standing Committee.
