WHEREAS the legislature of the Province of Ontario has proclaimed February 14 as *Hazel McCallion Day;*

THEREFORE, be it resolved that the Council of the City of Mississauga commend the Province of Ontario for proclaiming *Hazel McCallion Day;* and

WHEREAS an application has been submitted in the Dixie Employment Area Character Area for a manufacturing use that may be incompatible with the emerging vision for the Dundas Corridor;

AND WHEREAS Section 1.1.1 (c) and Section 3.0 of the *Provincial Policy Statement* states that healthy, liveable and safe communities are sustained by avoiding development and land use patterns which may cause public health and safety concerns and that development shall be directed away from areas of human-made hazards where there is risk to public health or safety or of property damage, and not create new or aggravate existing hazards;

AND WHEREAS Section 1.6.8.3 of the *Provincial Policy Statement* contemplates new development planned on lands in proximity to transportation facilities should be compatible with and supportive of the long-term purposes of the corridor and should be designed to avoid, mitigate or minimize negative impacts on and from the corridor and transportation facilities;

AND WHEREAS Section 3.2.1 of the Provincial *Growth Plan* requires that priority will be given to Provincial infrastructure investments that support the policies of the *Growth Plan*;

AND WHEREAS Section 3.2.3 of the Provincial *Growth Plan* requires that transit infrastructure shall be used to shape growth by planning for higher residential and employment densities along and around station areas in order to support and ensure efficiency and viability of the public transit system;

AND WHEREAS Mississauga Official Plan identifies Dundas Street as an intensification corridor with higher order transit that has the potential to be supportive of growth and development;

AND WHEREAS the Dundas Corridor has been identified in *The Big Move* for higher order transit and has been identified by Metrolinx as a Next Wave project; and the Province of Ontario has funded a study ("Dundas Connects") to consider intensification and transit-supportive land uses for the Dundas Corridor;

AND WHEREAS the Municipal Comprehensive Review of Employment Lands (2015) identifies lands within the Dixie Employment Area Character Area as a "Potential Conversion Area" to consider higher density, mixed use development including residential and other sensitive land uses;

AND WHEREAS additional land use conversions including higher density residential and other sensitive land uses to support higher order transit in the vicinity of the Mavis-Erindale Employment Area Character Area are being contemplated by the Dundas Connects Study;

AND WHEREAS the City is developing a master plan for the Dundas Corridor to identify higher order transit technology and land uses that support the intensification and compatible land uses in proximity to the Corridor;

AND WHEREAS land uses that may be established in the Dixie Employment Area and Mavis-Erindale Employment Area Character Areas are based on existing Official Plan policies and Zoning By-law 0225-2007 provisions, as amended, which would allow for uses that may be incompatible with the emerging vision for the Dundas Corridor and therefore certain land uses should not be permitted until such time as a study has been undertaken to determine which manufacturing uses would be appropriate;

AND WHEREAS an application has been submitted for a use that has raised awareness that existing land use permissions under the current Official Plan and Zoning environment may jeopardize the emerging vision of the Dundas Corridor, council considers it to be vital before any new potentially incompatible uses become established that a pause be taken to allow time for the undertaking of a study to determine the types of land uses that will be compatible with the emerging vision for the Dundas Corridor;

THEREFORE BE IT RESOLVED that:

The Planning and Building Department be directed to undertake a study of Mississauga Official Plan land use policies and Zoning By-law 0225-2007 provisions, as amended, for the lands in the Dixie Employment Area Character Area and the lands in the Mavis-Erindale Employment Area Character Area south of the Canadian Pacific Rail Line (otherwise known as the St. Lawrence and Hudson Railway) and

- 2. City Council enact an interim control by-law pursuant to Section 38 of the *Planning Act* for a period of one year for the Dixie Employment Area Character Area and the Mavis-Erindale Employment Area Character Area south of the Canadian Pacific Rail Line to prohibit the following incompatible manufacturing land uses:
 - abattoir or rendering of animals and animal by-products
 - ammunition, firearms or fireworks manufacturing
 - asbestos products manufacturing
 - · battery manufacturing
 - beverage distillation and manufacturing
 - cement manufacturing or concrete batching plant
 - chemical manufacturing and processing
 - composting facility
 - dry cleaning plant
 - explosives manufacturing and storage
 - fish products manufacturing, oil extraction from fish and animal matter
 - gypsum or limestone processing and by-product manufacturing
 - hazardous materials processing or manufacturing
 - · industrial gas manufacturing
 - manufacturing and storage of fertilizers or pesticides
 - · medicinal product manufacturing
 - milling operations
 - oil-based paints, oil-based coatings, adhesives, resin, and natural or synthetic rubber manufacturing
 - outdoor storage
 - petroleum and coal refining and by-product manufacturing
 - · phosphate or sulphur products manufacturing
 - plastics manufacturing
 - science and technology facility related to any prohibited use

- smelting or foundry operations
- solvent manufacturing
- sugar refinery
- tannery
- tar and asphalt manufacturing
- · textile manufacturing and processing
- truck terminal
- waste processing station
- waste transfer station
- wood treating and preservative facility
- The enlargement or replacement of uses listed in Paragraph 2 which were legally existing on the date of the passing of the interim control by-law shall not be permitted.
