This cover letter will also be sent to the organizations indicated by the "CC" at the end of the letter. They include the required notifications to the Fire, Police, Building Enforcement and the Health Department. The City of Mississauga's Clerk Office will also be sent a copy, of which they will gain approval by the City of Mississauga City Council, before they can produce a letter of non-objection. A Copy of the letter of non-objection will then be forwarded to your office by mail or fax.

The Streetsville Legion Branch 139 is once again proud to be hosting several community events this summer that will increase public awareness of our goals and objectives as well as our commitment to serving the community and providing much needed funds to local, regional, provincial and national organizations. Our local concerns include Veterans, Seniors' needs, our local Hospitals, four Cadet Corps as well as many others on an as needed basis. Some of the funds raised from these events as well as our dedication to our annual Poppy Campaign also support provincial and national Legion charity programs and provide much good to our Canadian Society.

Lest we forget

We intend to utilize our licensed premises and patio, some of our parking lot and grassy area on the north side of the building as we have in previous years. We will be serving food, liquor and beer in these areas and providing live band and DJ entertainment. The entire property is owned by the Legion. We are again preparing to welcome Legion members, as well as non-members visiting or residing in the community. We are hoping to attract 500 people or more to each event.

Hot food will be served with uncooked food being kept in coolers, personal hygiene procedures will be observed in the proper manner as directed by the Region of Peel Health Unit. No additional buildings will be constructed and we will use tents for shelter of the serving areas only. The conditions and careful procedures as directed by the Mississauga Fire Department will be followed in regards to the positioning of all cooking units and fire extinguisher quantity and placement. We will be controlling event access with comprehensive fencing and Legion volunteers acting as our Identified Staff to secure all entry and exit points. A warm welcome to the advice and attendance of the Peel Regional Police is always extended and we expect many officers will the time to visit as in the past.

The Streetsville Legion has never committed or experienced any disturbances of bylaws or liquor infractions at any of our events and we plan on keeping our record unblemished. We assure total compliance with all Municipal, Fire, Health, AGCO and Security regulations. We eagerly look forward to once again serving our community.

Restricted Access Area(s)

In order to provide the necessary safety zone for the picnic and Open House, the area will be supervised by staff members and volunteers. The beer zone will have a tent (approximately 20'x40') and will be bordered by fences. Alcohol will be under the supervision of management and will be sold by bartenders who have Smart Serve Certificates. Non-alcoholic beverages will also be available on site. Guests will have access to the main floor of the residence and the 10-acre gardens. There will be guided tours by request. The petting zoo will be separate from the food area and will meet all regulations.

Event Operating Hours

The picnic and entertainment will take place on Sunday, June 18th from 1 pm to 5 pm. There will be free parking available. Food and beverages will be served outside from 1 pm to 4 pm in the area immediately adjacent to the exit from our Atrium, approximately 40' x 50' (see site plan attached).

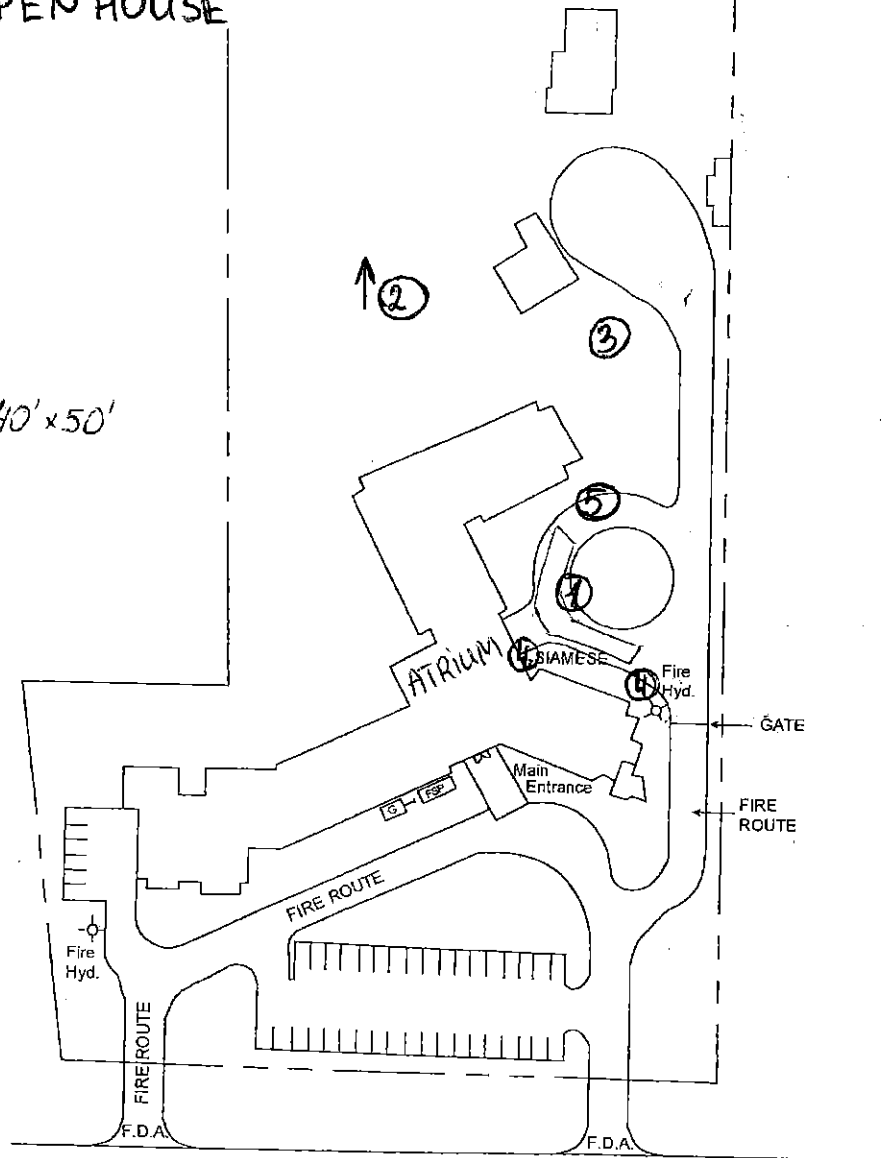
