Dear Mayor Crombie:

Thank you for your recent letter.

I appreciate your questions regarding both the closure of Runway 05/23 for maintenance, and our ongoing efforts to engage the community as it relates to our operations and our plans for Toronto Pearson airport.

On March 28, the GTAA began the rehabilitation construction project on Runway 05/23, our main east-west runway, our busiest runway, and the busiest runway in Canada. The runway accounts for approximately 45% of the aircraft arrivals and departures at Toronto Pearson. The last major reconstruction of Runway 05/23 was performed twelve years ago in 2005. Like all infrastructure, our runways need to be properly serviced and maintained to ensure safe operations.

Regrettably, weather conditions during this construction project were unseasonably wet and windy, and this, combined with a number of other factors that affect airport operations, meant that flights were operating on north-south runways on a much more frequent basis, and flights to and from Toronto Pearson were delayed. I apologize for any inconvenience this rehabilitation caused your constituents in the form of travel delays or significantly changed patterns in aircraft traffic in recent weeks.

This work has now been completed, and as of the evening of Tuesday, May 16, Runway 05/23 is in service. In addition, we were able to advance and complete Phase 3 of the construction, which was originally scheduled for Fall 2017. The Runway rehabilitation was completed safely and on time, returning the runway to service ahead of peak summer travel.

We expect flight paths around Toronto Pearson will now return to more regular usage patterns, determined by weather and other operational factors. Residents to the north and south of the airport should notice reduced aircraft traffic levels versus what has occurred during this period of runway work; residents to the east and west will experience aircraft traffic levels they were familiar with prior to March 28.

We're communicating our return to regular operations through contact with elected officials, an updated Noise Advisory, our social media channels, website, media relations, outreach to CENAC members and other residents directly, and Checking In, our community e-newsletter.

The GTAA has also been invited to participate in a public town hall meeting on the topic, hosted by MPs Peter Fonseca (Mississauga East-Cooksville), James Maloney (Etobicoke Lakeshore) Arif Virani (Parkdale-High Park) and Borys Wrzesnewskyj (Etobicoke-Centre) on Saturday, May 27 from 2 p.m. to 4 p.m. at Silverthorn Collegiate.

Our team is working to refine and improve our approach for communicating the impacts of future major projects with passengers, local communities and elected officials.

As part of this work, over the next six months, we're reaching out to community members in many ways, including:

- public workshops;
- a survey on Noise Fairness and Airport Growth, which is now available on our website (www.torontopearson.com/rrp);
- open houses;
- Community Environment and Noise Advisory Committee (CENAC) meetings; and
- the annual Runway Run and Street Festival.

Opinions and feedback provided through these outreach opportunities will be used to inform a Residents Reference Panel on Noise Fairness and Airport Growth. The panel, which will be comprised of 36 randomly selected residents from the regions of Peel, York, Durham, Vaughan, Toronto and Halton, is being created specifically to ensure that Toronto Pearson's future growth takes into account the priorities and concerns of area residents. The random selection process ensures that the Panel is balanced to match the gender, age, and population profile of the region, as well as proximity to the airport. Residents that did not receive an invitation package to participate in the Panel can stay involved in the process through the activities listed above.

The Residents' Reference Panel will help us by:

- developing criteria to decide when and where we should implement changes that are proposed in the noise mitigation studies that are currently underway;
- providing recommendations around airport growth to our management team and to the Community Environment and Noise Advisory Committee (CENAC); and
- guiding our approach to future public consultations, starting with our outreach to residents about Noise Mitigation Initiatives – Ideas 5 & 6, which will happen later this year.
