5. **PRESENTATIONS**

5.1. MiWay Student Ambassador Program Awards

6.2. HomeStay Health Services

Shadea Subero and Joanne Turner, Co-Founders of HomeStay Health Services spoke regarding their Special Needs, Dual Diagnosis and Mental Health Programs that serve adults with disabilities in the City of Mississauga and noted the various partnerships they have with other social services and mental health agencies. Ms. Turner spoke regarding the pending opening of a new location in Ward 11 and requested that Council assist with the cost of leasing the property. Councillor McFadden spoke in support of an additional location and suggested that they provide education to the surrounding neighbours. Councillor Saito spoke in support of an additional location and suggested that a deputation to Regional Council would be appropriate as the Region may be able to assist with funding.

6.3. Mississauga Music and 'From Far and Wide'

Demetrius Nath, founder of Mississauga Music spoke regarding the Mississauga Music organization, noting that they showcase the best from Mississauga's music community. Mr. Nath introduced the members of 'From Far & Wide' who sang their Canada 150 song, "We are the North". Members of 'From Far and Wide' spoke regarding their connections with the Mississauga Arts Council and the City's Culture Division. The Mayor and Members of Council congratulated the group and invited them to sing at various Canada Day events. Councillor Iannicca put forth a motion to have the song, "We are the North" be declared as Mississauga's official song of summer 2017.

6.4. Canada Day Together Festival

David Raakman, Steering Committee Chair spoke regarding the second annual 2017 Canada Day Together Festival in Ward 10 and showed a video highlighting the scheduled entertainment and activities. Mr. Raakman commented further on the cultural diversity of the event and noted that participants in attendance would have the opportunity to paint a tile that would be amalgamated to create a legacy public art piece, to be displayed at the new community centre in Ward 10. The Mayor and Members of Council congratulated Mr. Raakman on the upcoming event.

6.5. Petition: To Rescind Clause 3 of Council Resolution 0054-2017

Sami Khairallah of the Peel Taxi Alliance spoke regarding Petition 12.1., opposing the issuance of 250 temporary taxi plates during the pending TNC Pilot Project noting that there are currently taxi plates "on the shelf" and that issuing additional plates would create great losses of income to current plate owners and drivers. Councillor Parrish commented that Enforcement staff had mailed a survey to taxi drivers to gauge interest in purchasing a temporary taxi plate and that there had been 228 positive responses. She spoke to reducing or removing many taxi regulations to make the requirements equal to Uber's requirements. Mr. Khairallah indicated that the potential harm caused by issuing the temporary plates could be greater than the competition with TNCs.

6.6. <u>Cankerworm Issue in Ward 2</u>

Councillor Ras made a presentation regarding the infestation of cankerworms in Ward 2, noting that the last aerial spraying to control cankerworms and Gypsy Moths had occurred ten years ago. Councillor Ras spoke to the Forestry Division providing education to residents, and that residents have been banding their trees but it has been ineffective this year due to the infestation. Jessica McEachren, Forestry Manager provided an update on staff's efforts to control the infestation of cankerworms, noting that a ground spray had been applied to 249 trees, that a second application could be applied shortly and that a preventative spray should occur at the first frost. Mayor Crombie and Councillor Starr requested that educational information be sent to the Councillors' offices in order to provide residents with a standard response. Furthermore, Mahoney indicated that communication with residents was extremely important and thanked the staff for their work on the matter.

At this time Council took leave of the agenda to hear from residents during Public Question Period.

Councillor Ras thanked both residents for attending the meeting and spoke regarding regular spraying as a regular regimen. Councillor lannicca noted that the spray, "BTK", is organic and harmless. Mayor Crombie noted the importance of public consultation.

Whereas cankerworms have wreaked devastation in trees in the City of Mississauga this Spring, in particular Ward 1, 2, 6, 7 and 8;

Whereas if populations are left unchecked, cankerworms and gypsy moth can grow to outbreak levels which can lead to tree defoliations and ultimately affect the health of the urban forest canopy;

Whereas the last time the city aerial sprayed BTK was 10 years ago;

Whereas BTK is soil-dwelling bacterium, commonly used as a biological pesticide and is effective in the control of cankerworms and gypsy moth and safe for use in urban areas;

Whereas other nearby municipalities such as Toronto have recently conducted aerial spraying to combat these pests;

Whereas even with preventative measures such as banding, appears to have little effect;

Be it resolved that the City of Mississauga Forestry staff be directed to report back in the Fall 2017 with a plan, including: aerial spraying; community consultation; and a communications plan regarding the areas that will be sprayed and the costs and that the City of Mississauga coordinate and collaborate with area municipalities where possible to find greater efficiencies and lower cost pressures.

And whereas all hammerheads along Glen Erin Drive were built to an approximate size of 16' deep and 16' wide allowing for a vehicle to park in the hammerhead;

And whereas this has been the situation since 1992 when the homes were built;

And whereas in 2007 the City amended the Zoning bylaw for the first time to add a section on hammerheads and to restrict the size of hammerheads in the city;

And whereas no notices were sent to any resident who has a previously site plan approved hammerhead that this was the new restriction;

And whereas over time many if not most of the hammerheads along Glen Erin have been widened to accommodate two vehicles;

And whereas parking along Glen Erin has been banned in several locations making all parking for those homes only available on the driveway and hammerhead;

And whereas the resident at 5881 Glen Erin Drive widened his hammerhead in 2005 to a width of 19' leaving the existing depth of 16' and was told by By-law enforcement that it did not comply to the new bylaw necessitating an appeal to the Committee of Adjustment;

And whereas Planning staff at the C of A advised the committee that the variance was not for only 3 feet in width but that now the hammerhead fell under a new zoning requirement of a maximum width of 8.5 feet that the variance was therefore not minor; And whereas the committee not having any information of the previous city approved requirements and size of the hammerheads, refused the application;

And whereas it is unfair that the resident was not made aware in 2007 that these changes would be in in place and that his previously approved property rights would be removed;

And whereas the committee did not have the full information they should have been provided with to make a reasonable decision;

And whereas the city could spend a lot of time and money opposing the committee decision at the OMB which would likely grant the application based on all the facts;

Therefore be it resolved that Council waive the Committee of Adjustment fee for the resident at 5881 Glen Erin Drive to reapply for his variance so that all facts can be put before the committee on this matter.

And further that Planning staff be directed to review the restrictions in the 2007 Zoning bylaw to ensure that all previously city required and approved hammerheads are not affected by the new size requirements and that any future applications for variances be based on the initial approved size.

18. ENQUIRIES

18.1. Secondary Units; Staff Compensation Practices

Mayor Crombie inquired about the City of Brampton's recent actions with respect to secondary units. Ed Sajecki, Commissioner of Planning and Building indicated that they intend to waive registration fees and noted that the City of Mississauga already implemented waiving the registration fees.

Mayor Crombie inquired about the City of Mississauga's staff compensation program. Janice Baker, City Manager and CAO spoke regarding the staff compensation structure and policy and spoke to the transparency of Mississauga's compensation program.

18.2. Random Drug Testing

Councillor lannicca spoke regarding random drug testing on Transit employees and requested that staff bring a report back in the fall. Janice Baker, City Manager and CAO indicated that a report would be brought back by the Commissioner of Transportation and Works.

18.3. Random Drug Testing – Tow Truck Drivers

Councillor Parrish inquired whether random drug testing could also be done on tow truck drivers, to which Janice Baker, City Manager and CAO advised that tow truck drivers operating in the City of Mississauga are not City employees and follow policies and rules of the companies they are employed by.

18.4. Reimagining the Civic Precinct

Councillor Kovac spoke regarding the LRT Open House and reimagining the lands around the Civic Centre with a public consultation process. Janice Baker, City Manager and CAO spoke regarding the Downtown 21 Plan Refresh, noting the renovation of Celebration Square due to infrastructure funding, that staff is looking at enhancements along the LRT project as it relates to Duke of York Boulevard and the need to ensure it aligns with the overall Plan. Geoff Wright, Commissioner of Transportation and Works spoke regarding infrastructure maintenance and repairs, streetscape guidelines and offered to meet with Councillor Kovac. Ms. Baker commented that the City does not own the entire street, that there would be development on Duke of York Boulevard, that Square One Shopping Centre has their own plan and the need to put infrastructure in place before considering what it may look like. Additionally Ms. Baker spoke regarding the collaborative work being completed with Metrolinx.

Councillors Iannicca, Tovey and Parrish spoke in support of Councillor Kovac's request to reimagine the Civic Precinct. Ed Sajecki, Commissioner of Planning and Building spoke to the extensive public consultation that resulted in Celebration Square and the Downtown 21 Refresh.

Councillor Saito indicated that more information was required and noted her concerns that other pending projects may be deferred. Councillor Mahoney spoke in opposition of reimagining the Civic Precinct and noted the need to build on the Downtown 21 Plan and to consider the entire City.
