6. **PRESENTATIONS**

6.1. Phil Green Award

Donnie Morris, Chair and Dorothy Tomiuk, Citizen Member of the Mississauga Cycling Advisory Committee presented the Phil Green Award to Mississauga resident, Nicole Hanson. Councillor Kovac presented Ms. Hanson with a certificate on behalf of Councillor Fonseca, who was not present at the meeting due to other municipal business.

7. **DEPUTATIONS**

7.1. <u>Tax Adjustments and Tax Apportionments</u>

No one present at the meeting requested to speak regarding tax adjustments or tax apportionments.

7.2. The Mississauga Food Bank

Chris Hatch, Executive Director of The Mississauga Food Bank spoke regarding the Thanksgiving Food Drive Campaign, noting the current status of hunger and poverty in Mississauga. Mr. Hatch spoke to the mission and vision of the Mississauga Food Bank, the importance of the Thanksgiving Food Drive, and thanked the Mayor and Members of Council for their promotion and participation. Mayor Crombie spoke to the One Bag Challenge, noting the people that she has challenged to participate and encouraged the Members of Council to promote the Challenge and challenge others to participate. Councillor Saito spoke regarding Eden Food for Change and thanked Mayor Crombie for starting the One Bag Challenge in 2016. Councillor Parrish inquired about eligibility requirements for those who wish to access the food bank and was advised that there is no eligibility requirement, other than their address, as participants must use the food bank located in their own Ward.

7.3. Request to designate the CF-100 in Malton as a Heritage Monument

Stephanie Scott, General Manager of the Malton BIA spoke regarding the CF-100 plane located in Malton and showed a video depicting the refurbishment of the CF-100. Councillor Parrish spoke about the process to have the CF-100 restored and requested to have the CF-100 in Malton declared as a Heritage Monument.

7.4. Earth Market Mississauga

Andrea J. McLeod, Supervisor, Environmental Outreach spoke regarding Earth Market Mississauga taking place on September 23, 2017, noting the various activities and vendors that would be present at the event. Ms. McLeod noted that the sponsors of the event were Meadowvale Town Centre and First Capital and invited the Mayor and Members of Council to attend. Councillor Mahoney thanked Ms. McLeod for her work and encouraged residents and his fellow Members of Council to attend the event.

8. **PUBLIC QUESTION PERIOD - 15 Minute Limit**

8.1. Mississauga residents, Brad Schneller and Terry Murphy spoke regarding Item 14.1.4., a letter dated July 14, 2017 from Erindale Village Living Inc. and Item 14.1.13., a letter from the Erindale Village Association Land Use Advisory Group. Mr. Schneller noted that the address stated in the letter from Erindale Village Living Inc. was incorrect. Mr. Schneller noted that the Community Hall had been in use since 1927 and asked whether heritage buildings had been sold in the past to developers and why, why the Hall had not been well maintained since being transferred to the City, and whether the transfer of the property would be a breach of trust.

Mr. Murphy inquired about the Mississauga Official Plan and spoke to the zoning status, noting that it should not be offered for sale for profit. Furthermore, Mr. Murphy noted the issues he had with the issues with altering the Official Plan as declining property values, traffic problems, pollution, illegal parking, safety of pedestrians, visibility issues, and the environmental assessment pending from Credit Valley Conservation Authority. Mr. Murphy asked whether the Council and the Planning and Building Department will honour the commitments as stated in the Official Plan.

Councillor lannicca directed staff to report back to General Committee and noted that the history pertaining to the "sale" of the property was questionable. Additionally, Councillor lannicca noted that he had heard from the Ratepayers Association President, who advised that the Association did not want the process expedited.

Councillor Parrish noted that this issue had been considered by the Heritage Advisory Committee and commented that this file should be considered further by the Committee. Paul Mitcham provided background on the file and noted that it required further discussion.

WHEREAS climate change is one of the most significant threats facing our planet; and

Whereas Greenhouse Gas Emissions are a primary contributor to climate change; and

Whereas cities account for approximately 70 per cent of all GHGs produced globally; and

Whereas cities are experiencing the impacts of climate change and are on the front line to address the growing crisis; and

Whereas Mississauga has recently experienced the effects of severe weather including the 2009 flooding; 2013 flooding; 2013 ice storm; and 2017 high water levels, among other events, which have cost our City over \$10 million in damages and cleanup costs; and

Whereas in the coming years, Mississauga is expected to experience increased average temperature, increased extreme heat days, increased overall precipitation in spring, winter, and fall, and increased extreme weather and precipitation events;

Whereas in 2014 the United Nations, along with cities around the world, created the Compact of Mayors following the United Nations Climate Summit in in an effort to reduce GHGs at the municipal level to support global efforts to reduce GHGs; and

Whereas in 2016 the Compact of Mayors merged with the Global Covenant of Mayors to become the Global Covenant of Mayors for Climate and Energy;

Whereas the Global Covenant of Mayors for Climate and Energy simply requires cities to, within three years of joining the Compact:

- Create a GHG inventory for our city consistent with the Global Protocol for Community-Scale Greenhouse Gas Emission Inventories, within one year or less;
- Catalogue the climate hazards faced by our city, within one year or less;
- Develop a target to reduce GHG emissions, within two years or less;
- Catalogue the climate vulnerabilities faced by our city, within two years or less; and
- Outline our plans to address climate change mitigation and adaptation within three years or less

Whereas 20 Canadian cities are already members, including London, Ottawa, Edmonton, Oakville, and many others; and

Whereas the city of Mississauga is undertaking the development of a Climate Change Action Plan, complete with GHG emission reduction targets, and thereby

will meet the criteria to reach compliance with the Global Covenant of Mayors for Climate and Energy; and

Whereas membership in the Global Covenant of Mayors for Climate and Energy is voluntary and has no cost associated with membership; and

Whereas Mississauga has always been a leader in taking action to mitigate climate change including expanding transit, reducing GHG emissions equivalent to 700 cars off the road in 2016, planting over 250,000 trees through its One Million Trees Program, and converting all street lights to LEDs, among other initiatives;

THEREFORE be it resolved the City of Mississauga declare to the Compact of Mayors, through a letter from Mayor Bonnie Crombie, our intention to join the organization;

Therefore be it further resolved that staff undertake all necessary measures to meet the requirements set forth by the Global Covenant of Mayors for Climate and Energy.

10.5. Report dated September 1, 2017 from the Commissioner of Transportation and Works: Increase to Existing Contract with Pacific Paving Ltd., for Canada150 Community Improvement Program - Intake 2 Funded Eglinton Avenue Multi-Use Trail (Replacing Creditview Road Multi-use Trail).

Councillor Ras noted that she does not agree with sole-sourcing and asked why the project had not gone out to tender. Geoff Wright, Commissioner of Transportation and Works commented that the timing of the project was tight, as the work must be complete by February 2018. Additionally, Mr. Wright spoke to a report brought for consideration in March 2017 that was rejected, that the contract with Pacific Paving was terminated at that time, and that Pacific Paving was contracted for the current project to avoid a claim. Janice Baker, City Manager and CAO spoke to integrating Federal planning with the City's budget and commented on the weather-dependant nature of the project. Councillor Starr clarified that the City will be seeking a solution to bike trail pathways along the route and thanked staff for their work.

And whereas the Mississauga Tourism Board is working on a new Tourism Master Plan that will be presented to Council in fall 2017 that will set out how the city should move ahead with tourism in the future;

And whereas the partnership with Tourism Toronto as the global marketing agency for tourism for Mississauga has been very successful in supplementing the City's own efforts, staff and resources in this area;

And whereas Regional Council will be considering on September 14, 2017 a Notice of Motion recommending that tourism be a regional initiative;

AND WHEREAS the City of Mississauga expanded the Lisgar District Sump Pump Subsidy Program, now known as the Foundation Drain Collector (FDC) Sump Pump Subsidy Program, in 2015 to include all households in the City of Mississauga that are serviced by a municipal foundation drain collector that provides a one-half cost sharing arrangement between the City of Mississauga and the homeowner, with a maximum contribution of \$3,000 per household to be provided by the City of Mississauga as prescribed under By-law 0170-2015;

AND WHEREAS the Lisgar District Sump Pump Subsidy and the Foundation Drain Collector (FDC) Sump Pump Subsidy Programs specify that the sump pump must be installed by a plumber licensed in Ontario and with a City of Mississauga business licence to be eligible for a subsidy;

AND WHEREAS the City of Mississauga Business Licensing By-law 1-06 stipulates that no Person can act as a Plumbing Contractor, Master Plumber, Drain Contractor or Drain Layer in the City of Mississauga unless the Person is licenced under this By-law;

18. MATTERS PERTAINING TO REGION OF PEEL COUNCIL

18.1. Paving at Winston Churchill Blvd. and Britannia Road

Councillor Saito indicated that she had received notice that paving in the area of Winston Churchill Blvd. and Britannia Road was ready to begin and that the paving would continue overnight through the weekend, necessitating a Noise Exemption Notice. 18.2. Fair Share Conference and Greater Toronto Airports Authority

Councillor Parrish spoke to a report on the Regional Council agenda the following day with respect to the Fair Share Conference and noted that there would likely be a recommendation to cancel the conference. Furthermore, Councillor Parrish noted that the Greater Toronto Airports Authority (GTAA) would be requesting to make a delegation to Regional Council to provide information on their projects and requested that staff provide an education session to Council with respect to all outstanding issues regarding the GTAA.

19. **ENQUIRIES**

19.1. Subsidized and Affordable Housing

Councillor lannicca spoke to an article in the Mississauga News regarding subsidized and affordable housing and clarified that he was in favour of subsidizing housing when it was clear where the subsidy was coming from. Additionally, Councillor lannicca spoke regarding a subsidy-per-unit fee and the cost of building a parking lot.
