7. **DEPUTATIONS**

7.1. Cooksville Creek Flood & Erosion Project

Ann Vidal, Rhonda Valley Residents Group spoke to numerous damage issues and requested that a City Inspector be sent out to the site. Geoff Wright, Commissioner of Transportation and Works advised that staff would go to the site to meet with residents and note their property damages.

Geoff Wright, Commissioner of Transportation and Works indicated that there had been delays due to contractor issues, that discussions were underway to determine a completion date, and assured Ms. Vidal that damages would be repaired at the City's expense. Councillor Kovac spoke regarding the project plans, noting that he shared the residents' concerns. Ms. Vidal requested that a City Inspector visit the site, to which Mr. Wright advised that staff would go to the site to meet with residents and note their property damages.

7.2. Remembrance Day

Andrew Carlson, Officer Cadet from the Toronto Scottish Regiment spoke regarding the organization's Remembrance Day service, noting the itinerary and locations, and invited the Mayor and Members of Council to attend. The Mayor and Members of Council thanked Officer Cadet Carlson and congratulated the Toronto Scottish Regiment on their work in the community.

7.3. Banners and Boxes Program Update

Mike Douglas, Executive Director of Mississauga Arts Council provided an update on the Banners and Boxes Program, thanking Heritage Mississauga for their guidance and Council for the funding that was provided to support the program and for fostering connections with utility companies. Furthermore, Mr. Douglas spoke regarding the various box locations, the artists who had participated, and the costs of program implementation. Members of Council congratulated Mississauga Arts Council on an excellent venture and expressed interest in expanding the program, to which Mr. Douglas agreed, noting that sponsorships would be required to do so. Councillor lannicca spoke regarding the installation of transformer stations along the HLRT, noting support having them included in the program and directed staff to connect with Metrolinx to discuss.

7.4. Lighting of the Port Credit Lighthouse

Karen Priest, Resident spoke regarding lighting the Port Credit lighthouse and requested Council's support in providing \$6,000 to the project. Members of Council spoke in support of providing the funding to the project and suggested that plaques be placed on the base of the lighthouse to denote the sponsors who made the lighting project possible.

8.1. Karen Carstenson, resident, spoke regarding Item 7.1., the deputation regarding the Cooksville Creek Flood & Erosion Project, noting several issues with the property along the creek including the construction fences, the collection and pooling of water due to the berm, and the excess of trees in a small area. Furthermore, Ms. Carstenson noted that several of the trees had died due to the water tanker's inability to access the area to water them and asked for the situation to be fixed. Geoff Wright, Commissioner of Transportation and Works noted that the tree planting was part of the overall construction program to provide naturalization of the area, that the dead trees would be removed and replaced, and that staff would look at relocating the access point to the

area to allow for appropriate maintenance. Councillor Kovac inquired whether the construction plan had been shared with residents prior to the start of construction, to which Mr. Wright advised that he would review the project files to find out.
