Whereas the Region of Peel "Draft Malton Neighbourhood Community Data Summary Report, March 20, 2018" describes the results of extensive consultation with Malton stakeholders through community meetings, focus groups, local association reports and current census statistics;

Whereas additional data has been made available by various agencies and institutions including The Peel Data Centre, Peel Health Services, Statistics Canada, The City of Mississauga, The Peel District School Board and The United Way of Peel;

Whereas Census Tract Average Individual Incomes, compared to Toronto's CMA Average Income (median total income by family types by census metropolitan area) of \$46,666 shows Malton to be in the "Very Low" category at 54-60% – Malton individuals having, in fact, the lowest average incomes in Mississauga at \$24,142 – with newcomers even lower at \$17,266 (59.9% of Malton's population);

Whereas 21.5% of Malton's 38,075 residents live under the poverty line, 10.5% are unemployed with 25% of Youth unemployed, 24.3% are lone parent families and 82.5% are visible minorities;

Whereas 9,900 children and youth make up 26% of the Malton population, 28% are not involved in any activities whatsoever because of cost and access to transportation, only 482 participated in the City's subsidized programs in 2016, 1708 were registered in full cost programs and there were 15,597 visits to drop-in free City programs;

Whereas Early Development Scores in 2014 indicated 34.4% of Malton's children are considered vulnerable, every single school in Malton scored HIGH on the Social Risk Index and the 2016-17 Healthy Smiles Screening showed 64% of Malton's children require urgent or preventative dental care while the average for Peel, at 36%, is the highest in Ontario according to Wellfort Health Services;

Whereas the Village of Malton is isolated by Pearson International Airport and an enormous Commercial/Industrial belt which is the economic engine of both Mississauga and the Region of Peel - Malton's residents remain the City's poorest;

Whereas Lincoln Alexander SS pool wing is owned by the City of Mississauga, its doors remaining chained for seven years, wasting 8,263 square feet of space;

Whereas a Motion passed unanimously at the Region of Peel Thursday April 5, 2018 to use Peel 2018 Human Services funding to evaluate the process and cost of converting the Lincoln Alexander pool enclosure into a Youth Hub with a Drop-In Centre on the main floor and a 40% mezzanine to accommodate health and counseling agencies specifically focused on youth;

Whereas the Motion went on to task the Region with surveying agencies currently serving Malton's youth and funded by The United Way of Peel at \$579,235, to ascertain their willingness to relocate to the Lincoln Alexander SS Facility;

Whereas a Commitment In Principle, subject to the 2019 Budget, was passed unanimously at the Region to provide 2/3 of the capitol funds necessary to complete the conversion;

Therefore Be It Resolved:

That appropriate City staff be directed to participate fully in the preparation of design and structural requirements for the conversion of this City-owned facility; and further;

That Council approve in principle, subject to the 2019 Budget deliberations, 1/3 of the funding required to complete the conversion of the pool wing of Lincoln Alexander SS into the much needed Youth Hub for Malton.
